At the December 14 potluck/meeting there will be no formal program and usually no business of consequence. This is a time for fellowship and the Ham of the Year award is usually announced at this time. At press time, I do not have information about programs for 1997.

Minutes of the November 21, 1996 general meeting

The meeting was called to order by President Al Staples N7VOF. Eleven members were present, a quorum. Those present introduced themselves.

President Al asked for any discussion of the minutes of the October meeting, and a motion was made and seconded to approve the minutes as published in SPARKS, motion was passed unanimously. A motion was made and seconded to approve the Treasurer's report as published in SPARKS, motion passed unanimously.

Chuck Graff K7CHV reported that he has acquired three handheld 2 meter units from Puget Power, which can be reprogrammed for amateur frequencies. These will be placed in the trailer for emergency use. President Al asked Harry Lewis W7JWJ, our W.Wash section manager, to discuss the situation regarding the proposals by commercial interests to take over the amateur frequencies in the 2 meter and 70 centimeter bands. The ARRL has had to hire additional lobbyists to promote our interests in this matter, and this is a strain on ARRL finances, being a non-profit organization. It is his feeling that this argument presages attempts to take over other amateur frequencies, and thus threatens the entire field of amateur radio. The league has asked for individuals and clubs to donate funds to help cover this new expense for lobbying Congress, as well as at the international level. Mary Lewis W7QGP also pointed out that ARRL is up against many millions of dollars of industry lobbying. After considerable discussion, a motion was made and seconded and passed unanimously to contribute \$50 from the club treasury for this fund. Individual contributions are tax deductible.

Jim Von Seggern KC7FEH discussed the proposed 1997 budget. The main expense item, aside from the insurance, is the newsletter. The newsletter costs \$6/year/member, and about 37% of the mailing list are non-dues paying recipients. The budget has a deficit of \$268, which we could make up by increasing membership, or selling some surplus equipment. It was suggested that perhaps 1997 would be a good year to purchase a table at the Puyallup Swap Meet. A motion was made and seconded and passed unanimously to approved the budget as published in SPARKS. The mailing list will be revised at the Board level.

A motion was then made to adjourn. Following refreshments, a very interesting talk on antenna tuners and what they do and don't do and how they can be used was presented by Patrick Buller W7RQT.
