

FCC Part 95 Changes:

FCC MODERNIZES PERSONAL RADIO SERVICES RULES -- WASHINGTON

May 18, 2017 – Today, the FCC took steps to update the Personal Radio



Services rules, also known as Part 95 of the Commission's rules, in order to modernize them, remove outdated requirements, and reorganize them to make it easier to find information. Significantly, as part of this effort, the FCC addressed more than two dozen proposals submitted by interested parties. Today's action will result in a more consistent, clear, and concise set of rules that will better serve the needs of the public. The FCC Personal Radio Services rules cover a wide variety of wireless devices that are used by the general public. These devices generally use low power levels, communicate over shared radio frequencies, and usually do not require an individual FCC license for each user. Some common examples of Personal Radio Services devices are walkie-talkies; radio control toy cars, boats, and planes; hearing assistance devices; CB radios; medical implant devices; and Personal Locator Beacons. The revisions adopted today reflect a comprehensive reform that will simplify, streamline, and update these rules. These changes will ensure that these rules reflect technological advances, recognize the 21st century uses of the Personal Radio Services, and are easy for the public to use and understand.
