I believe it can be said by most of the members who have passed through our roster: we have learned a lot about ATV. Most of us have invested in new equipment and have learned how to send and receive ATV pictures from home and mobile stations, as well as from remote transmitters (Skycam, weather radar, RC cars, and even helium balloons and kites!) Recently, we've also enjoyed a related aspect of images via radio: SSTV. While this was never considered as the primary thrust for WATS, it has certainly brought a lot of excitement and enthusiasm to many WATS members—even something to talk about on our weekly ATV Roundtables. John Gafford, N5XAK called the meeting, held at the CORD offices, to order at 7:06 pm. Attending were

The Minutes of the August Director's meeting as published in the September Happenings were approved following a motion by W5TAH, second by AC5CV, and unanimous vote.

The August Treasurer's Report as published in the September Happenings was approved following a motion by AC5CV, second by W5TAH, and unanimous vote.

#### **Old Business**

 N5XAK gave thanks to AC5CV for taking care of the Skycam electrical work while he was out of town. • W5TAH reported on ATV experiments around the Brazos River bottoms using the Skycam transmitter as a signal generator. He reported poor reception west of Waco Drive bridge and east of Interstate 35. Hence his recommendation is not to pursue a microwave cross-band repeater for this area. There was no objection from the other Directors.00

#### **New Business**

- N5XAK announced that, since we've not been satisfied with the ATV signal quality in past WWWC event coverage, WATS was not planning to pursue ATV coverage of the event this year. AC5CV would communicate this to HOTARC (in light of their past year's contributions to WATS from this event).
- AC5CV raised the issue of the future of WATS in light of reduced membership, upcoming election of
  officers, and other changing realities. AC5CV and N5XAK both indicated they were not planning to
  serve as Officers (or Directors) next year. N5XAK raised the issue of how WATS might be dissolved.
  W5TAH agreed to investigate further (studying bylaws and charter) and recommended we should
  discuss thoroughly with the members.

N5XAK heard a motion by AC5CV to adjourn at 7:35 pm.

- W5TAH reported that, as a result of live tests using the Skycam, he did not recommend that WATS pursue a microwave cross-band repeater for this area. The Directors concurred. KC5UOZ offered, as a suggestion, that we might consider a different location for the present repeater.

### **New Business**

• N5XAK briefly reported the discussions of the Directors concerning reorganization or dissolution of WATS. Research and discussions would continue in the coming weeks.

N5XAK heard a motion by W5TAHto adjourn approximately 7:48 pm. There was no special program.
