## FCC Tells L.A. City & County to Get Off 2.4 Gig!

SB OST ARL ARLB010 ARLB010 FCC Denies LA County 2.4 GHz Application, Cancels Experimental Grant to City

Following objections from the ARRL, AMSAT and others, the FCC has turned down an application from Los Angeles County, California, for an experimental license permitting airborne microwave TV downlinks (TVDL) in the 2402-2448 MHz range. The FCC also canceled an experimental license grant to the City of Los Angeles to operate an identical TV downlink system in same band.

The ARRL, AMSAT and the Amateur Television Network had asked the FCC to deny the County's application. ARRL members Art McBride, KC6UQH, and Thomas O'Hara, W6ORG, also filed informal objections. The League, AMSAT and ATN also had objected to the City's experimental grant. The FCC gave the City until December 1 to terminate its operation but reserved the right to accelerate the cancellation date if interference occurs.

The LA County proposal, filed in August 1999, sought FCC authorization to develop a TVDL system on four 2.4 GHz channels for deployment aboard sheriff's and fire department airborne units. The FCC granted the City's WB2XEN experimental license based on a similar submittal.

In protesting the County's plan, the ARRL called the application a "foot in the door" toward gaining a permanent berth in the 2.4 GHz band. ## COMPUTERS MADE "SYMPL"

TweakUI is a windows utility written by some otherwise idle byte pushers in Redmond WA. For some time, it was not supported by Microsoft, but today it is. It works in all versions of Windows (95, 98, ME) and can be downloaded from their web site at www.microsoft.com/windowsme/ guide/tweakui.exe. Tweakui.exe is a self-extracting program which, when executed, dumps some files into your c:\windows\temp directory. After executing the file, go to this directory and right-click on the file tweakui.inf. You can use Windows Explorer to get to this file. A drop-down menu will appear, and one of the choices will be "install". Click on this, and an icon will be installed on your control panel labeled "Tweak UI". Go to your Control Panel and double-click on the icon to see a set of tabs with everything from "Mouse" to "New". For help on the tabs, click the? in the upper right-hand corner then click an item on a tab to get an explanation of what it does. Most tabs also have some explanation of the uses thereon. As an example, click the "Boot" tab, and under "Boot menu" put a check mark in the "Always show boot menu" box. Set the time duration setting to your choice. The next time you start your computer, the boot menu vou see when vou hold down the F10 key (Windows 95) or the Ctrl key (Windows 98) will appear on your screen. Now, if for some reason you need to start your machine in DOS mode, or want to one-step the boot activity (troubleshooting), just choose the action you want from the boot menu. You can explore the other tabs, but be careful to not change something you don't want to change. This is just one example of a miriad of features in the Windows operationg systems that are not very well

documented. Next month I will tell you about some "Easter Eggs" and how to find them.


