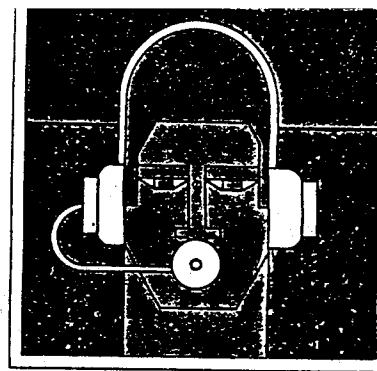

Not to mention that our financial situation was substantially improved as a result of convention profits. Let's take a lesson from that and be cautious about how and where we spend our money. For openers, I feel the club should get a newer HF rig...something that will work on 12VDC power. Not necessarily brand new but at least relatively current. The club tower trailer could really be made emergency-ready by the addition of a generator and some lights. How about a phone answering machine for members and interested persons to call to hear about current SCCARA activities? Remember, not everyone uses 2 meters! This would be handy for providing current info on classes, meetings and changes of meetings sites and/or dates, or any other pertinent info such as how to join the club, dues, etc. The ultimate wish would be for a permanent home for SCCARA with a nice shack...but that's certainly beyond our current means.
