The United Way Building, 1922 The Alameda, San Jose, (about one mile South West from the San Jose Air Port). From 1-880: take the Alameda turn-off going South for ½ block then turn left on McKendrie. From the South: go North on the Alameda, ½ block past Hedding turn right on McKendrie. Immediately turn right into the parking lot just behind the small church on the corner. The entrance is up the steps at the South East corner of the building. There is wheelchair access at another door at the North East corner, but for security reasons, only one door is open at a time-someone will have to notify the guard if you need wheelchair access. Also, try not to be too late--the doors may be closed with nobody around to let you in.

NEW LOCATION! The San Jose Red Cross: South-West corner of North 1st St. and Plumeria Dr., San Jose. Plumeria is North of Trimble and South of Montague Expressway. From the South on I-880, take the 1st Street exit, go North. From the North on I-880, take the Montague (Trimble) exit, go West to Trimble then turn right (North) on 1st. From the South on US-101, take the Trimble (De La Cruz) exit going North, then turn left (North) on 1st. From the North on US-101, take the Montague exit going North/West, then turn right (South) on 1st.

The main entrance faces Plumeria, go straight in past the front desk. The radio room is in back of the conference room on the left just past the rest-rooms. Board meetings are open to all.

The board voted to produce a thank you certificate to be presented to Wally KA6YMD and Barbara KD6QEI for their food preparation efforts during field day.

The board decided to have another SCCARA picnic this summer (details elsewhere in this newsletter).

Most of this meeting dealt with the problem of attracting and keeping new members. The suggestions included: Revive and expand the ELMER list/program; have technical open-house sessions at the club station where people could come with problems, questions, or their rigs (we could have a soldering iron, test equipment and two or three knowledgeable HAMs there); talk one or two knowledgeable people into writing some kind of hints column for the newsletter (on a regular basis); do more activities that would appeal to new amateurs (small events, not like field day). If anyone has any other ideas, please let us know. Keep in mind: more than just good ideas are needed, members need to step forward to make these things happen. If you'd like to do something or participate in some activity, mention it to Doug WN6U, bring it up at the next general meeting, or stop by the next board meeting.

Flea Market

Despite the fact that we didn't have anything of much value at the June flea market, we still made \$135.70. Thanks go to Harold KK6ZE who helped transport and sell.

At the last general meeting, I was delighted to hear a fair amount of discussion regarding our flea market effort. There were a number of ideas, most were variations on the ones put forth in last month's column. A few people felt some kind of rotating shift would help prevent any one person from having to put in too many hours--the problem is that there are not enough volunteers to rotate.

Finally, a motion was made to cancel the flea market effort, except for special occasions, and stop renting that big locker. The motion was later tabled until the July meeting to give more members a chance to vote (June was a sparsely attended meeting).

One person later asked me if I received any compensation for my efforts (gas/travel reimbursement, etc.). Perhaps many of you assumed something like this too. Well, for the record: I swear that, to the best of my knowledge, no reimbursements or payments of any kind have come out of the flea market revenues (except as listed below). In fact, I even chipped in a few bucks myself for a couple items.

The following is a complete account of ALL the

"undocumented" expenditures paid from the flea market proceeds: 1) The seller's entrance fee (\$10 per vehicle that transported stuff), 2) Parking fee (\$1 per vehicle that transported stuff), and 3) Refreshments offered to those who helped transport or sell (coffee, doughnut, hot-dog, soda... usually \$5 or less per person). For example: if two people transported our goodies, this "overhead" expense usually comes to around \$30.

Most of you know about the "documented" expense of the storage locker: \$45 per month (every month). We have a booth at six flea markets per year (there are seven, but we don't have a booth when we host), so the total average expense per event is typically \$120. (If I'm alone, it's more like \$105; if there are three people, \$135.)

The reported amount of what we make at each flea market includes these "undocumented" expenses, but NOT the locker rent. So, to get a more accurate picture of what we keep, reduce the reported amount by \$90. (The June flea market increased our repeater fund by \$45.)

If you have any feelings on this subject, please come to the next meeting or get word to myself or our president Doug WN6U.

Field Day on the USS Alabama

I spent the last week or so on a training assignment in Mobile, Alabama. While there, I talked with many hams on VHF and found them to be a friendly bunch.

They have some nicely linked repeaters and likely have more "tactical" use than we do since they have lots of violent weather. Their weekly check-ins are interesting, they take them by repeater. A typical check-in would be net control asking for all persons checking in on WA4AIZ and

when done, he would then ask for check-ins from the next linked repeater. Some are permanently linked.

The local club was able to wangle a deal with the overseers of the battleship USS Alabama to allow them to do Field Day from there. They ran 5A class. One of the members worked for a cable company and supplied hardline plus the expertise to permanently install it. Plans are to use it in future years plus there are possibilities for having a permanent station. They are actively looking for people familiar with the radios and antenna systems on the ship.

They set up two CW stations, one phone station, and one VHF/satellite station in the ward room located on the main deck. Two more stations were situated in the radio room located two decks down. They eventually moved out of it since it got very hot. The ward room on the other hand was air conditioned.

They had volunteers "coming out of the woodwork." Members could bring their families out plus a lunch was served on Saturday. The bands were pretty good. They had severe problems with foreign broadcasts on 40 meters rendering the band almost useless. They had one 10-15-20 beam, several verticals and dipoles everywhere. Someone had to do some real acrobatics to get them up.

It was a great experience and the hams there are really lucky having such a nice field day site.

Subject: Field Day antenna Comparison

We ran 5 watts on Field Day with two HF antennas. A delta loop about 180 feet/leg, fed at high point, facing West, angled about 45 degrees to horiz., over dry/ledge earth, with bottom leg about 10 feet above ground: Performance was better than a much higher dipole, but nowhere near as good as a terminated vee described below.

Vee antenna, #24 enameled wire, 270 feet/leg, about 120 degrees included angle, terminated at far end to ground rod with 500 ohm resistor; feed-point by extending wire down from support line, fed with Johnson matchbox. Faced west, looking at the delta loop. Excellent performer 80 through 15 meters; if we could hear 'em, we could work 'em on the first or second try. Whole antenna averaged 15 feet above ground.

The vee antenna outperformed anything else we've run on HF, and has done so for several years. Bandwidth was excellent, too - did not require tuning except when changing bands.

ARRL Pacific Division Update

Update on Effort to Save 13 cm Band:

By the deadline of May 11, the ARRL and several members filed Comments on the NTIA plan. Each cited current activity on the band plus plans and commitments made which would be destroyed if the plan were adopted. Thanks to each of you who helped by writing!

To recap, NTIA has made it very clear that their overwhelming concern was to free up 50 MHz of the Federal Government primary spectrum allocation immediately and to minimize the conversion costs involved for the Federal Government, regardless of costs or problems caused to non-Federal Government entities. All other problems are to be resolved by FCC. These problems include sharing agreements with all other services, interference caused by the proposed reallocation to all parties, costs already spent by non-Federal Government services, to name only a few of the problems.

On April 27, the FCC issued a Notice of Inquiry, Docket 94-32, with a Comment deadline date of June 15, 1994, concerning the NTIA proposal for the immediate release of frequencies. This docket asks questions dealing with proposed new usage, issues of compatibility with existing Amateur Radio Service, etc. The ARRL has filed Comments; others including NARCC and SCRRBA (The Southern California Repeater and Remote Base Assn.) have also filed. The Reply Comment deadline is June 30, 1994.

ARRL still needs more hard documentation of current activity by ATV and any other operations at 2.3 GHz. There are a list of questions as a guideline for documentation and a four page NTIA report available from me. Just ask!

The Comments on the NTIA proposal can be obtained via the NTIA BBS at (202) 482-1199 or on Internet by telnet to ntiabbs.ntia.doc.gov. Look for the menu items

under "200 MHz Report" which itself is under "Public Notices / Comments" on the main menu. The FCC Docket 94-32 can be obtained from ARRL or from me and is also available from the NTIA BBS in the "200 MHz. Report" section. Call me or Vice Director Maxwell for further details (see page 8 of any QST).

Please send an original and four copies of your Comments on the FCC Docket to Secretary, FCC, Washington DC 20554 and another copy to Dave Sumner, K1ZZ, EVP, ARRL HQ, 225 Main St., Newington, CT 06111-1494. Remember the deadline for Comments is June 15. The deadline for Reply Comments is June 30.

Be assured that ARRL has several actions underway to try to turn this situation around, but ALL depend on your documentation of current 2.3 GHz activity and plans.

One more piece of information on auction matters: pre-auction activities for Interactive Video Data Services (IVDS) and narrow band Personal Communication Services (PCS) which has been in the media the last few weeks apparently refer to the previously authorized auction plans for the 218 - 219 MHz band and below 902 MHz and above 930 MHz. The PCS and IVDS auction activity is planned to start on July 25. This action apparently does not directly involve the 13 cm band proposal by NTIA.

Vanity "Preferred" Call signs:

At the ARRL National Convention, a FCC official indicated that the vanity call implementation should occur by the end of the year. The basic outline of the ARRL Comments filed on FCC Docket 93-305 by the April 21 deadline is contained in the June 1994 Update.

Congressional Legislative Report:

HJR 199 has 238 co-sponsors in the House for a majority of members. There are no new co-sponsors from the Pacific Division. With a majority we can now plan to bring up the resolution for consideration. The identical resolution in the Senate (SJR 90) now has 45 co-sponsors. We need 4 more for a majority in the Senate. In the Pacific Division, we still need to convince 11 California Congressmen (Hamburg, Herger, Matsui, Pelosi, Dellums, Pombo, Lantos, Eshoo, Condit, Dooley, Thomas), California Senators Feinstein and Boxer, Nevada Congressman Bilbray, Nevada Senators Reid and Bryan, to become co-sponsors. Hawaii is 100%! HR 2623 (Amateur Radio Volunteer Protection Act) has 75 co-sponsors in the House (the sole co-sponsor from the Pacific Division is Ron Dellums from the CA 9th District) - not yet introduced in the Senate. Keep writing letters to your congressional delegation with copies to Steve Mansfield, Legislative Mgr. in ARRL HQ so he can use them when visiting your congressional delegation in Washington. Steve met with key Congressional members June 8 - 10 to lay out the strategy for introduction of HJR 199 and SJR 90. More details as they develop.

Antenna Ordinances:

Rusty Epps, W6OAT, continues to lead a Pacific Division-wide effort to develop a database of antenna ordinances and related materials. Rusty reports that data is coming in from all parts of the Division -- thanks! Send all the material to Charles K. (Rusty) Epps, W6OAT, 651 Handley Trail, Redwood City, CA 94062.

FCC Has Full Staff of Commissioners:

With two recent additions, the FCC has finally been brought to the full complement of five Commissioners. The views on Amateur Radio of the two new members are unknown. The last two appointees, who have been confirmed by the Senate, are: Susan Paula Ness, age 45, resident of Bethesda, MD; Attorney, Democrat. She was active in the Clinton campaign. Prior to that she worked in the media lending division at American Security Bank, reportedly administering loans for cable and broadcast TV, small telephone, cellular telephone and paging companies. Rachelle Blossom Chong, age 34, resident of San Francisco. Attorney, Republican. She was a partner in the San Francisco office of the Graham & James law firm and primarily represented cellular telephone clients. She is the first Asian-American FCC commissioner.

Pacific Division Hams become Fellows of the Radio Club of America:

There were five persons elected to Fellows of the Radio Club of America from the Pacific Division, of which four are hams. The Radio Club of America is the oldest organized club of its kind in the World. The four hams are John S. Powell WB6SDS, Lee Wical KH6BZF, George Badger W6TC, and Stan Kaisel K6UD.
