Parts were obtained from a ham in the Comm. sqd. without problems. These were the days when you built things you needed, no local ham stores. (The most impressive thing I recall while stationed in Deuchland was the fact that all ham equipment owned by my German ham friends was home made and of very high quality. Not only transmitters and receivers, but test equipment as well.)

Finally, the most awaited mail arrives, DL4ZC is ON THE AIR. Talk about frequency drift, like a small boat on a very windy lake. (Most hams licensed recently have not experienced drift of this magnitude, you haven't lived until you have.)

This was the mid 1950's. World wide communications happened daily. I worked over 150 countries in less than a year on CW.

Several months later I met W0PVH, Capt. Lloyd Rounds from Kansas. Lloyd was Cmdr. of the Base Comm. Sqdn. and we quickly became friends. Later I was reassigned to Base MARS. This was the happiest time in my life.

My fellow ham friends, this reminiscing is ok but, the greatest times in our lives should not be in the past, they should be in our future. After all why shouldn't they be?

The United Way Building, 1922 The Alameda, San Jose, (about one mile South West from the San Jose Air Port). From 1-880: take the Alameda turn-off going South for ½ block then turn left on McKendrie. From the South: go North on the Alameda, ½ block past Hedding turn right on McKendrie.

As soon as you turn onto McKendrie (heading East), turn right into the parking lot just behind the small church on the corner. It's best to park at the far end of the parking lot.

The entrance is up the steps at the South East corner of the building. There is wheelchair access at another door at the North East corner, but for security reasons, only one door is open at a time-someone will have to notify the guard if you need wheelchair access. Also, try not to be too late—the doors may be closed with nobody around to let you in.

The San Jose Red Cross: South-West corner of North 1<sup>st</sup> and Plumeria Dr. Plumeria is two lights North of Trimble and South of Montague Expressway. From the South on I-880, take the 1<sup>st</sup> Street exit, go North. From the North on I-880, take the Montague (Trimble) exit, go West to Trimble then turn right (North) on 1<sup>st</sup>, (if you miss Trimble, just follow Montague then turn left (South) on 1<sup>st</sup>). From the South on US-101, take the Trimble (De La Cruz) exit going North, then turn left (North) on 1<sup>st</sup>. From the North on US-101, take the Montague exit going North/West, then turn right (South) on 1<sup>st</sup>.

The main entrance faces Plumeria, go straight in past the front desk. The radio room is in back of the conference room on the left just past the rest-rooms. Board meetings are open to all.

## Repeater Report

As most of you know, our two meter repeater is located at Trish's house (WA6UBE). The antenna was moved to make way for a new roof. The roof work is done-and it included a locked enclosure (closet) on the back porch. The repeater has been moved (out of the way) from Trish's back room to this closet. The new spot places the equipment closer to the antenna, so we were able to shorten the coax by roughly 20 feet. We also now have a half-way decent Earth ground.

The closet is little cramped, but it's not bad now; however, part of it will be used for storage. This could make servicing the repeater difficult; so, this arrangement isn't as good as it now appears. Paper work is in progress concerning the eventual move to the San Jose City radio vault. Once a "memorandum of understanding" is agreed to, the move should take place.

The repeater is currently putting out 45 watts (roughly half power) into the attenuator and duplexer with a SWR of 1:1. After the coax attenuator and duplexer, the power going to the antenna is 7.5 watts with a SWR of 1:1. We believe this power level allows the user to receive the repeater about as well as repeater receives the user. The attenuator is used instead of reducing the transmitter power because a similar type transmitter was observed to produce spurious signals at low output levels.

# ARRL Pacific Division Update

January 1995

#### **Congressional Legislative Report:**

The "lame duck" session of Congress in late November has come and gone.

Unfortunately, even though the ARRL and many others did everything they could, the Senate did NOT bring up House Resolution 4522, the FCC Authorization Act of 1994. The House passed the bill in the closing hours of the session on Oct. 7 before leaving for the election campaign.

HR 4522 contained various technical provisions desired by the FCC and other provisions desired by ARRL (but less the Joint Resolution language, which was passed, as reported last month). Among the provisions was one that Congress had decided to change the \$7 per year fee for "vanity calls" to a ONE TIME application fee of \$150. It was the judgment of Congress that this change was "revenue neutral" and would ease the burden of billing and collection on the FCC. (It also helps to stay away from a potential annual license fee for ALL Amateur Radio licenses).

The ARRL staff is now planning our national legislative agenda for 1995 for approval by the Board in January 1995. I would like to have your input to this process. Please contact me immediately with your ideas. Ideas being proposed include reintroduction of the HR 4522 bill concerning vanity call sign application fees; protection for volunteers while performing their specific tasks, such as OO's, VE's; spectrum protection; enforcement issues; to name but a few.

Let's look ahead to the potential Pacific Division Amateur Radio support in the 104th Congress to convene in January 1995. In the Pacific Division part of California, of the 21 members of the House, 9 who were co-sponsors of HJR 199 were re-elected (Edwards in the 16th District, who was a co-sponsor retired; Lehman in the 19th was defeated). Newly re-elected Riggs in the 1st was not a sponsor of HJR 199, but was a co-sponsor of HR 73 in 1992. The one Senator (Feinstein) who was a co-sponsor of SJR 90 was In Hawaii, both members of the House co-sponsored HJR 199 and were re-elected; both Senators co-sponsored SJR 90 (Akaka was re-elected - Inouye was not required to run in 1994). In Nevada, the one member of the House (Vucanovich) who co-sponsored HJR 199 was re-elected; Bilbray, who was NOT a co-sponsor was defeated; neither Senator co-sponsored SJR 90. From this analysis, it would appear that our Pacific Division Amateur Radio support continues to be as healthy as it was. Please thank those who were our co-sponsors in 1994. Please contact the new members of Congress concerning Amateur Radio - in CA, Frank Riggs in the 1st., Zoe Lofgren in the 16th, and George Radanovich in the 19th; and in NV, John Ensign in

the 1<sup>st</sup>. We will be needing all their help.

Again, many thanks for all the 1994 grassroots work!

#### News on Effort to Save 13 cm Band:

By the time you read this, Comments on ET Docket 94-32, the NPRM involving the sale of licenses in the 2390 - 2400 and 2402 - 2417 MHz bands, will have been filed by all the parties interested. The comment deadline was Dec. 19, 1994. Many thanks to all who have worked so hard on this effort, with special thanks to Jim Von Striver, W6ASL, the spokesman for the Pacific Division Spectrum Committee, NARCC, NCPA and many others for all the effort put into trying to save 13 cm for all of us. Jim is planning a campaign to write Reply Comments on this matter. The Reply Comment deadline is Jan. 3, 1995. Please contact Jim at (510) 827-9826 if you are interested in helping.

There is another docket which discusses spectrum allocations above 40 GHz. This one appears to be relatively benign as it involves Amateur Radio only in the 76-77 GHz. segment of one of our bands and appears not to really threaten us. Nevertheless, the ARRL is filing comments, and I ask those of you interested to secure a copy of the Docket from Jim Von Striver, W6ASL, who will be assembling the Pacific Division comments. Comments are due on Jan. 31, 1995.

#### Latest on Vanity (Preferred) Call Signs:

At the ARRL National Convention in mid 1994 and at a later meetings, FCC officials indicated that the vanity call implementation should occur in early 1995. The basic outline of the ARRL Comments filed on FCC Docket 93-305 by the April 21 deadline is contained in the June 1994 Update. For the moment the dollar cost for obtaining a vanity call license remains at \$7 per year annual fee - see Congressional Legislative Report, above.

#### Pacificon '95:

The Mount Diablo ARC has again agreed to sponsor the Pacific Division Convention. Many thanks! Details are in the Coming Events schedule.

#### Massive FCC Reorganization:

More pieces of the Aug. 1, 1994, reorganization are now falling into place. The Wireless Telecommunications Bureau is now in existence. This is the group which administers the Amateur Radio Service. The new Chief is Regina Kenney. Of significance is that there is an Enforcement Division of 30 people within this Bureau. We hope that this is another step in the direction of more and better enforcement of the rules.

ARRL President George Wilson, W4OYI, and the ARRL Washington Staff continue to call at the top of the FCC (Commissioners and Civil Service Staff).

#### **Electronic Filing of 610s:**

The first data interchange tests between selected VECs and FCC dealing with electronic filing of 610s has started. So far, the test results seem favorable. If all goes well, the FCC could be fully on-line with the new 610 process by the beginning of 1995. This action should continue to shorten the time between examination and issuance of license.

#### **New Pacific Division Appointments:**

With great pleasure I announce we have added a new Volunteer Counsel in the state of California. He is Al Crespo, WR6R, of Orinda. It is also with great pleasure I announce that Wallace Oki, KH6DJF, of Hilo, HI, has accepted an appointment as a Volunteer Consulting Engineer.

Welcome, Al and Wallace!

#### **Antenna Ordinances:**

Rusty Epps, W6OAT, continues to lead a Pacific Division-wide effort to develop a database of antenna ordinances and related materials. Rusty reports that data is coming in from all parts of the Division -- thanks! Send all the material to Charles K. (Rusty) Epps, W6OAT, 651 Handley Trail, Redwood City, CA 94062.

As this Update is being written, we are in the middle of what could be the most significant antenna ordinance trial of many years in the Pacific Division, if not nationally. This is the retrial of Hotz vs. Rich, of Foster City. A favorable outcome in this trial could have far reaching impact on the enforceability of CC&Rs involving Amateur Radio. Jimmy Rich, WD6CJB, is the defendant in this long running case. My thanks to Kip Edwards, W6SZN, Assistant Director, and Rusty Epps, W6OAT, Assistant Director and Volunteer Counsel, for spearheading this huge effort, and to Chris Imlay, N3AKD, General Counsel of the ARRL, Dave Leeson, W6QHS, Bob Vallio, W6RGG, Ted Harris, N6IIU, Howard Brainen, WZ6Z, Lou Beaudet, K6TMB, and many non hams for appearing as witnesses for Jimmy.

Known other antenna ordinance activities are currently underway in Fresno, Sonoma and Santa Clara counties and in Pleasant Hill, CA. All are being monitored closely. Please let me or Rusty know of activities in your area involving antenna ordinances.

## Pacific Division Member Receives ARRL Cover Plaque Award:
