The United Way Building, 1922 The Alameda, San Jose, (about one mile South West from the San Jose Air Port). From 1-880: take the Alameda turn-off going South for ½ block then turn left on McKendrie. From the South: go North on the Alameda, ½ block past Hedding turn right on McKendrie.

As soon as you turn onto McKendrie (heading East), turn right into the parking lot just behind the small church on the corner. It's best to park at the far end of the parking lot.

The entrance is up the steps at the South East corner of the building. There is wheelchair access at another door at the North East corner, but for security reasons, only one door is open at a time-someone will have to notify the guard if you need wheelchair access. Also, try not to be too late-the doors may be closed with nobody around to let you in.

The San Jose Red Cross: South-West corner of North 1st and Plumeria Dr. Plumeria is two lights North of Trimble and South of Montague Expressway. From the South on I-880, take the 1st Street exit, go North. From the North on I-880, take the Montague (Trimble) exit, go West to Trimble then turn right (North) on 1st, (if you miss Trimble, just follow Montague then turn left (South) on 1st. From the South on US-101, take the Trimble (De La Cruz) exit going North, then turn left (North) on 1st. From the North on US-101, take the Montague exit going North/West, then turn right (South) on 1st.

The main entrance faces Plumeria, go straight in past the front desk. The radio room is in back of the conference room on the left just past the rest-rooms. **Board meetings are open to all.**

As stated on the order form (part of the membership form--cover of the SCCARA-GRAM), a copy of your license is required. Some people did this, some didn't, but many of you expected us to still have the copy you sent in one or more years ago. If you could see things from my point of view, you wouldn't make that assumption! ©

Anyway, I filled in most of the gaps from the latest on-line Callbook. The upshot is that if you ordered the repeater codes, but have NOT receive them yet, there are four possibilities: 1) you didn't send in a copy of your license and couldn't be verified in the Callbook (KE6EOC, KE6DSB, KE6EOD, KE6FQV, KE6FTZ, KE6OUN, and KE6OUP); 2) your license is due to expire in 1995 or already has expired (WA6BYB WA6QYS, K6CAY, and WA6MYU); 3) it got lost in the mail; 4) we slipped up. In any case, let me know if you are still waiting.

Board Meeting, March 27, 1995



Attendance: Mike K8ERL, Hugh KD6EFL, Gary WB6YRU, Rex N6BUO, Don K6PBQ, Lou WA6QYS, Don KO6HH (sitting in for Dan Dietz WM6M), George AB6OZ, Don KK6MX, Imre KD6MZM, and Bob N6PCQ.

Meeting called to order at 7:23 PM, Mike K8ERL presiding.

KO6HH: Proposed SCCARA have a 2 meter QSO party (FM voice only) April 22, 1-4PM (local). A copy of the proposed rules were examined and will appear in the next SCCARA-GRAM. Seconded and passed unanimously.

7:30P checked in to the 2 meter net. 7:37 resumed. AB6OZ: Youth group committee will send out a SCCARA-GRAM and questionnaire to hams 17 or younger in the Santa Clara County (about 70). Will need to include postage for this and SASE. KO6HH motion to approve; seconded and passed unanimously.

K8ERL: Started discussion with United Way about reducing our meeting room cost... nothing yet. Also talked to San Jose Red Cross about radio room--negative response, (Scott KB6UOO is coordinating). We could probably meet at the Red Cross on Fridays. KK6MX suggests looking in to meeting at library's. K8ERL talked about meeting room costs and possibly meeting elsewhere.

KD6EFL: Tom Schiller N6BT from Force 12 Antennas will speak at the next meeting about antenna designs.

WB6YRU: We have received dues from over 120 members now. Most repeater codes have been sent, except those who didn't send in a copy of their license and there is no callbook record, or if license has expired.

N6BUO: Income so far this year: \$948.50 dues, \$49 raffle, \$11.65 other income \$1009. Expenses: \$184 meeting room rent, \$531 newsletter & misc., \$268 repeater, \$52 prizes, for a total of \$1277. Net total so far this year: loss of \$191.62. Meeting room rent has gone from \$75/mo to \$109.50/mo. Our total account has been going up roughly \$1500 per year, so we should be able to handle the new meeting room rent.

We might want to consider putting some of our savings into a CD to get more interest. Discussion followed. We will look into it and decide at the next board meeting.

WB6YRU: The latest Roster will go out with the next SCCARA-GRAM issue.

New Business K6BPQ: We should start looking into a place for the 1995 December dinner meeting. The last one was good, but a little crowded. Discussion followed regarding cost per person, type of restaurant, etc.

WA6QYS: SCCARA will host the May 13 Foothill flea market. We need at least 24 people, 16 volunteered so far.

SCCARA Contest

Two Meter QSO Party

On Saturday, April 22, from 1 to 4 PM, SCCARA will have an informal contest open to members and hams under 18 years old who are sponsored by a member.

To make a contact (a QSO) call "CQ SCCARA" on one of the frequencies 147.405, 147.420, 147.465, or 147.495 MHz FM simplex or answer a "CQ SCCARA." Give your name (you can use a nickname, but use the same name for all exchanges), city; and record the name, city, and call sign of the other station.

Only two way contacts with members or sponsored hams count for credit. If the other station has a KE6 prefix the contact is worth 5 QSO points, a KD6 prefix is worth 3 QSO points, and any other prefix is worth 2 QSO points.

The total score for any station is the sum of the QSO points times the multiplier. The multiplier is 10 for hams who are first licensed in 1995, is 5 for those first licensed in 1994, 2 for those first licensed in 1993, and 1 for all others. For example: if KE6OUG, who is first licensed in 1994, makes contacts with K8ERL (2 QSO points), KD6EFL (3 QSO points), N6BUO (2 QSO points), and KE6FBY (5 QSO points); he will have a total of 12 QSO points, a multiplier of 5 and a total score of 60.

Other rules:

- 1. Only three consecutive contacts can be made on a frequency before changing frequencies.
 - 2. Only one transmitter at a time can be used.
- 3. Only the frequencies listed above can be used.
- 4. Any one entry must be single operator, except any number of KE6 operators can be added to a single operator station.
 - 5. Maximum power is 50 watts.
- 6. All stations should reply to calls (i.e. it is not proper to make contacts only with a friend and not reply to others).
- 7. KE6 and KD6 prefixes mentioned above only apply to 2X3 calls. For example, a contact with KD6SV would be worth 2 QSO points.
- 8. A station may be contacted only once for credit (no duplicate contacts).
- 9. All entries must be in the hands of a contest committee member by May 15, 1995, by US Mail or hand delivered at the May General Meeting.
- 10. If you are not a member of SCCARA and are under 18 years old, ask a SCCARA member to sponsor you. Any member can sponsor any number of hams under 18. Call AB60Z at 408-729-9012 if you need a sponsor.

Silent Keys

Goodbye to W6AVJ and W6LD0

Sadly, we must report the passing of two long time SCCARA members during the months of February and March.

Walter Nelson, W6AVJ, passed away on February 19. Walt joined the club in 1947 after he passed his license exam and received his Class B License and call. Walt was active on 10 meters in his early years in SCCARA and worked on several committees, taking part in a number of club events in the late 1940's and early 1950's. He served as Vice President for two terms, and during the mid 1950's he worked with his brother-in-law, Al Gaetano, W6VZT, teaching amateur license classes for SCCARA in the old Red Cross Headquarters at 440 North First Street.

Walt graduated from San Jose High School and, after serving in the Navy, attended San Jose State University where he earned a BS Degree in Electrical Engineering. He worked for Varian Associates in Palo Alto for over 30 years, retiring in 1988.

Walt's late father, "Pop" Nelson, W6FON, was also active in the Club, serving as Treasurer for a number of years. His sister, Helen, married Al Gaetano, W6VZT. For a time, Helen held the call KN6HGJ, so most of Walt's family members were radio amateurs and SCCARA members.

Walt leaves a wife, Marly and one son, Scott.

Walt, who was primarily a "phone man", worked DX on the HF bands. In 1990 he passed the Extra Class License exam, mostly because it was a challenge. While he spent most of his time on 40 through 10 meters, he also worked the LPRC repeater on regular basis. While he was not very active in SCCARA during recent years, he will be missed by many old friends in ham radio.

Walter Drozdiak, W6LDO, passed away on March 15. Walt joined the club in the early 1950's and attended many meetings and club events over the years. At one time

he was very active on the Northern California CW Net and other nets of the ARRL National Traffic System and handled a great deal of traffic for service men during the Korean War.

In the later 1930's, Walt worked as a shipboard radio operator on a "banana boat" between the U.S. and Panama. When WWII broke out, he joined the Army as leader of a radio intelligence unit in General George Patten's 3rd Army in Europe. He served with Patten at the Battle of the Bulge and was decorated with the Bronze Star and four battle stars.

After WWII, Walt earned his degree in Dentistry at Northwestern University's School of Dentistry. He and his new bride came to San Jose in 1950 where he established a dentistry practice on Forest Avenue across from Valley Fair. Many of us were his patients during his 43 year career.

It was during those early days that he set up his own ham station and joined SCCARA. He was an excellent CW operator and it was a pleasure to take and receive traffic from him. We will miss his clear crisp signals.

ARRL Pacific Division Update

April 1995

Vanity "Preferred" Call Signs:

The bad news from FCC is that the 610-V form will not be available until May 1, 1995. The FCC has also said they have received "hundreds of inquiries" so far. The FCC says they have no means to handle backlog requests, all requests received prior to May 1, 1995, will be discarded. A phone number was given for inquiry after May 1, 1995, 1-800-418-3676.

The good news is that the ARRL-VEC will accept SASE requests for 610-V forms NOW and will send you the forms when they are received. Send to ARRL-VEC, 225 Main St, Newington CT 06111-1494. Be sure to include a SASE.

There has been NO announcement of the starting dates for the various "gates" in the program. See March 1995 QST, page 98, for further details.

The one part of the program which will start on March 24, 1995, is the ability to apply for new club and MIL/REC call signs. The club call sign procedure will start with the issuance of sequential calls, probably from the Technician/Novice call sign block. There is to be a new form 610-B for this purpose, but it is not yet approved by OMB. In the meantime, to apply for a club call sign you can use the Form 610-B dated March 1992 and write "NEW" in the call sign box at the top of the form (item #1). Form 610-B can be obtained from the ARRL/VEC for a SASE. Mail the completed club call sign application form 610-B (with a copy of the trustee's license) to FCC, 1270 Fairfield Rd, Gettysburg PA 17325-7245.

In order to apply for a "vanity call sign" for a club, you must already have a club call sign or have obtained one under this new program. A club trustee would then apply for a vanity call based on the "gate" timing and within his license class for call sign format. See page 98, March 1995 QST for more details.

A Club Call Sign Application Fact Sheet by FCC will be released soon (date unknown) which is expected to fully define the process.

On the issue of what call signs from what call sign areas are to be available, the ARRL and several individual hams have filed Petitions for Reconsideration of paragraph 10 of this docket. The petitions are to restrict the availability of call signs to the call sign area of residence as proposed by ARRL and QCWA originally. This portion of the proposals was rejected by FCC. According to the present plan a qualified applicant may apply for call signs in any call sign area, including KH6, KH0, KL7, KV4, etc, even though the applicant is not a resident of the area for which application is made. There is no date known by when the FCC will make a decision on the Petitions for Reconsideration. However, no delays in the program are expected, for this aspect of the call sign assignment will not be applicable until "gate 2" of the program. Again, please read page 98 of the March 1995 QST for details. The ARRL-VEC also has an information sheet available to answer questions if you will send an SASE to ARRL-VEC 225 Main St, Newington CT 06111-1494. The cost for any "vanity call sign" will be \$70 for the ten year license based on the current statutes.

Some additional thoughts for those of you concerned with recovering Silent Key call signs of close relatives, please be ready. Be sure that you or some close relative is licensed at some level.

13 cm Band-- WE WIN BIG TIME!

On Feb. 7, 1995, at the FCC Open Meeting, it was announced by the Commissioners that the Amateur Service not only retained our 2390-2400 MHz and 2402-2417 MHz spectrum, but we were upgraded from Secondary Allocation to Primary Allocation!

There was no reallocation of 2300-2310 MHz as it was not involved specifically in this matter although some commenters wanted to pair up this segment with 2390-2400 MHz. The battle over 2300-2310 MHz will likely surface again in 1995 to meet NTIA's schedule of transfer in 1996. Be prepared again!

While celebrations are in order for now, please remember that we were in a very similar position a few years ago in the battle for 220-222 MHz.

In the Report and Order there was a second NPRM regarding related matters. As in the past on this Docket, the time frame for reply was very short (comments due by March 20; reply comments due April 4). Again, Jim Von Striver, W6ASL (the spokesman for the Pacific Division Spectrum Committee), NARCC, NCPA, and many others have stepped up to file comments and support the ARRL comments in a timely fashion.

I thank them and many others, again, for all the effort put into the "Save 13 cm" campaign. For more background information, please see the article on page 24 of the April 1995 QST and a follow-on due in the May 1995 QST.

FCC News:

Although there is no official announcement, it appears that the Compliance and Information Bureau (formerly FOB) field offices face a reduction in staff and number of locations. There are no specific details as yet known.

On March 17, the FCC issued a Report and Order on ET Docket 93-40 concerning the 219-220 MHz band. The Amateur Service has been awarded, on a secondary basis, permission to use a point to point fixed digital message forwarding service. More details should be available soon

Congressional Legislative Report:

The ARRL staff has developed our national legislative agenda for 1995 which was approved by the ARRL Board at the January 1995 meeting. As we are always looking for new ideas, please contact me or Vice Director Jim Maxwell, W6CF, if you cannot reach me, with your ideas. Ideas being proposed include reintroduction of the HR 4522 bill concerning vanity call sign application fees; protection for volunteers while performing their specific tasks, such as OOs, VEs; spectrum protection; enforcement issues; to name but a few.

As you have all read, the 104th Congress is just getting started, so it is too early to really determine what Congress is likely to do about amateur radio legislation.

As I reviewed again the support for amateur radio I would expect from our Pacific Division Congressional Delegation, it looks much as it did in 1994. You all did a great job in obtaining the co-sponsorships of our bills in 1994 and I would expect similar response from the delegation to our legislation plans this year.

Please thank those who were our co-sponsors in 1994. Please contact the new members of Congress concerning amateur radio - in CA, Frank Riggs in the 1st, Zoe Lofgren in the 16th, and George Radanovich in the 19th; and in NV, John Ensign in the 1st. We will be needing all their help.

Again, many thanks for all the 1994 grassroots work!

Antenna Ordinances:

Rusty Epps, W6OAT, continues to lead a Pacific Division-wide effort to develop a database of antenna ordinances and related materials. Rusty reports that data is coming in from all parts of the Division -- thanks! Send all the material to Charles K. (Rusty) Epps, W6OAT, 651 Handley Trail, Redwood City, CA 94062.

Ken McTaggart, N6KM, Volunteer Counsel, and John Wallack, W6TLK, Section Manager - San Francisco Section continue to lead the charge on the potentially very explosive proposed Sonoma County antenna ordinance. This ordinance as currently proposed not only involves tower restrictions of the common nature but proposes to add an

RF intensity at the property boundary line measurement criteria. If such a proposed ordinance is passed, it would be the first such in the US. The ARRL is very involved in supporting Ken and John as they wrestle with this proposed ordinance. Keep up the good work, Ken, John, and all others involved!

Other known other antenna ordinance activities are currently underway in Fresno and Santa Clara counties, cities of San Jose and in Pleasant Hill, CA. All are being monitored closely. Please let Rusty or me know of activities in your area involving antenna ordinances.

Scholarships and Awards:

There are many scholarships and awards covering a wide range of situations available to licensed Amateurs. The ARRL Foundation, The Dayton Amateur Radio Association, The Foundation for Amateur Radio, to name only a few, will be announcing their dates for applications for their 1995 scholarships.
