<u>The United Way Building</u>, 1922 The Alameda, San Jose, (about one mile South West from the San Jose Air Port). <u>From</u> <u>1-880</u>: take the Alameda turn-off going South, then turn left immediately on McKendrie. <u>From the South</u>: go North on the Alameda, ½ block past Hedding turn right on McKendrie.

As soon as you turn onto McKendrie (heading East), turn right into the parking lot just behind the small church on the corner. Park at the far end of the lot. The main entrance is up the steps at the South East corner of the building. There is wheelchair access at another door at the North East corner, but for security reasons, only one door is open at a time--someone will have to notify the guard if you need wheelchair access. Also, try not to be too late--the doors may be closed with nobody around to let you in.

<u>The San Jose Red Cross</u>: South-West corner of North  $1^{st}$  and Plumeria Dr. Plumeria is two lights North of Trimble and South of Montague Expressway. From the South on I-880, take the  $1^{st}$  Street exit, go North. From the North on I-880, take the Montague (Trimble) exit, go West to Trimble then turn right (North) on  $1^{st}$ , (if you miss Trimble, just follow Montague then turn left (South) on  $1^{st}$ ). From the South on US-101, take the Trimble (De La Cruz) exit going North, then turn left (North) on  $1^{st}$ . From the North on US-101, take the Montague exit going North, then turn left (North) on  $1^{st}$ . From the North on US-101, take the Montague exit going North/West, then turn right (South) on  $1^{st}$ . The main entrance faces Plumeria (North). <u>Board meetings are open to all.</u>

President, K8ERL: About the cost of our meeting place... I talked to the United Way people, but the charge for the room is firm. We could meet at the San Jose Red Cross, but probably not on Monday.

Joe WA6DXP will stop making up the mailing labels after this time. WB6YRU: That falls within the editor's duties anyway; I'll do it, no problem.

Secretary, WB6YRU: We have 130 dues members

and 35 "honor" members.

# **Packet Pieces**

## Downloaded from the packet network:

#### QRT

At about 0015 UTC April 1, 1995, NMN the U.S. Coast Guard station in Chesapeake, Virginia tapped out the end of its final message with a long "SK" and gave the frequency over to static.

The U.S. Coast Guard had followed the example of all of the other services and ceased to use Morse Code. The U.S. NAVY had long ago given up CW in their communications. Everything is now sent by voice or digital modes. In April 1993, the Coast Guard had ceased CW operations on medium wave frequencies (400-500 KHz). In June of that year they graduated their last class of commspecialists who were trained to use the code.

The use of CW by merchant ships has declined in recent years as it has for hams and the military. However, managers for shore stations KFS (San Francisco) and WLO (Mobile) report that the decline of CW has stopped. Both stations plan to continue offering CW service to those ships whose owners will not or cannot afford the additional expense of new computer equipment.

At 2300 UTC March 31st, the operator at NMN worked a few last ships. As operator on the SS LANE VICTORY (KECW), I checked in to give them one last 73. The operator was sad and a little nervous as I imagine there were many watching him. The contact was smooth as any one of the hundreds of thousands the Coast Guard has handled over the years. Even though the crisp formality of commercial message handling was in the past, he still took the time to ask QRU? I had no message. I just wanted to say good bye.

RFI changes proposed

The FCC has proposed to permit manufacturers and suppliers of computers and computer peripherals to market their equipment without having to apply for equipment certification and await FCC approval, in ET Docket 95-19.

These devices now must be FCC-certified to ensure that they do not cause interference to radio services, including amateur. Certification requires that all measurement data and a detailed description of the product be submitted to the Commission's laboratory for review and approval.

The certification process can take 35 days or more, the FCC said, and eliminating the wait could save the computer industry some 250 million dollars a year, the industry has said. The FCC called the current regulations "particularly burdensome for small manufacturers" and said its proposed new authorization procedure would "align" FCC requirements for personal computers with those "used successfully in other parts of the world."

Under the proposed new procedure, FCC

authorization would be replaced by a process based on a manufacturer's or supplier's Declaration of Conformity (DoC). The Commission also has proposed the option of permitting personal computer compliance to be based on tests and DoCs of individual components, without further testing of completed assemblies.

Petition threatens W1AW

A petition for rule making before the FCC would eliminate all one-way transmissions such as code practice and information bulletins on the amateur bands below 30 MHz, including those from W1AW.

The FCC has assigned file number RM-8626 to the petition, which was filed by Frederick O. Maia, W5YI, publisher of the commercial newsletter the W5YI Report. The petition seeks to eliminate the rules that permit one-way information bulletins and Morse code practice in the amateur bands below 30 MHz. The effect of the petition would be to silence W1AW bulletin and code practice transmissions, among others.

Maia calls the FCC rule that permits certain one-way transmissions on the amateur bands "a very permissive category and taken in its broadest context, permits just about anything to be transmitted that is even remotely associated with the Amateur Service."

Maia says that code practice is now available on computer software, and information bulletins about Amateur Radio can be had on various computer on-line services.

Comments on the petition may be sent in the form of a letter to the Secretary, FCC, Washington, DC 20554. The file number, RM-8626, should be shown prominently at the top. An original and five copies is preferred, but single copy comments will be accepted.

A copy should also be sent to Mr. Maia's lawyer, Raymond A. Kowalski, Keller and Heckman, 1001 G Street NW, Washington DC 20001. The deadline for comments on the petition is May 4, 1995.

## Vanity "Preferred" Call Signs

Mar. 24 was the date hams could start applying for "sequentially issued" club call signs. This part of the program is underway, and I understand that some club call signs have already been received.

FCC continues to state that the 610-V form (for the Vanity Calls) will not be available until May 1, 1995. The FCC has also said they have received "hundreds of inquiries" so far. As the FCC says they have no means to handle backlog requests, all requests received prior to May 1 will be discarded. A phone number of 1-800-418-3676 was given for inquiry after May 1.

The ARRL-VEC will accept SASE requests for 610-V forms now and will send you the forms when they are received. Send to ARRL-VEC, 225 Main St, Newington CT 06111-1494. Be sure to include an SASE.

There has been no announcement of the starting dates for the various "gates" in the program. See March 1995 QST, page 98, and April 1995 QST, pages 9 and 89 for further details.

The club call sign procedure has started with the issuance of sequential calls from the Group D call sign blocks. There is to be a new form 610-B. In the meantime, to apply for a club call sign you can use the existing Form 610-B dated March 1992 and write "NEW" in the call sign box at the top of the form (item #1). Form 610-B can be obtained from the ARRL-VEC for an SASE. Mail the completed club call sign application form 610-B (with a copy of the trustee's license) to FCC, 1270 Fairfield Rd, Gettysburg PA 17325-7245.

In order to apply for a "vanity call sign" for a club, you must already have a club call sign or have obtained one under this new program. A club trustee would then apply for a vanity call based on the "gate" for his or her license class.

A Club Call Sign Application Fact Sheet by FCC has been released to fully define the process. The ARRL-VEC also has an information sheet available to answer questions if you will send an SASE to ARRL-VEC 225 Main St, Newington CT 06111-1494.

On the matter of what call signs from which call sign areas are to be available, the ARRL and several individual hams have filed Petitions for Reconsideration of paragraph 10 of the Vanity Call Sign Docket. The petitions are to insure the availability of call signs from ONLY the call sign area of residence as proposed by ARRL and QCWA originally and currently rejected by FCC. The FCC plan currently makes any available call sign in any call sign area --KH6, KH0, KL7, KV4, W6, W7, et al -- available to any applicant. There is no date known by when the FCC will make a decision. However, this aspect of the call sign assignment will not be applicable until later in "gate 2". See May 1995 QST, page 95 for more details.

The cost for any "vanity call sign" will be \$70 for the ten year license based on the current statutes.

Some additional thoughts for those of you concerned with recovering SK call signs of close relatives, please be ready. Be sure that you or some close relative is licensed at some level.

## 13 cm Band--WE WIN BIG TIME!

On Feb. 7 it was announced by the FCC that the Amateur Service not only retained our 2390-2400 MHz and 2402-2417 MHz spectrum, but we were upgraded from Secondary Allocation to Primary Allocation!

There was NO reallocation of 2300-2310 MHz as it was not involved specifically in this matter although some commenters wanted to pair this segment with 2390-2400 MHz. The battle over 2300-2310 MHz will appear again in 1995 to meet NTIA's schedule of transfer in Aug. 1995. Be prepared again!

While celebrations are in order for now, please remember that we were in a very similar position a few years ago in the battle for 220-222 MHz.

May 1995 QST on page 94 contains a "2400 MHz Honor Roll" honoring those organizations and individuals who contributed to this win.

#### We get new Spectrum -- 219-220 MHz

On Mar. 17, the FCC issued a Report and Order on ET Docket 93-40 awarding operating privileges in the 219-220 MHz band effective April 26, 1995. The Amateur Service has been awarded, on a secondary basis, permission to use a point to point fixed digital message forwarding service. As we will be sharing this spectrum with other services, ARRL, acting as a "national contact point" for "local amateur coordinators," will provide information on known current licensees in these other services. See page 9 of May 1995 QST and the R & O for more detailed information.

# NTIA report outlines future amateur radio spectrum

The National Telecommunications and Information Agency (NTIA) on April 7 released a report on US National Spectrum Requirements. The report describes a 10 year projection of spectrum requirements needed to support evolving radio communications requirements in the United States, based on comments to a June 1992 Inquiry, NTIA studies, and other available literature. It describes the present and projected uses of spectrum within the United States for all licensed radio services.

The ARRL filed extensive comments in response to the 1992 Inquiry. The report finds a requirement for an additional 2,180 KHz for the amateur services, as follows:

The executive summary of the report has this to say about the Amateur and Amateur-Satellite Services:

#### Amateur Service

The amateur and amateur-satellite service allocations have been based, in part, on the desirability of having a choice of relatively narrow frequency bands distributed throughout the spectrum with different propagation properties. Current amateur allocations start at 1800 KHz and, in narrow bands, extend to 250 GHz.

#### Amateur-Satellite Service

The amateur-satellite service will soon have a new generation of amateur satellites in orbit that will use all frequency bands allocated to the amateur-satellite service from 29 MHz through 24 GHz. For this reason, the retention of current allocations, additional amateur-satellite allocations, and the upgrading of certain current allocations is desirable. While the NTIA recognition of our requirements will not by itself lead to fulfillment of those requirements, it is a significant step that begins the journey toward that objective and is an excellent example of both the importance and the success of our advocacy efforts.

## FCC News

The FCC announced that new call sign blocks will be available for Hawaii, Alaska and Puerto Rico. Although details of when and how they will become available are not known, the new Hawaii calls will begin with KH7, AH7, NH7, and WH7. Availability presumably depends on the exhaustion of the current "6" call sign blocks and the completion of the "Vanity Call Sign" program development.

Although there is no official announcement, it appears that the Compliance and Information Bureau (formerly FOB) field offices face a reduction in staff and number of locations. While there are few specific details available, further information on FCC reorganization is contained on pages 20 and 95 of May 1995 QST.

## **Congressional Legislative Report**

Steve Mansfield, N1MZA, ARRL Manager of Legislative Programs and Public Affairs made some significant calls in late March on a number of the Legislative Assistants to new members of Congress including George Radanovich in the California 19<sup>th</sup> District and John Ensign in the NV 1<sup>st</sup>. Many thanks for all your 1994 grassroots work!

## Antenna Ordinances and related matters

Rusty Epps, W6OAT, continues to lead a Pacific Division-wide effort to develop a database of antenna ordinances and related materials. Rusty reports that data is coming in from all parts of the Division -- thanks! Send all the material to Charles K. (Rusty) Epps, W6OAT, 651 Handley Trail, Redwood City CA 94062.

Ken McTaggart, N6KM, Volunteer Counsel and John Wallack, W6TLK, San Francisco Section Manager continue to lead the charge on the potentially very explosive proposed Sonoma County antenna ordinance. The latest information indicates that Sonoma County may not adopt an "RF intensity at the property boundary line measurement" criteria. If such a proposed ordinance involving RF intensity measurements were to pass, it would be the first such in the US. Keep up the good work, Ken and John, and thanks to all others working locally on this challenge!

## **Scholarships and Awards**



# Field Day is coming up!

### Field Day contest weekend is June 24-25. Mark your calendars!

For those who are new to amateur radio: Field Day is one of the biggest radio contests of the year. The underlying idea is to give amateurs practice making contacts under disaster conditions. This means the participants are encouraged to set up and operate portable stations. You can operate at home, but it's better (worth more points) to "setup shop" elsewhere. For the past several years we have been going up to Mt. Madonna County Park (Southern end of the county). We usually have a variety of stations and antennas. The stations include phone, CW, digital, novice, solar, VHF, etc. The antennas include: couple of beams on towers (one is a sizable crank-up on a specially made trailer), a long wire, and miscellaneous dipoles and verticals. The more exotic the power source, the better. We usually use batteries, generators, and solar cells. We operate under a classification where several transceivers are on the air at one time. We are allowed a certain amount of time to set up--that's why some of us go up Friday afternoon. Once set up, we have 24 hours (starting at a specific time) to make as many contacts as possible. It's a lot of fun and a great way to hone those operating skills! Everyone is encouraged to participate. You can make a weekend of it or just show up for part of it, whatever you like.

The 1995 SCCARA Field Day weekend will again be held at Mt. Madonna County Park on June 24 & 25. Anyone who joins the group going up on Friday, June 23 and stays through Sunday helping with both setup and tear-down will be able to stay for free. All others need to pay the camping fee of \$8.00 per night per vehicle. Those who won't be staying overnight will be responsible for paying the "day use" fee themselves at the Park entrance.

A Field Day Committee and set-up group will be forming soon. Dan WM6M agreed to be the SCCARA 1995 Field Day Chairman, but he has been away for most of the last few months, so...? If you are interested, stay tuned.

The club will be serving a BBQ dinner at 1:00 PM on Saturday and breakfast on Sunday morning. The Saturday dinner will be your choice of steak or chicken, plus all the "fix'ns".
