President's Prose

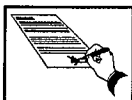

First street San Jose. The price at that time was \$12/\$15 (for Friday, Saturday, and Sunday) because of the cost of the hotel to our club! We even sent out 17,000 mailers to amateurs within the pacific area. Many of our SCCARA club members got together at a school near Bascom and Camden area. The convention chairman was AE6Z, "Shorty" Freitas.

Pacificon 95 is now sponsored by the Mount Diablo Amateur Radio Club and will be held at the Hilton hotel in Concord CA on October 20-22 1995. The cost is \$3.00 in advance, \$5.00 at the door. What a reasonable price. Check packet "PACINFO" for updates. 800-826-2644 will get you to the hotel reservations (only \$72.00 per night, single/double, mention the Pacificon '95 convention). Registration opens Friday 12:00 noon, Saturday at 6 AM, and Sunday at 8 AM. Remember, price of admission is good for all 3 days. You only need to register once!

Forums will be informative, they include: Computer Aided Antenna Design Fri 8:00am-3:00pm. Much more will be available on Sat. and Sun. The convention includes a flea market in a parking lot across the street from the hotel at the shopping center on Sat 6:00 AM to 11:00 AM. The United Way Building, 1922 The Alameda, San Jose, (about one mile South West from the San Jose Air Port). From I-880: take the Alameda turn-off going South, then turn left immediately on McKendrie. From the South: go North on the Alameda, 1/2 block past Hedding turn right on McKendrie.

As soon as you turn onto McKendrie (heading East), turn right into the parking lot just behind the small church on the corner. Park at the far end of the lot. The main entrance is up the steps at the South East corner of the building. There is wheelchair access at another door at the North East corner, but for security reasons, only one door is open at a time--someone will have to notify the guard if you need wheelchair access. Also, try not to be too late--the doors may be closed with nobody around to let you in.

The San Jose Red Cross: South-West corner of North 1st and Plumeria Dr. Plumeria is two lights North of Trimble and South of Montague Expressway. From the South on I-880, take the 1st Street exit, go North. From the North on I-880, take the Montague (Trimble) exit, go West to Trimble then turn right (North) on 1st, (if you miss Trimble, just follow Montague then turn left (South) on 1st). From the South on US-101, take the Trimble (De La Cruz) exit going North, then turn left (North) on 1st. From the North on US-101, take the Montague exit going North/West, then turn right (South) on 1st. The main entrance faces Plumeria (North). Board meetings are open to all.

KO6HH: Nominations are coming up. Think about it.

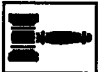
K8ERL: Are we going to have a General class? We need

upgrade from Novice or Technician to General Class. The

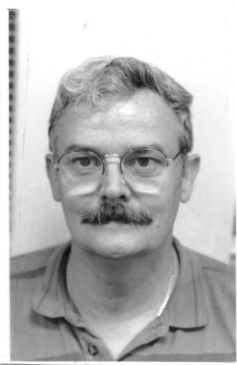

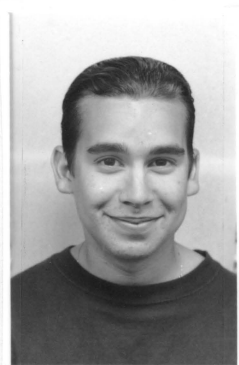

Introduction To Packet Radio

Part 5

USING A PACKET BULLETIN BOARD SYSTEM

In this part of the series I will introduce you to the basics of bulletin board system (BBS) use; in part 6 I will discuss BBS commands in detail. There are now dozens of different packet radio bulletin board system programs available to the packet community. You might find a few minor differences in the commands used, but for the most part they are the same. If you find that a command does not function as I describe here, use the ? or H - HELP command to get more specific details for the BBS program you're using.

You connect to a BBS exactly the same way as you connect any other station. Don't forget the SSID for the BBS call sign if one is required. Once you're connected,

you will receive a welcoming message, information for that particular BBS and some basic instructions. Read the information and the instructions carefully. The first or second time you connect you might receive a request to enter your name, QTH, zip code, and home BBS for the system's user file. Some systems will simply ask you for the information, while others will ask you to "register". On some systems, the software will not allow you to use any of the commands except HELP until you have entered this information.

After you receive the welcoming message and information from the BBS, you should note that the last line ends with a >. This is known as the PROMPT. When the BBS sends the prompt it is telling you that it has finished sending you information, and it is waiting for you to tell it what to do next. You do this by sending it a command. You must follow each command by a carriage return <CR>, just like on your TNC, which you send by hitting the "Enter" or "Return" key.

When checking in to a BBS for the first time, you should become familiar with the commands available to you. Enter a ? or H and read the general instructions for the BBS you're using. It should tell you how to get a list of the commands that are available. Review the command list to see what features the BBS offers.

When entering a BBS command, you must be careful to enter it exactly as the program requires. Some commands are just a single letter, while other commands require added information. Computers are not very forgiving and expect things to be entered in proper form. Enter only one command at a time, and be sure to read the information that is sent to you by the BBS. Take your time, check out the various features that the BBS offers and enjoy yourself. There's no need to feel rushed or intimidated. If you get to a point where you don't know what to do next, don't give up and disconnect. Enter a ? or H again for further assistance. That's what the help information is there for! Remember this important point: whenever you're using a BBS and you don't know what to do next, enter a ? or H for the HELP instructions. I suggest that you make a printed copy of the complete help document so that you have the information available as a reference when using the BBS.

Now let's go through the basic procedures you should follow when checking into a BBS. After you connect and receive the welcome message, you will receive a list of your mail if there are any personal messages addressed to your call sign. Enter the command RM to read your mail. (If that command isn't available, note the message numbers and then enter: R followed by the message numbers, separating each by a space. Example: R 24112 24174)

If there were messages addressed to you, you should

erase or "kill" them once you've read them. You can do this with the KM command, which means "Kill Mine". This command will erase all messages that are addressed to you that have been read. You can also kill each message individually by entering K XXXX, where the X's are the message number.

After reading your mail, the next thing I recommend that you do is list the new bulletin messages, by entering L. The BBS program updates the user file each time you check in, logging the latest message number. The next time you check in, only the new messages that have been received by the system are included in your list. The first time you check in, you might want to avoid using L by itself. Many systems have more than 1000 active messages available, and since you haven't seen any of them, the L will list all of them for you. As an alternative, I suggest that you use the LL (LIST LAST) command. You enter LL followed by a space and then the number of messages you'd like to see, such as LL 30 to list the last 30 messages that were received by the BBS. When you receive the list, you'll note that each message has a number, and that the size of the message, the topic, the originating station, a date and time, the subject, and other information are given. I will discuss each of these parts later in the series. For now, note the numbers of the messages you're interested in reading - that's the number to the far left of the screen.

Some BBS programs have a paging feature that will send just enough information to fill your screen and then stop. You simply enter a CR by hitting the "Enter" or "Return" key to tell the BBS to continue. When listing the new messages, you might have the option of reading the ones you're interested in before continuing with another page from the message list. As mentioned earlier, be sure to read the information that is sent to you by the BBS program before you proceed with your next operation.

To read the messages you're interested in, you enter R XXXX, where the X's represent the message number(s), such as R 14521 14528. Note that there is a space between the command and the number. If the paging feature is not available or not turned on, it's best to "capture" your messages or have your printer turned on when reading messages. They're apt to come in faster than you're able to read them. (By "capture" I mean using your communications program to save incoming data to a file. You can read it later after you've disconnected from the BBS.)

Once you've read all the messages you're interested in, you have several options. You can look back at old messages, send messages to other stations, see what's available in the file directories - the BBS library, download a file, upload a file, check the list of stations that have recently checked in to the BBS or stations that have been heard on the BBS frequency, check the status of the BBS

to find out what other stations are connected and who has mail waiting for them, or a variety of other things. We look at the BBS commands in detail in part 6 and explain how to do all of these things and more.

So that we don't leave you connected forever, when you're ready to leave the BBS, enter the B command (bye). You should always use the B command rather than just disconnecting so that the system updates your user file.

FCC notifications begin

The FCC has begun mailing notices of upcoming amateur license expirations. Those amateurs whose licenses would expire in December 1995 are being sent, by first class mail, a computer-generated Form 610-R "short form."

The Commission's Gettysburg facility expects to mail more than 5000 such notices this week, covering expirations from December 1 to December 20, 1995.

The new Form 610-R may be signed, dated, and returned to the FCC to renew the license, provided that no changes (such as address) are needed. It will be permissible to correct misspelled words. For other changes along with renewal, it will be necessary to file a regular FCC Form 610.

For some time the ARRL has been sending license expiration notices as a free membership service. That service will be discontinued once the new FCC program is established.

There is no monetary fee for an amateur license renewal.

NEW RFI BOOK FROM THE FCC

The Federal Communications Commission has released a new interference handbook for consumers. The 24-page, full color book will be stocked by fcc field offices around the country to provide people experiencing interference to home electronic equipment with information and solutions to interference problems.

The book deals not only with interference to televisions from radio transmitters, but also illustrates and describes interference caused by poor antennas (weak signals, ghosting), electrical interference from home devices such as hair dryers, electrical interference from power lines, interference from home computers, and low power radio devices such as garage door openers.

In addition to interference to televisions, the handbook describes solutions to interference to hi-fi systems, telephones, and video cassette recorders. Techniques for solving problems include the use of ferrite cores, improving receiving antenna systems, checking cabling, and isolating interconnected units to find the one that is at fault.

The book lists addresses and phone numbers for sources of high pass filters, common mode filters, band reject filters, ferrites and beads, AC line filters, telephone filters, and interference resistant telephones, as well as an extensive list of manufacturers of home electronic equipment.

Page one of the new FCC interference handbook says "Many interference problems are the direct result of poor equipment installation. Cost-cutting manufacturing techniques, such as insufficient shielding or inadequate filtering, may also cause your equipment to react to a nearby radio transmitter. This is not the fault of the transmitter and little can be done to the transmitter to correct the problem. If a correction cannot be made at the transmitter, actions must be taken to stop your equipment from reacting to the transmitter."

ARRL laboratory supervisor Ed Hare, KA1CV, says, "This is the statement from the FCC that hams have been waiting for. The book takes a fair and honest approach to explaining responsibilities and cures for interference problems. The FCC team that put this together has done a fine job with a complex technical and emotional subject." [Editor's emphasis]

Telecommunications Reform

Telecommunications reform is one of the key topics in Washington DC currently as Congress returns from its August Recess. Both the House and Senate have passed differing Telecommunication Reform Acts. Apparently these bills focus on broadcast TV, cable TV, telephone service, and related matters. It appears that these bills do not affect the Amateur Radio Service directly, but there may yet be surprises. In September, a conference committee from both houses will try to reconcile the differences between S. 652 and H. R. 1555.

There are also various other proposals floating around Washington DC, including proposals to eliminate the Department of Commerce and the FCC. This latter idea comes from the "Progress and Freedom Foundation," a "Think Tank" group consisting of folks with various political views. The proposal, essentially, is to eliminate the FCC and allocate the entire RF spectrum on a "property rights" basis.

The mood in Congress seems to be to enact some sort of telecommunications reform, but just what, is unclear so far.

The ARRL Washington Team continues to monitor these developments and be active on our behalf. See September QST page 50 and October QST page 53 for more details.

Wireless Technologies Restructuring

The Office of Technology Assessment of the U.S. Congress has just published a 300 page document describing several concepts of a "fundamental restructuring of the U.S. communications and information technology infrastructure." Although targeted on the telephone, computer, cable television, cellular telephone, satellite, and broadcasting aspects and how they might relate to the National Information Infrastructure (NII) concept, it appears to have ready application in the Amateur Radio Service. With the ongoing U.S. Congress efforts on Telecommunications Reform, this document would appear to be very important to the future of all telecommunications as it discusses various options and potential plans. There is some reference to Amateur Radio in side comments, but "between the lines" reading may suggest other more profound possibilities.

This document, "Wireless Technologies and the National Information Infrastructure," OTA-ITC-922, dated July 1995, can be obtained from the U.S. Government Printing office for \$19.

Vanity "Preferred" Call Signs

It appears as though the program for the actual application for call signs, other than the club call sign part of the program, will continue to be delayed. There are various stories targeting "late 1995."

The fee for a vanity call sign has been reduced by the FCC to \$30 from \$70 effective September 18, 1995.

Additional details regarding availability of the necessary forms can be found in previous editions of this Pacific Division Update and in QST.

FCC News

On Aug. 17, FCC Chairman Reed Hundt proposed actions to save money, including personnel reductions and facility closings. In the Pacific Division, the Honolulu HI field office and the Livermore CA monitoring station would be closed by the summer of 1996. The Honolulu field office is now part of the FCC's San Francisco Region as the Seattle Regional office is now closed with the retirement of the Regional Director.

One facility, in Laurel MD, would be the central site for "electronic monitoring." The FCC will add a new centralized FCC Call Center, where for the first time members of the public anywhere in the United States will be able to call one toll-free number to reach the FCC for information or assistance. See October QST page 15 for more details.

In another announcement, the FCC is considering privatizing the resolution of radio frequency interference to consumer electronics devices. Under the plan, private repair shops would be used to fix problems in the field. FCC spelled out the Commission's concept at a meeting in Tampa, saying "Since it is not feasible for the Commission to attempt to resolve these complaints" (most of which come from Citizens Band operation), "it is our policy not to investigate interference to home electronic equipment. Likewise, we do not offer any protection from interference." Over the past several years, the FCC has been unofficially out of the "retail" RFI business, and parties who contact the FCC about an interference problem are asked to work together toward a solution. Depending on what the local repair shop found, either the shop would fix the equipment or, in the case of a violation of FCC rules, the service shop would refer the case back to the FCC for possible FCC action. The question of who would pay was not addressed. See October QST page 80 for additional details.

The FCC Compliance and Information Bureau has just released a new 24 page color publication titled, "Interference to Home Electronic Entertainment Equipment Handbook." This document states, "cost-cutting manufacturing techniques, such as insufficient shielding or inadequate filtering, may also cause your equipment to react to a nearby radio transmitter. This is not the fault of the

transmitter and little can be done to the transmitter to correct the problem." The publication contains diagnostic checklists and suggested remedies in language targeted to consumers who experience various types of interference. It is also a good compilation of data for hams. The publication called Bulletin CIB-2, May 1995, apparently may be obtained directly from the FCC CIB Field offices, although reports of actual availability vary. One known source is the U.S. Government Printing Office, PO Box 371954, Pittsburgh, PA 15250, phone (202) 512-1800. The price is \$2.50 postpaid. See October QST page 15 for additional details.

Spectrum Protection Battles Continue

Just as we are coming out of the 13 cm band battle, the 5.6 to 5.9 GHz band is now threatened by a petition from Apple Computer Corp. Basically, Apple asks to share 150 MHz of our already shared 275 MHz wide band to develop an "National Information Infrastructure" band. One characterization of the NII band might be a "wireless internet available to all persons without license." One key request in the petition is that "Part 16" standing for the NII band be granted, which translated means that no interference can be caused to the unlicensed service by other services. Although "Part 16" does not now exist, it apparently is a proposed upgrading of Part 15 unlicensed service which does exist. Although denied in the Comments on the Petition by Apple, one impact of this proposal might be the elimination of the operation of a San Francisco Bay Area group which has been active in this band for some 20 years. The petition also asks for 150 MHz just above 5.1 GHz, outside our band. The petition provides very little technical information on such items as why 300 MHz is needed, how the sharing technically will be done, the power and antenna aspects, and many other issues. The Apple request appears to be to have the FCC authorize this conceptual idea and then to work out the details in a Notice of Proposed Rule Making. See Sept. QST pages 61-62.

After a extremely rapid but effective effort, the ARRL filed Comments and Reply Comments on time opposing the petition. Several individuals and groups in the Pacific Division also worked extremely rapidly to file Comments and Reply Comments opposing the petition.

See page 50 in Sept. QST for details of another attack on these frequencies in the U.S. Senate in S. 652. The Washington and the Pacific Division teams are working tirelessly to defend this spectrum.

Congratulations

Dewayne Hendricks, WA8DZP, from Fremont CA, with a team of 3 others, has just been awarded a \$400,000 National Science Foundation grant to study the use of wireless communication in urban and rural schools in the state of Colorado. The study will seek to determine the usability limits imposed by issues of allowable range and radiated power, urban and rural electromagnetic,

geographical, and building environments (interference, scatter, line loss), availability of field power sources (where retransmission is required), data types, and interoperability of wireless with wired networks using the ubiquitous general network protocols such as TCP/IP, local LAN, serial, and ethernet connectivity. The data collected over the one year period of the project will be analyzed and placed in a publicly accessible network as rapidly as significant findings are reached.

The significance of this research project is that the it will produce widely needed objective analysis of wireless as a general connectivity solution for public education beyond highly controlled, costly, commercial-service or limited environments. There currently is no such collected data.

The accessible reports issuing from this project will serve the needs of those considering wireless--educators, public spectrum policy makers, developers, designers, researchers, and scientists.

Dewayne is a member of the Future Systems Committee of the ARRL. One of the other members of the team is Bob Buass, K6KGS, from Southern California, the holder of the U.S. national Amateur Radio Spread Spectrum STA from the FCC. Good luck, Dewayne!
