
Enough for now - I will disclose more of my ideas next month.

FCC Enacts Internet Code Requirement

The FCC, under pressure to clean up the Internet, especially after the Communications Decency Act provisions regarding Internet content regulation were stricken as violating the U.S. Constitution, has decided instead to create a Morse code requirement for Internet users. Citing the success of the Amateur Radio Service and the general belief that it's requirement for operators to pass a Morse code proficiency exam and other technical requirements, has kept the A.R.S. "clean," the FCC will enact a 5 word-per-minute requirement for all Internet users. They are leaving open the issue of whether there should be a "codeless" class of Internet user and are soliciting comments on the proposal. Presumably, a "codeless" user would be restricted to web pages published by household magazines and kitchen equipment suppliers.

Persons wishing to develop web sites that have actual content, as compared to just links to other web sites, must pass a 20 word-per-minute Morse proficiency in HTML and the Java programming language, and show that they have mastery of at least one human language such as English or Esperanto.

The FCC, which lacks budgetary authority to implement the testing program, has stated that it intends to create Volunteer Examiner programs for internet applicants. FCC proposes changes in spread spectrum regs

Responding to a petition for rulemaking from the ARRL, the FCC has proposed in WT Docket 97-12 to adopt changes in its Amateur Service rules governing spread spectrum. In spread spectrum the energy of the transmitted signal is distributed among several synchronized frequencies within a band and reassembled at the receiving end. This reduces power density and duration of a transmission on a particular frequency and lets spread spectrum almost invisibly share the same spectrum with users of other, narrow band modes. Spread spectrum also provides for improved communication under poor signal-to-noise conditions and in selective fading and multipath environments, and the ability to accommodate more communication channels operating simultaneously in the same spectrum.

The League's December 1995 petition asked the FCC to relax its rules to give Amateur Radio more opportunities to contribute to the development of spread spectrum techniques. Specifically, the League sought to have the FCC relax restrictions on spreading sequences and asked for greater flexibility in spreading modulation. In response, the FCC now has proposed to drop rules restricting amateur stations to transmitting only frequency-hopping and direct-sequencing spreading techniques. As requested by the League, the FCC also has proposed to require automatic power control for spread spectrum transmitters, to ensure use of the minimum power level needed to carry out communication.

The FCC also went along with the League's request to

permit brief test transmissions using spread spectrum and to allow international spread spectrum communications between amateurs in the US and those in countries that allow hams to use spread spectrum. The current rules allow only domestic communication.

The use of spread spectrum techniques was first approved for Amateur Radio in 1985 for bands above 225 MHz and at power levels up to 100 watts, and there has been some experimental amateur operation since then. The FCC also has authorized Special Temporary Authority (STA) in some instances to allow broader SS experimentation. Since spread spectrum was introduced in the Amateur Radio service, commercial spread spectrum applications have been developed, including personal communication services, remote meter reading, and position locating. But, the League had argued that rules limitations held back further spread spectrum experimentation. No changes are proposed in the frequency bands where spread spectrum is permitted.

The FCC said the rule amendments would "increase spectrum efficiency and allow amateur operators to contribute to technological advances." Comments on the NPRM in WT Docket 97-12 are due May 5, with reply comments due June 5.

New HAM Volunteer Services Bill

During the week of March 9, Rep. Anna Eshoo (CA, 14th Dist.), along with 21 cosponsors, introduced the Amateur Radio Volunteer Services Act of 1997 (HR 1013) into Congress. This bill, if enacted, would place volunteers in the Volunteer Examination Program and the Amateur Auxiliary under the protection of the Federal Tort Claims Act by affording them the same legal protection as employees of the Federal Government while they're carrying out such volunteer duties. Rep Eshoo, in her comments, stated that amateurs save the government time and money, and that it was unfair for the volunteers not to be provided with some element of legal protection while performing their volunteer services. FCC Issues Spread Spectrum NPRM

On March 9, 1997, the FCC issued a Notice of Proposed Rule Making (NPRM), WT Docket 97-12, proposing to make significant changes in the regulations governing Amateur Radio use of spread spectrum (SS) technology. The changes are proposed in order to encourage greater use of this mode, a mode that is expanding very rapidly in commercial circles, but hardly at all within the Amateur Radio community. This NPRM was in response to an ARRL petition submitted on Dec. 12, 1995.

Further details will be made available on the Pacific Division web site and to the Pacific Division alert teams. For those wishing to comment on this Docket, comments are due no later than May 5 1997, while reply comments are due no later than June 5.

Committee Proposes New Licensing Plan

One of the charges given to the ARRL WRC-99 Planning Committee by the ARRL Board of Directors early last year was to study the US amateur licensing structure. A full discussion of the Committee's proposals related to the US licensing structure is given in March QST at page 55 Please read it and offer your comments to ARRL and to me.

My thanks to all of you who have written already. I have read each e-mail and hard copy letter and noted your thoughts. My goal is to respond to each of you in the Division who have written me directly.

Please remember that this is just a proposal and

there is no certainty that the ARRL Board will adopt this or any other proposal on this matter. Further, it is not clear that the FCC is even interested in revising the Amateur Radio licensing and testing structure.

In addition to the US license restructuring matters, the WRC-99 Planning Committee of the ARRL Board was charged with the task of developing recommendations to be passed on to the US Government delegation to WRC-99, dealing with potential changes in the International Telecommunications Union Rules governing the Amateur Service. This activity resulted in the survey published in QST last August, as well as an additional mail survey subjected to careful statistical controls. The results of this survey were published in QST for Jan., 1997.

Avalanche of New Antenna Ordinances

There is a huge new wave of antenna ordinances being proposed by cities and counties. These ordinances are being driven by the spectrum purchases and by new and expanding Cellular and Personal Communications Services licenses.

All of us need to be aware of this trend. When you first sense any of this action in your community, contact your Section Manager, the ARRL Regulatory Information Branch, and me immediately so that we can get help to you and the rest of the hams in your community. The key to a successful defense is to separate the commercial interests from Amateur Radio in the minds of the city officials. It's vitally important that your city or county officials understand Amateur Radio involvement with emergency communications - this story must be told repeatedly, especially before the antenna ordinance crisis develops!

Latest Band Threat News

2m/1.25m/70cm Band Threats

At the Feb. 13 meeting of the IWG-2A, the Little LEO folks added a last minute request for the bands from 219-225 MHz. The Amateur Radio community responded with an avalanche of e-mail messages opposing the Little LEO flexible allocation plan. The IWG-2A committee offered its recommendations to the FCC's Industry Advisory Committee on March 5 - without the flexible allocation plan being in the main body of its report as a formal recommendation. This does not mean that we are out of the woods on this matter, for it's still being pushed by the Little LEO folks. However, the fact that the flexible allocation plan was not a part of the formal report from IWG-2A is gratifying just the same. Additional details can be found in the ARRL Letter for March 7, 1997.

Thanks to all who responded to the last minute plea. for comments on the flexible allocation plan. The period for public comment has ended, so no additional comments on the subject will help at this time.

2300-2310 MHz Band Threat

The FCC issued a Report and Order on Feb. 19, 1997, on this matter. The FCC created the Wireless Communications Service (WCS) and a new Part 27 to the FCC rules. They also changed Part 97. In summary, we retained the secondary allocation from 2300-2310 MHz. Instead of the Federal Government, the new primary allocation at 2305-2310 MHz is WCS - yet to be developed. There is no primary allocation in the US at 2300-2305 MHz.

Please also note that this Report and Order does NOT include any action on the ARRL petition submitted to elevate our status to primary in 2300-2305 MHz. That petition is still pending.

FCC Drops Date of Birth Information

On Feb. 21, 1997, as a result of a privacy review, FCC dropped Date of Birth information from licensing records. Unfortunately, this loss of information means that I will no longer be able to send my personal letters to the youngest and the most senior new licensees in the Division.

Awards and Scholarships
