

He made many strong points including ideas on how to keep courses interesting and how to keep students involved to enhance their experience and fortify their recollection of materials presented. Lectures with demonstrations were said to be the most effective method of presenting information to be retained. Rick's training program starts with "training the trainers" to use these techniques. The success rate of his classes has been very high which speaks to the effectiveness of this approach.

A motion was made and passed to accept the minutes of the September general meeting and board minutes.

Don, KO6HH announced that the Nomination Committee has found a full slate of candidates for officers in 1998. He also announced that he would not continue in the duty of nominations chair.

Lou, WA6QYS announced that SVECS received some help from SCCARA members at the October Foothill Flea Market. He noted that October 25th will be the quarterly SVECS breakfast.

These operators were from several local radio clubs. It is hoped that with earlier notification next year, more operators will participate and assist in this event.

Board meeting was called to order at 7:38 PM by President Jack Ruckman, AC6FU at Red Cross building in San Jose. Attending were: Jack, AC6FU; Clark, KE6KXO; Lou, WA6QYS; Lloyd, KD6FJI; Gary, WB6YRU; Barbara, KD6QEI; Wally, KA6YMD and Dan, WM6M. Member Kevin Gehrke, KF6MBG also attended.

Barbara reported an arrangement has been made with Hewlett-Packard regarding use of the Oak Room facility for future SCCARA general meetings. They have approved our use of the room beginning November, 1997 until further notice. The Oak Room is available to SCCARA for no cost. Barbara will notify Don, K6PBQ to contact the United Way to advise of our change of venue. We may possibly have to pay for November use due to our short notice of change.

The repeater Committee was represented by Wally, KA6YMD who reported an audio problem with the two-meter repeater. He will contact Trish, WA6UBE to determine a course of action to correct the problem. No information is known regarding the status of the possible move of the repeater from the present site to the San Jose City radio vault.

Barbara, KD6QEI reported that ARRL President Rod Stafford, KB6ZV, may attend our November general meeting. Several other possible speakers were mentioned as we have need for good programs for the 1998 club meetings.

Gary, WB6YRU brought up his memo to the board members which he distributed at the last general meeting which commented on his objection to actions taken by the board at the last board of directors meeting (Gary was not present) related to the repeater and general fund checking and savings accounts. It had been discussed and agreed that the club should change from having a separate checking and savings for the general fund and for the repeater fund to a more manageable single account. A motion was passed to merge two checking accounts into one and two savings accounts into one.

A lengthy discussion ensued as to whether this motion was the best and appropriate course of action. A motion was made to investigate the history of the repeater fund. We need to determine who are the signatures of record on the repeater accounts as Lloyd has no information on this. No accounts will be merged or any other further action taken in pursuit of the motion which was passed at the September board meeting which merged the general and repeater funds into one account. The motion includes putting all pursuant actions on hold until further information is available. Motion was passed.

Wally, KA6YMD made a motion to donate \$50.00 to the American Cancer Society in memory of SK Bob Keller, KB6OHO who recently passed away. Motion was passed.

Jack made a motion that SCCARA's secretary contact surviving spouses of SK members to determine which charity should be given a \$50.00 donation in memory of that deceased member. This will be done from this date forward as a matter of club policy. Motion passed.

Barbara, KD6QEI brought a motion to invite surviving spouses of members to our social events if they so desire. They will also be asked at least 3 months after the death of their spouse if they wish to continue to remain on the mailing list and to receive the club newsletter for another year. They will be invited as guests of SCCARA to our annual Christmas Dinner. Motion was passed.

Jack, AC6FU presented a copy of a letter he has written to the FCC declaring support for the ARRL petition relative to RM-9150.

Jack is seeking an activities chairman to establish and maintain an operating schedule for the club station. Kevin Gehrke, KF6MBG will be the 1998 club secretary and was attending this meeting. Kevin volunteered to serve as the Activities chairman to which Jack made a motion to approve Kevin in this new position. The motion also included an approved expenditure of not to exceed \$100.00 for the printing of new club QSL cards. Motion passed.

## From the ARRL

#### FCC announces electronic renewal form 900

The FCC's Wireless Telecommunications Bureau (WTB) has consolidated eight renewal forms into one form. Form 900, Application for Electronic Renewal of Wireless Radio Services Authorizations, is an interim measure to permit all WTB licensees, including hams, to renew their licenses electronically.

This form is only for renewals, not for license modifications. You can only enter changes (eg, name, address) using Form 900 as a part of the process of renewing your license. You can only use Form 900 if the expiration date on your license falls within the renewal window (within 120 days of expiration). You cannot use Form 900 to renew an expired license. Form 900 may only be submitted electronically. No Form 900 paper applications will be accepted. When filing Form 900, you will be required to enter a Social Security Number for a taxpayer ID number.

Access Form 900 on the WTB Electronic Commerce page, http://www.fcc.gov/wtb/electcom.html (click on Production Page for Electronic Commerce Applications to access the Form 900). Click on any item number for filing instructions. Once you have filed the form, clicking on Electronic Renewal Query lets you view or print the information submitted.

Once you have successfully submitted Form 900, it is important to click on the Continue button to obtain the fee information pertaining to your filing. The screen will prompt you with a Fee Remittance Advice, Form 159. The form will indicate that there is no charge to renew an Amateur Radio license (except for vanity call sign holders, who won't have to renew for several more years yet).

Form 900 updates will be batch processed at night. They are not instantaneous.

#### FCC issues new form 610, old versions obsolete

The FCC announced this week that as of January 1, 1998, Amateur Radio applicants may only submit FCC Forms 610, 610A and 610B that carry an edition date of September 1997. After the first of the new year, previous editions of Form 610 will not be accepted for filing by the FCC or by Volunteer Examiner Coordinators (VECs). Amateurs may begin using the new Form 610s now.

The major change on the new form is a certification that says the applicant has "read and will comply with Section 97.13(c) of the Commission's Rules" regarding RF radiation safety and the amateur service section of OST/OET Bulletin No 65, Evaluating Compliance with FCC-Specified Guidelines for Human Exposure to Radio Frequency Electromagnetic Fields. But, Amateur Radio Supplement B of Bulletin 65, which has additional information on how to conduct a routine RF safety evaluation and explains other aspects of RF safety, is still in the draft stages and not yet available to the ham radio community.

ARRL Executive Vice President David Sumner, K1ZZ, says the League is concerned that the new Form 610 could be in the hands of hams before Amateur Radio Supplement B is complete. Sumner says it's essential that the FCC make Supplement B available in time for hams to complete their evaluations to meet the deadlines in the rules.

ARRL Lab Supervisor Ed Hare, W1RFI, who's been involved in reviewing the draft supplement, said he expects the FCC to release it sometime in November. The ARRL will release a book on the new RF safety regulations near the end of the year. "Above all, it is important that the required station evaluation be as easy as possible for hams," Hare said. "The FCC has pretty much met that goal. Additionally, most hams, by virtue of their power levels, will not need to do an evaluation at all."

Section 97.13(c) reads: Before causing or allowing an amateur station to transmit from any place where the operation of the station could cause human exposure to RF electromagnetic field levels in excess of those allowed under 1.1310 of this chapter, the licensee is required to take certain actions.

1. The licensee must perform the routine RF environmental evaluation prescribed by 1.1307(b) of this chapter, if the transmitter PEP exceeds the following limits: 160-40 meters, 500 W; 30 meters, 425 W (legal limit is 200 W--Ed); 20 meters, 225 W; 17 meters, 125 W; 15 meters, 100 W; 12 meters, 75 W; 10 meters, 50 W; VHF (all bands), 50 W; 70 cm, 70 W; 33 cm 150 W; 23 cm, 200 W, 13 cm 250 W, SHF/EHF (all bands) 250 W.

2. If the routine environmental evaluation indicates that the RF electromagnetic fields could exceed the limits contained in 1.1310 of this chapter in accessible areas, the licensee must take action to prevent human exposure to such RF electromagnetic fields. Further information on evaluating compliance with these limits can be found in the FCC's OET Bulletin 65, Evaluating Compliance with FCC-Specified Guidelines for Human Exposure to Radio Frequency Electromagnetic Fields.

The new Forms 610 may be obtained from the FCC's Web site via the Internet at http://www.fcc.gov/formpage.html, at ftp://ftp.fcc.gov/pub/Forms/ or by fax at 202-418-0177 (request index, or for Form 610 use form code 000610, for Form 610A use form code 006101, for Form 610B use form code 006102). The FCC Forms Distribution Center will accept FCC forms orders by calling 800-418-3676.

ARRL VEs and VE teams will be able to obtain a supply of the new Forms 610 in mid to late November--once the ARRL/VEC has had time to obtain a supply of the new forms.

Individual amateurs may obtain a copy of the new Form 610 by sending a self-addressed, stamped envelope (SASE) to: ARRL/VEC, 225 Main St, Newington CT 06111. Include 32 cents postage for each Form 610 requested (this is a four page form).

#### ARRL continues to push for federal preemption

The ARRL Executive Committee has voted to have the League continue to urge adoption of the antenna regulatory preemption policies contained in its petition, RM-8763. The action came on a motion from ARRL Vice President Steve Mendelsohn, W2ML, as the Executive Committee met October 11 in Philadelphia.

The League's petition, filed in February 1996, seeks enhancement of the PRB-1 limited federal preemption of state and local regulation of Amateur Radio antennas. However, the FCC appears to have made no progress with regard to the petition, which asked the FCC to declare that localities must find the least restrictive means to deal with ham radio. Among other things, the petition called on the Commission to amend Section 97.15(e) of the rules to say that any state or local antenna restrictions limiting ham radio antennas to heights below 70 feet would be "presumed unreasonable," unless the state or local authority could show its restrictions were necessary for health, safety, or aesthetic reasons.

It was also announced at the Executive Committee meeting that the League will submit comments in Mass Media Bureau Docket 97-182 supporting a comprehensive antenna facilities sitting policy, including amateur antenna structures.

The ARRL also continues to pursue FCC preemption of local and state attempts to regulate in the area of RF radiation safety.

The Committee also was told that numerous comments, most of them supportive, were filed on the ARRL's petition (RM-9150) seeking to improve the FCC's handling of private-sector complaints of serious amateur rules violations. The League has filed reply comments in the matter.

#### AMSAT-NA & TAPR, possible APRS move

The Board agreed--in cooperation with Tucson Amateur Packet Radio (TAPR)--to help an ongoing effort to minimize the impact of moving current APRS users off 145.79 MHz. The Board agreed to donate up to \$500 to help defray needed expenses of various fixed-frequency APRS node operators to find new homes for their operations. If it proves acceptable to the APRS community, the frequency shift would contribute to an effort to clear 145.80 MHz for worldwide use by Mir, SAREX and the International Space Station.

## ARRL Pacific Division Update

### October 1997

### RF Exposure Rules Effective Jan. 1, 1998

The long-awaited FCC decision on RF Exposure rules for the amateur radio service were finally released in August. An excellent summary of the obligations the new rules places on individual hams is contained in October QST, pages 51 and 52. Two questions immediately will come to mind: when must individual hams be in compliance with the new regulations, and how must individual hams demonstrate such compliance. More details are provided in the QST article cited above, but in brief, here's the story.

When - The new regulations become effective Jan. 1, 1998; however, there will be a transition period for compliance by individuals, as follows:

1. New licensees after Jan. 1 1998 must be in compliance with the new regulations at the time for first licensing. The FCC is preparing a new version of Form 610, which will contain a statement to the effect that the new licensee understands and complies with the new regulations. That is, the applicant will certify compliance by the very act of signing off on the 610 application.

2. All those licensed prior to Jan. 1, 1998, will have to be in compliance with the new RF-Exposure regulations whenever a Form 610 is filed, such as for a license renewal, upgrade, or other modification. Because the same revised Form 610 as used by new license applications is used for such modifications, the act of signing off on the 610 will certify compliance.

3. All stations, new or old, must be in compliance with the new regulations no later than Sept. 1, 2000. This date must be met whether a Form 610 has been filed previously or not.

How - The full story of how each ham must determine compliance to the new regulations is too lengthy to present here; additional details may be found in the Oct. 1997 QST article. Briefly, each ham, with some exceptions, will need to perform a routine station evaluation to ensure that maximum permissible power levels, as described in the new FCC rules, are not exceeded. Those running at or below certain threshold power levels will be exempt from routine evaluations, although they will not be exempt from complying with the RF exposure levels prescribed by the regulations. The full list of the threshold power levels is given in the Table below. For example, from 160 through 40 meters routine evaluations need not be performed at output levels of 500 watts PEP or less, while at 2 meters the level that triggers an evaluation is 50 watts PEP.

Output PEP Thresholds for Routine Evaluation of

Amateur Radio Stations:

30 m	425
20 m	225
17 m	125

### **Protection for Volunteers Started**

"The Volunteer Protection Act of 1997," Public Law 105-19, should provide Federal protection from "frivolous, arbitrary, or capricious" lawsuits against our OO/AmAux and VE volunteers as well as other volunteers. The law became effective on Sept. 16, 1997. The text is available on the WWW at http://thomas.loc.gov/. The text should also be available from other sources.

PL 105-19 is much broader in scope than the Amateur Radio Volunteer Services Act of 1997 -- To quote PL 105-19, "The purpose of this Act is to promote the interests of social service program beneficiaries and taxpayers and to sustain the availability of programs, nonprofit organizations, and governmental entities that depend on volunteer contributions by reforming the laws to provide certain protection from liability abuses related to volunteers serving nonprofit organizations and governmental agencies."

## Vanity Call Program

Gate 3 opened for Advanced Class licensees on Aug 6, 1997. Details on the Vanity Call program can be found on the ARRL WWW site at www.arrl.org or by calling the FCC National Call Center at 1-888-CALL-FCC. To file, use Form 610-V available via the FCC Internet Homepage at http://www.fcc.gov/wtb/amradsrv.html or from ARRL HQ. The fee became \$50 for a 10 year license starting Sept. 15, 1997.

On Wednesday, September 17, the FCC issued some 500 to 600 vanity call signs to those who had filed applications on August 6, the opening day. Applicants can check for new call signs at http://www.arrl.org/fcc/fccld.html or by using one of the other popular call sign databases.

The date for opening Gate 4 has not yet been announced.

### **Two Versions of Form 159 Confusing**

With no fanfare, in July the FCC issued a new Form 159, Remittance Advice, that's somewhat different from the earlier version of the form issued in February. As of September 15, 1997, the FCC requires vanity call sign applicants to file a Form 159 with their applications no matter the method of payment. The FCC still was shipping the old Form 159 as of mid-summer, despite the revision.

While the two forms require essentially the same information, some item numbers on the new form--available via the FCC Web formpage site--are different from those reported in last week's ARRL Letter, Vol. 16, No 36. For example, applicants enter the Payment Type Code (which is "WAVR") in Item 20A on the new version and Items 14A and 14B on the old version of Form 159. Under Item 21A on the new form, applicants filing only one application may write "1" or simply ignore the box.

The Fee Due, entered in Box 22A, rose to \$50 for the ten-year license term as of September 15, 1997. Hams can ignore Items 23A and 24A. Under Item 25, Payer TIN, and Item 26, Applicant TIN, applicants should supply the appropriate Social Security number(s). The new Form 159 contains a Section F for Credit Card Payment Information. Applicants must print their name and sign Form 159.

### **Amateur RF Exposure Rules**

The long-awaited FCC decision on RF exposure rules for the amateur radio service were finally released in August. An excellent summary of the obligations the new rules places on individual hams is contained in October QST, pages 51 and 52. Two questions immediately will come to mind: when must individual hams be in compliance with the new regulations, and how must individual hams demonstrate such compliance? More details are provided in the QST article cited above, but in brief, here's the story.

When - The new regulations become effective Jan. 1, 1998; however, there will be a transition period for compliance by individuals, as follows.

1. New licensees after Jan. 1 1998 must be in compliance with the new regulations at the time of first licensing. The FCC is preparing a new version of Form 610, which will contain a statement to the effect that the new licensee understands and complies with the new regulations. That is, the applicant will certify compliance by the very act of signing off on the 610 application.

2. All those licensed prior to Jan. 1, 1998, will have to be in compliance with the new RF exposure regulations whenever a Form 610 is filed, such as for a license renewal, upgrade, or other modification. Because the same revised Form 610 used by new license applications is used for such modifications, the act of signing off on the 610 will certify compliance.

3. All stations, new or old, must be in compliance with the new regulations no later than Sept. 1, 2000. This date must be met whether a Form 610 has been filed previously or not.

How - The full story of how each ham must determine compliance to the new regulations is too lengthy to present here; additional details may be found in the Oct. 1997 QST article. Briefly, each ham, with some exceptions, will need to perform a routine station evaluation to ensure that maximum permissible exposure levels, as described in the new FCC rules, are not exceeded. Those running at or below certain threshold power levels will be exempt from routine evaluations, although they will not be exempt from complying with the RF exposure levels prescribed by the regulations. The full list of the threshold power levels is given in the Table below. For example, from 160 through 40 meters routine evaluations need not be performed at output levels of 500 watts PEP or less, while at 2 meters the level that triggers an evaluation is 50 watts PEP.

## **Electronic Renewal Form 900**

The FCC's Wireless Telecommunications Bureau (WTB) has consolidated eight renewal forms into one form. Form 900, Application for Electronic Renewal of Wireless Radio Services Authorizations, is an interim measure to permit all WTB licensees, including hams, to renew their licenses electronically.

This form is only for renewals, not for license modifications. You can only enter changes (e.g., name, address) using Form 900 as a part of the process of renewing your license. You can only use Form 900 if the expiration date on your license falls within the renewal window (within 120 days of expiration). You cannot use Form 900 to renew an expired license. Form 900 may only be submitted electronically. No Form 900 paper applications will be accepted. When filing Form 900, you will be required to enter a Social Security Number for a taxpayer ID number.

Access Form 900 on the WTB Electronic Commerce page, http://www.fcc.gov/wtb/electcom.html. Select "Production Page for Electronic Commerce Applications" to access the Form 900. Click on any item number for filing instructions. Once you have filed the form, clicking on "Electronic Renewal Query" lets you view or print the information submitted.

Once you have successfully submitted Form 900, it is important to click on the "Continue" button to obtain fee information pertaining to your filing. The screen will prompt you with a Fee Remittance Advice, Form 159. The form will indicate that there is no charge to renew an Amateur Radio license, except for vanity call sign holders, who won't have to renew for several more years yet. (Thanks - FCC and ARRL Letter Oct. 3, 1997.)

## **Changes to Morse Code Waiver Rules**

The ARRL has asked the FCC to change the way Morse code exam exemptions for severely handicapped applicants are handled. The League wants to change the procedural requirements in Part 97 that must be met prior to granting examination credit.

Under the League's proposed changes, a candidate at least would have to attempt the CW test - with any and all permissible accommodations - before being granted an exam waiver based on a physician's certification. Also, Volunteer Examiner Coordinators (VECs) would be entitled to request medical information pertinent to an applicant's handicap from the certifying physician. VECs also would be required to have this information on file before the application is forwarded to the FCC for processing.

The League said it believes the procedural changes alone will help to deter those who might abuse the process while still allowing exemptions to deserving applicants.

## **US Applies for CEPT Participation**

The State Department has applied for US participation in the European Conference of Postal and Telecommunications Administrations (CEPT) Amateur Radio licensing system.
