AMATEUR RADIO INDUSTRY MULLS IDEAS TO BOOST HOBBY GROWTH

Meeting June 8 in conjunction with HAM-COM in Dallas, representatives of the Amateur Radio industry focused much of their discussions on ideas to attract younger licensees. Some of the conversation also centered on ways to boost the number of amateurs.

HAM-COM hosted the meeting and provided dinner. Moderating the session were Gordon West, WB6NOA, and Evelyn Garrison, WS7A.

Those on hand included contingents from the ARRL and from major Amateur Radio manufacturers, suppliers, other publishers and instructors. Representing the League were President Jim Haynie, W5JBP; Field and Educational Services Manager Rosalie White, K1STO; Media Relations Manager Jennifer Hagy, N1TDY; and Advertising Manager John Bee, N1GNV.

Bee, who also attended a similar industry gathering earlier this year in Wisconsin, said he thought the Dallas meeting was, in general, positive. "The industry recognizes that it needs to take an active approach and to undertake, or at least fund, new approaches to increase participation," he said.

During the session, President Haynie spoke on the need for an intensified youth-recruitment campaign--now dubbed "The Big Project." He reiterated his intentions to raise \$1 million in corporate and foundation donations for the project this year.

White reviewed recent Amateur Radio upgrade statistics and discussed various efforts under way in her department that

SB-1714: Letters Needed!

You may know that SB-1714, which is our first step toward restraining local jurisdictions from regulating Amateur service antennas out of existence, passed the California Senate 39-0 on May 30. From there it has gone to the Assembly for consideration.

On June 6 SB-1714 was assigned to the Local Government Committee of the California Assembly. The members of the committee are Assembly members Longville (Chair), Pacheco (Vice-chair), Corbett, Kaloogian, Kuehl, Thompson, Torlakson and Wiggins. The present text of the bill may still be found at http://www.leginfo.ca.gov; click on "bills" and search on "1714" (no quotes). The text is also appended to this Update. It has been amended slightly since last month.

We have just been informed that the SB-1714 will be considered in the Local Government Committee on Wednesday, June 28. Preparations are in progress right now for a small group to appear before the Committee in support of the bill. The makeup of our group is in a state of flux at the moment, but current plans are for our group to be led by Vice Director Vallio, W6RGG, ably supported by Sacramento Valley Section Manager Jerry Boyd, K6BZ, and possibly Volunteer Counsel Coordinator Harry Styron, K6HS. I will be out of the country on that date, so will not be able to attend.

We do not have a sponsor in the Assembly, so we need to be more active in support than was necessary in the Senate, where we had the minority leader carrying the bill. We continue to face opposition to any meaningful bill from the California League of Cities and other lobbying organizations concerned with land use and real estate.

You should express your opinion (hopefully supportive) to your individual Assembly member and to the members of the Local Government Committee and/or to the committee staff. At this point please do not suggest changes to the bill, because any amendment in the Assembly would effectively kill it for this year. In its present form it doesn't hurt, and it will permit us to work with the Governor's Office of Planning and Research to get (hopefully) something next year that will really help.

The Local Government Committee is more primitive, for they have no email address. Their snail-mail address is 1020 "N" Street, Room 157, Sacramento, CA 95814. Their telephone number is 1-916-319-3958 and their fax number is 1-916-319-3959. You should send them a copy of every letter addressed to your Assembly member or to the Assembly members of the Local Government Committee. In the Senate we got a very misleading support count in the legislative analysts' comments, because few of our letters went to the committee staff. They said we only had six letters in support, which is only the count of letters that went to the staff itself - they apparently did not see the many letters addressed to individual Senators.

It is sufficient just to write or telephone to say "I am an Amateur Radio Service licensee and I support SB- 1714." Staff at each level simply keeps a count for and against for the member. The Assembly member generally will not see the individual letters, only the count.

Please at least tell me and our Pacific Division Volunteer Counsel Coordinator Harry Styron, K6HS, (hlstyron@wcrklaw.com) that you have written, to whom you have written, and if your letter was for or against the bill. This way we can keep a count for when we appear before the Committee.

WRC-2000 Recommends Agenda 2003

WRC-2000 concluded June 2 in Istanbul, Turkey. During the assembly the WRC-2000 Future Agendas Working Group agreed to recommendations for a number of World Radiocommunication Conference 2003 agenda items of importance to Amateur Radio. Among other things, the Little LEOs could be back at the trough at WRC-2003 seeking additional allocations. The ITU Council will make the final decision on the WRC-2003 agenda two years before the conference.

Amateur Radio-related topics likely to be on the table at WRC-2003 include a possible revision of Article S25 of the International Radio Regulations. Article S25 contains

the basic rules for the amateur and amateur satellite services and includes the requirement to demonstrate Morse code proficiency for access to amateur bands below 30 MHz. Observers report there was broad support and no opposition voiced to having Article \$25 on the WRC-2003 agenda. Provisions of Article S19 of the International Radio Regulations--concerning the formation of call signs in the amateur services in order to provide flexibility for administrations--also could come up at WRC-2003. So could a review of the terms and definitions of Article S1-as required as a consequence of changes made in Article \$25. Among other things, Article S1 contains the definition of the amateur and amateur-satellite services.

Also up for possible consideration is a so-called "harmonized" or worldwide 40-meter allocation--a longstanding problem identified at WARC-92.

Text of SB-1714 as Amended:


SECTION 1. Section 65850.3 is added to the Government Code, to read:

65850.3. Any ordinance adopted by the legislative body of a city or county that regulates amateur radio station antenna structures shall not preclude amateur radio service communications. Any ordinance that regulates amateur radio station antenna structures shall reasonably accommodate amateur radio service communications and shall constitute the minimum practicable regulation to accomplish the legitimate purpose of the city or county.

SEC. 2. On or before July 1, 2001, the Director of the Office of Planning and Research shall do all of the following:

- (a) Prepare and publish a technical assistance bulletin suitable for use by local officials and planners in the preparation and adoption of local ordinances that regulate the placement. screening, and height of amateur radio service antennas. In preparing this bulletin, the director shall consult with individuals and groups with experience in amateur radio service communications and land use regulation, including, but not limited to, the American Radio Relay League, the American Planning Association, the California Association of Realtors, the League of California Cities, the California State Association of Counties, and the Federal Communications Commission.
- (b) Prepare and publish a model ordinance suitable for adoption by the legislative bodies of cities and counties for the regulation of the placement, screening, and height of amateur radio service antennas.
- (c) Report to the Legislature and the Governor regarding any recommendations for changes to the state statutes regarding state or local regulation of amateur radio service antennas.
