8. The examination session will be conducted under the auspices of the ARRL VEC, IAW their processes and procedures.

ON EXAM DAY BRING THE FOLLOWING ITEMS:

- **1.** A legal photo ID (driver's license, passport).
- **2.** When no photo ID is available, two forms of identification must be presented:
 - **a.** non-photo ID/driver's license (some states still have them)
 - **b.** birth certificate (must have the appropriate seal)
 - c. social security card
 - d. library card
 - **e.** utility bill, bank statement or other business correspondence that specifically names the person; or a postmarked envelope addressed to the person at his or her current mailing address as it appears on the Form 605.
- **3.** Students may bring any of the above items and/or a school ID, minor's work permit, report card, or a legal guardian may present a photo ID.
- **4.** Bring your Social Security Number (SSN) or your FCC issued Federal Registration Number (FRN). VEC's are required by FCC to submit either your SSN or your FRN number with your license application form. If you prefer not to give your SSN, then you may use your FCC issued FRN, if you have one. The phones' calculator function may not be used.
