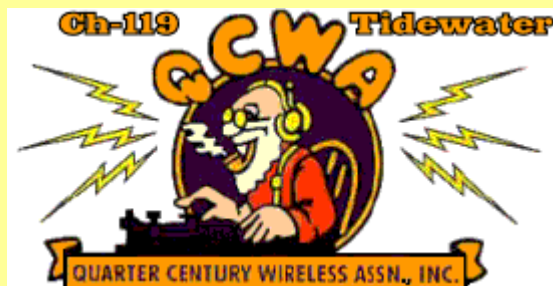

CHAPTER 119 ON THE GROUND

MEMBER NOTES. **W4XQ, Steve.** reports that the 2009 Strawberry Festival is now history. I suspect few know the extent to which this event is underwritten by Steve, W4XQ, who does prodigious work to insure the success of the event. Sponsored by the Virginia Beach ARC, Steve has been the motive force for this event since its inception. Characteristically, Steve is quick to appreciate the efforts of all who helped to bring this event to its successful conclusion this year. Steve contributes the following synopsis of the event.

“W4S, a Special Event station from the Pungo Strawberry Festival was again a success in its second year of operation Saturday and Sunday, May 23rd and 24th, 2009. This year we operated in style from the EmComm trailer provided by The Norfolk Area Baptist Association. You may have seen this fully-equipped beauty at Field Day last year. If not, be sure to check it out this year! Thanks to Chuck Moseley, NS4CM, Pastor of Oak Grove Baptist Church for making this happen.

W4S again ran a Yaesu FT-900 and a Buckmaster OCF (Off Center-Fed) dipole. The amp we used this year was a Yaesu FL-2100B, running a pair of 572b's. A new addition was the satellite station: A Kenwood TS-2000, KenPro Az/EI rotor and a Cushcraft AOP-1 antenna array. Don, KC4H, made a video of the station in operation and put it up on YouTube. View the video here <http://www.youtube.com/watch?v=JtaqosTfeH0> That's me (Steve, W4XQ) operating; Ed, KC4UFN logging; and Butch, KE4AZL and Joe, KI4RKB inspecting the coax patch panel outside the trailer.

W4S made over 450 contacts this year. Most were on 14.260 MHz. We ran for a brief time on Saturday morning on 7.260 MHz. but quickly abandoned that frequency to avoid QRM as various nets started popping up. HF contacts included 36 states and 29 countries. The satellite station actually only ran one satellite pass. That was late on Sunday as AO-51 was passing over. We made about ten contacts in that pass.

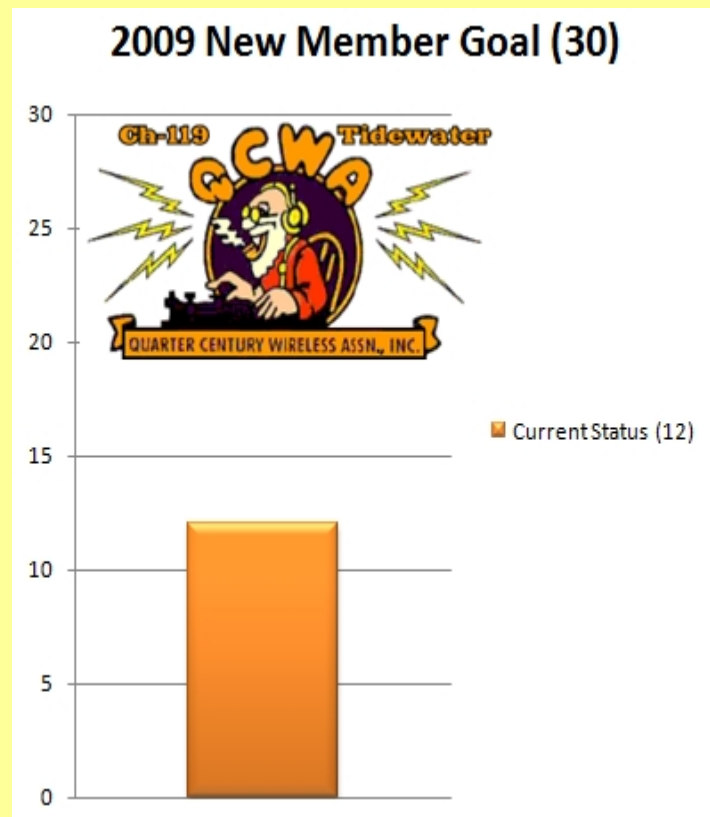

DXING. The coming weeks DX notes come to you courtesy of the ARRL DX News service. The content is edited for date appropriate listings.

ITU HQ, 4U1ITU. Hans, PB2T, Brennan, N4QX and others may be active as 4U1ITU until May 29. QSL direct.

CYPRUS, 5B. A group of operators will be QRV as C4SV from May 23 to 29. Activity will be on all HF bands using CW, SSB and RTTY. QSL via SV2DGH.

TOGO, 5V. Werner, DL9MBI is QRV as 5V7PM and has been active on 20 meters using RTTY after 1400z. QSL to home call.

MALDIVES, 8Q. IW3HVB will be QRV as 8Q7GP from the Bathala Island resort from May 27 to June 4. Activity is holiday style on the HF bands using SSB and PSK31. QSL to home call.

THE GAMBIA, C5. Andre, ON7YK is QRV as C56YK from Kotu East until June 7. Activity is on 6 meters using CW and SSB on 50110 kHz. QSL to home call.

NEW CALEDONIA, FK. Steve, 9M6DXX will be QRV as FK/G4JVG from May 22 to June 3. Activity will be on 40, 20, 17 and possibly 15 meters using SSB. QSL via M0URX.

ALAND ISLANDS, OH0. Uwe, DL6NDK, Iris, DL6LI and Ralf, DL9GTI will be QRV as OH0/home calls from May 23 to 29 while on holiday. Activity will be on 80 to 10 meters, including 6 and 2 meters, using mainly CW with some PSK31. QSL to home calls.

GREECE, SV. Laci, HA0HW will be QRV as J48HW and SV8/home call from Thassos Island, IOTA EU-174, from May 28 to June 6. Activity will be on 40, 30, 20, 17 and 6 meters using mainly CW, with some SSB, RTTY and PSK31. He will be active in the upcoming CQ WPX CW contest as J48HW. QSL to home call.

DODECANESE, SV5. Darren, G0TSM is QRV as SV5/home call from Kos, IOTA EU-001, until June 3 while on holiday. Activity is mainly on 12 and 6 meters using CW and SSB. QSL to home call.

TURKEY, TA. Karl, WA2KBZ is QRV as TA0/home call from Buyukada Island until June 17. Activity is on 40, 30, 20 and 17 meters using QRP CW only.

NIUE, ZK2. Chris, ZL1CT is QRV as ZK2V and is active on various HF bands using CW and SSB. He will also be an entry in the upcoming CQ WPX CW contest. QSL via N3SL. ---

N3UR reports that Chris, ZK2V, will be active from Niue for about 25 more days. Some RTTY activity is planned, as is a special operating permit on 60 Meters from 1100 UTC on June 1 2009 until 1100 UTC on June 8. Chris will transmit only on 5403.5 KHz (USB for USA, but CW for the rest of the world!) and he will listen on 5371.5 or on another channel, if necessary. Thanks Bernie. ---

QCWA Chapter 119 Members Finish Well In DX Marathon. Three QCWA Chapter 119 members finish high in the CQ Worldwide Marathon Contest for 2008. This year-long contest challenges the DX operator to work as many countries and zones as possible within the calendar year. In 2008 Chapter 119 had THREE finishers in this contest:

In the categories column, U stands for Unlimited Class, F stands for Formula Class. Formula class must declare at the beginning of the year a fixed set of parameters, either 1) QRP – 10 watts or less, or 2) 100 watts with simple antenna, e.g., vertical or dipole. These parameters may NOT change at any time during the contest year. Unlimited class runs any legal power to any legal antenna. No assistance is permitted in order to secure contacts but the use of DX Cluster spotting networks is permitted in both classes of operation.

This was a fine performance for Chapter 119. Congratulations to the World Ranked Participants. Can we do better in 2009? These guys are already ON IT! ---

Continue on Indian Creek Road (past Northwest River Park) until just past 2324 Indian Creek Road (about 5.5 miles), where you will turn left (at Virginia Beach City limit sign) and proceed to the long red bard with silver (aluminum) roof.
