### Minutes of the October 2004 AARA Board of Directors Meeting

Tuesday, October 19, 2004  
AARA Clubroom, Bldg 601 (PB7),  
601 Data Dr., Plano TX

#### OPENING AND ROLL CALL

President Frank Krizan, KR1ZAN, called the meeting to order at 5:30 pm. Club officers Executive Vice President Miguel Ylagan, KC5FEJ, Vice President of Operations Mark

Dempsey, N5MD, Treasurer Al Koch, KB5VSL and Secretary Clarence Sebesta, K5YO were present.

#### SECRETARY'S REPORT

The September board meeting was not held. The minutes for the August board meeting were distributed by email and published in the newsletter. There were no corrections. Al MOVED and Mark SECONDED. The minutes were then APPROVED.

#### TREASURER'S REPORT

Al submitted the transactions report that showed payment for liability and equipment insurance. He also submitted an updated budget vs. actual report. The treasurer's report was accepted for audit.

#### VP OPERATION'S REPORT

**Repeater:** The parts for the remote base are still needed to get the remote base working. John Schroeder is planning a work party in the near future.

**HF Station:** The cable for the Butternut Vertical is now in the clubroom by the HF station. Some receiver testing has been done with the antenna; however, no transmissions have been made with the antenna. Tests need to be done to make sure the antenna is properly tuned. Low power interference tests need to be done before high power is applied to the antenna. The cable does need to be shortened. The board discussed routing the cable to a central junction box or rack and use coax switch to route to different stations.

**VHF / UHF Station:** A plan for a satellite antenna system is being developed.

**Internet:** Miguel Ylagan is working to setup accounts on these computers so members can use them to access the Internet.

**Other:** The Morse code lab has been setup in the clubroom by Mark. (WOW!) The teacher station has been

setup in the office cubical. A student station was also setup in the office cubical and two student stations were setup in the UHF/VHF cubical. Addition student boxes were used as connectors to make cables long enough to connect the stations together. These boxes were not made into stations because there weren't enough headsets or keys. The teacher station has not been connected to a computer or tape player. More headsets are needed.

#### EXECUTIVE VP'S REPORT

**Programs:** The October Telecom Corridor meeting will be held on Monday, November 1<sup>st</sup>, due to room scheduling problems. The program will be "WinLink 2000" and will be presented by Jon Brown, WB5KSD.

The November GMM will be held on the 3<sup>rd</sup> Tuesday November 16<sup>th</sup> that includes the annual election of officers and a preliminary budget for next year. The program will either be a short program by Thorsten Prutz K5UTD on the HF Remote Base at UTD or a brief overview of the repeater by Frank Krizan.

Miguel showed a marketing brochure that could be used to promote the club.

Due to the company dropping the PB numbers from the buildings, the club needs to change the address where appropriate. Al is changing the insurance address and Clarence is checking on other areas. Mark to revise trustee address. The mailing address stays the same except PB7 can be omitted. The newsletter will present the changes. The old PB numbers will be shown in parenthesis to aid in the transition.

#### PRESIDENT'S REPORT

Frank said that the non-employee access should be available in a few days. In the beginning, Security will escort the non-employee to the clubroom. Those approved will be notified.

### OLD BUSINESS

Training: Frank suggested that the club order the ARRL technician training course DVD and additional manuals. He noted that the general and extra class training hasn't been effective in the past.

Frank asked Al and Clarence to find out about the IRS financial limits for a non-profit club to be tax exempt.

### NEW BUSINESS

**AARA Web Site:** Frank made a MOTION authorizing the web master to establish an Internet web site on behalf of the AARA at a cost not to exceed \$225 for a 2-year service contract including a 3-year domain registration. Mark MOVED and Al SECONDED. After a brief discussion, the MOTION passed. Frank will notify Eric Wolf KG4VPV to proceed.

**2004 Operating Budget:** Frank noted that the club needs to make purchases as shown in the membership approved operating budget before year-end to avoid a reconciliation of the operating budget payment from Alcatel. The list included: ARRL training materials (Frank), spectrum defense fund (Al), Xmas door prizes (Miguel), Skywarn Recognition QSL cards (Frank), web site and registration (Eric – paid by Al).

### ADJOURNMENT

There being no further business, Mark MOVED that the meeting be adjourned. Al SECONDED. The motion was APPROVED and the meeting was adjourned at 7:10 pm.

### OPENING AND ROLL CALL

Some receiver testing has been done with the antenna; however, no transmissions have been made with the antenna. Tests need to be done to make sure the antenna is properly tuned. Low power inference tests need to be done before high power is applied to the antenna. John Schroeder offered his MFJ analyzer for antenna testing since the club's analyzer is out on loan.

**VHF / UHF Station:** A plan for a satellite antenna system is being developed. Mark presented a preliminary list of items needed.

**Internet:** Miguel Ylagan is working to setup accounts on these computers so our members can use them to access the Internet. He moved to contents from the old computer to the new ones. Suggested names for the computers are "W5VV" and "AARA".

### EXECUTIVE VP'S REPORT

Miguel Ylagan regretted the cancellation of the evening's speaker, Thorsten Prutz, but expects him to give the program at a later date. Future programs may include the North Texas Balloon Project. The October Telecom Corridor meeting will have a program on WinLink 2000. The November meeting will have election of officers and a program about the new repeater. The Telecom Corridor may have an Xmas dinner in December.

**PRESIDENT'S REPORT:** Frank noted the change in tonight's program and told briefly of his use of APRS while traveling. He thanked all for continuing the clubroom progress and repeater work and hoped to have a work party finish up the work.
