Membership Information

1. Dues are based on a "household" rather than individual members. A "household" shall include all persons living therein without regard to age. Full-time students, temporarily away from home shall be considered to be within the household.
2. Basic annual dues providing membership in the *Dial Radio Club* shall be \$ 12. Repeater privileges are not conferred at this level of membership.
3. Annual dues, combining membership and full repeater privileges shall be \$ 26. A special, new member dues of \$ 13 will apply to applications received after July 1 of the current year. For the purpose of this section, ***prior members whose membership may have lapsed two, or more, year(s) are considered new members.*** Repeater access codes will be forwarded upon acceptance of this application.
4. One autodial slot will be assigned to each household on a "first come first served" basis for no additional charge. Households may request additional slots, subject to availability, after all initial assignments have been made. Additional slots are subject to recall should they be needed to serve new members. Assignments will be limited to local, non-toll, telephone numbers only.
5. Persons pursuing a **new membership** in the *DIAL Radio Club* must be sponsored by a member in good standing. This application must then be submitted to the membership for a majority affirmative vote prior to acceptance into the Club. Sponsorship ***is not*** required for annual renewal. For the purpose of this section, ***prior members whose membership may have lapsed one, or more, year(s) are considered new applicants.***
6. A special fund exists to upgrade the Club's repeater systems. The monies donated are used, exclusively, for repeater system enhancement and maintenance. Our needs are ongoing; your new (and continuing) donations are essential to enable us to maintain our state-of-the-art facilities while developing new and exciting technologies.

Persons who may not care to become active members of the *DIAL Radio Club*, may demonstrate their support for the Club's repeater facilities by making a donation toward the improvement and maintenance of our repeater facilities.
