September 5, 2015 Siren Test

Last Sunday (August 23) we had an occasion for the sirens to go off in our area. It would be nice to know how many of you were outside and heard the siren in your area. I know I opened the door at my Granddaughter's and I could just hear the siren very faint. It is for this reason that I will be going out and checking the siren near her house on September 5 to make sure it is working. Luck was with us and nothing bad developed in Oakland County.

Thanks to a lot of you, all the sirens in the North West Section of Oakland County have been checked already this year. There are 3 months left for checking sirens this year and this would be a good time to go out and check the siren that is near your house or where you work. It is said that the radio and TV will let us know if a storm is coming. This doesn't always happen with cable TV and if there is a lot of noise you might not hear a warning or see a warning. If the weather looks bad, you can always check outside to hear if there is a warning from the sirens. I received the notice on my cell phone after the alert was over and the warning by email only works if you are checking your email at the right time.

The saying goes "When all else fails Amateur Radio still works". We have to be our own first line of protection and we do this by checking sirens and checking into the local Skywarn nets.

There will be a test of the sirens on September 5 at 1:00 p.m. I will be taking check ins, starting at 12:45 p.m. You are asked to sign up for a siren by emailing me at kb8pod@arrl.net or you can call me at (248) 421-2617.

My experiences with ham radio software and Windows 10 Joe Miller, KJ8O

After nearly a year of beta testing, Windows 10 was officially released to consumers on July 29, 2015. Being a part of the Michigan Section HF Digital Sound Card Team, I have this concern that one of us will be asked "does DM780 or FLDigi work with Windows 10?". I had to wait about a week and half before I received my notice from Microsoft that I could go ahead with the download and installation. Starting with my notebook computer, I began the download at about 12:30 pm, and had two time-outs resulting in restarts. I think it was about 10:00 pm before the actual installation began, and after going through three reboots, the process finally was complete at about 12:30 am. I should note that while waiting for the downloads, my wife and did some errands in between, so I have no idea of how much idle time was included in the twelve hours.

Then on Monday night, I see the "installation" icon on my desktop PC, (this is the one that I use for operating with digital mode), and at about 7:30 pm, I start the installation process. I should also note that this computer is left on nearly all the time, so the download part of the process was already complete. On this PC, the installation took just over an hour, and for the most part, went smoothly. Then getting DM780 and Ham Radio Deluxe to work was another story, since all the saved settings in the software were erased during the upgrade. Fortunately, I am well aware of the shortcoming in my computer that erases sound card settings the minute the computer is unplugged (as opposed to being turned off, as I suspect there is a trace amount of current active once turned off), and I quickly went to correct this first. Then when transmitting, I still had a high amount of ALC (it should be zero for digital modes), and with some more tweaking with exiting and restarting the program before I could adjust my output levels.

I am now happy to report that everything is working well with each other, and I have made a number of digital contacts since the operating system upgrade. So now when asked the dreaded question, my answer will be "yes, but". Outside of ham radio, I have found that using Microsoft Money (Sunset Version available to paid users of earlier versions on Money) will no longer work under Win 10 as many of Money's components were integrated with Internet Explorer 6, and is incompatible with Edge. Although, this was my only experience with this issue, I am sure there is other software that is incompatible also. Some other criticisms of Win 10 is that updates are forced and automatic, although it was recently reported in the ARRL Contest Update that there is a way allow the user to choose the time for their updates. I don't think I have to mention the importance of this function to contesters. Another criticism is the level of data collection taking place, and I do know that some of this occurs to feed information to Cortana, a software app initially developed for Windows Phone 8.1 and is now part of Win 10. Also, Microsoft has stated that this software would be made available to licensed users of Win 7 and Win 8.1 for a year, but I have not heard how much the subscription fees will be after that. And lastly, from those who have not had their upgrade go so smoothly, Microsoft does not offer any assistance other than to take your computer to a shop.

If you have not yet made the decision to upgrade, I hope you will find my report to be useful. In the case of my checkbook, I have an XP on hand and was able to export my data file to this older computer, and all is working well. In conclusion, it can be done, but a little planning may go along way.

It's all about emergency communications...

Summary: one amateur radio operator in participation, and several were on standby. The originally planned Field Day operation to be held at Springfield Oaks County Park in Davisburg Michigan was cancelled at 9:30 pm on Friday, June 26 as the weather prediction for Saturday included rain all day and wind gusts up to 35 miles per hour. Inasmuch as one of the portable towers used every year weighs approximately 500 pounds when assembled, we did not want to take any chances of injuring any of our members.

This year has been particularly demanding between the cold temperatures and snow fall during the winter, and the much higher than normal rainfall for the month of June.'

Although 285 contacts were made during Field Day, 21 contacts made with other "D" commercially powered stations were removed from the total contacts, and the net of 264 contacts were used for scoring purposes. The Dupe Sheet is attached as a separate document.

100% Emergency Power: commercial mains power used for all contacts made

Media Publicity: on Friday morning at about 8:20 am, David Wagner, DMA (KB8SUL) who is the morning host on WRCJ-FM in Detroit Michigan spent several minutes talking up Field Day, first mentioning the South Lyon Amateur Radio Club will be holding their Field Day exercise near I-96 in Milford, and that one of the staff at WRCJ would be participating with Field Day with the Arrow Communications Association in Ann Arbor, and then he mentioned a message received from Joe Miller who is the President of the Oakland County Amateur Radio and that they would be holding their Field Day exercise at the Springfield Oaks County Park in Davisburg. He then went on to say the Field Day exercises occur annually since 1933 and it used when conventional forms of communication is not available. Today, there are approximately 725,000 ham radio operators within the United States, and Field Day remains one of the most popular amateur radio events.

Comment: Afterwards, I had received several comments from both hams and non-hams saying that they had heard the announcement. WRCJ is a publicly owned radio station affiliated with Detroit Public Television and they play classical music 14 hours a day, and jazz for 10 hours each night.
