# **CIRC July Meeting Minutes**

July 24, 2013

President Gary Dearth (KD9F) opened the meeting at 7:00 pm. Gary D said the minutes had not been published yet, so he deferred review and approval to the August meeting. Norm (N9ZKS) was not present to give the Treasurers Report. Approval was deferred to the August meeting.

Old Business: Tom Planer (KJ9P) gave a report on the ARES/SKYWARN group. It was fired from the McLean County EMA because the communications between the two groups was lacking. The EMA was not able to define what tasks they wanted us to do and how we would do them. We will continue to work with SKYWARN and assist the National Weather Service via the Lincoln, IL office. We need more trained people, so please contact Tom to find out what you need to do to join the group.

Josh Golladay ( KC9UJS) found a contact with the Fire Department so we can operate at the McLean County Fair. We will use the special event call sign K9T. We can operate on multiple bands and those wishing to operate from the Fair should contact Josh. Chuck Henderson (WB9UUS) reported that to get **ECHO** Link/AllStar working we need an RTMC module for about \$275. We should also get a 5.6 gigabyte link. We can have two sites devoted to receiving. Gary D asked if this would be enough money to cover all the expenses. Benjamin (KC9PIM) said it would cost \$2.61 to insure the equipment, with at \$50 deductable. So we would need about \$542 to cover all the expenses. Tom made a motion that we approve \$600. After a second by Gary Huber (AB9M) the motion was approved.

New Business: The Nominating Committee reported that one person is thinking about running. The slate proposed is Grant Zehr (AA9LC) President, Duane Benjamin (KC9PIM) Secretary, and Earl Shaffer (WB9UWA) Vice President. Gary H moved to close the nominations. He also nominated Norm Huber (N9ZKS) to remain as Treasurer. Josh seconded the motion and it was approved. Tom moved that we accepted the slate of officers and elect them. After a second by Keith Hanson (AC9S) the motion was approved. Keith suggested we amend the constitution so that we have term limits on the officers.

Gary H discussed the proposed contract between the N1SF club at State Farm and CIRC. The contract is to allow CIRC to purchase some of the equipment of N1SF so that we can use it and insure it. N1SF plans to amend its constitution to rename the club and continue to provide services like APRS to the community. Gary is completing another draft of the contract so it meets some of the concerns of members of N1SF.

Gary H made a motion to add N9PE-2 to the site listing in the newsletter. After a second by Tom the motion was approved. Rick Kempf (WD9HRU) asked who was handling the QSL cards from Field Day. Tom said he would make them. Tom and Gary D talked about the equipment owned by CIRC. Duane asked for a list so that he can get it insured. Keith suggested that we feature the Ham Shacks of our members on our website.

Gary D reminded the members that we have our Coffee Klatch at 9:00 am, Monday to Friday, at the Dairy Queen on Veteran's Parkway. All are welcomed to attend. Bring a friend. And don't forget to check in on Tuesday's to the ARES Net at 8:00 pm, the 10 meter Net at 8:30 pm and the 2 Meter Net at 9 pm. Anyone with an item for the Newsletter should send it to Norm or Ed.

Dennis Mills (KE9UA) made a motion that we adjourn. After a second by Dave Roberts (KE9BA) the motion passed.

CIRC Special Meeting Wednesday August 7, 2013

Member Tom Planer (KJ9P) opened the meeting at 7:00 pm with 19 members present. The meeting was called to discuss the possible loss of the Corn Belt Energy tower that we use for the W9AML repeater.

Tom, in summary, said that Corn Belt had hired a tower crew to evaluate the structure and remove unused antennas. They mistakenly started to remove our antenna for the W9AML repeater. They cut out about 75 feet of hardline that was connecting the antenna to the repeater before we were able to stop them. They replaced the damaged feedline with some regular cable. If their evaluation indicates the tower is usable and safe, Corn Belt might decide to rent space on it for antennas from various businesses, organizations, and individuals. If it is not safe, they plan to have it torn down.

If we are able to continue to use the tower, we would need to pay for things like the electricity to run the FAA lights, electricity to run the repeater, and so forth. It was estimated to replace the hardline and connectors would cost about \$5,000.

Gary Huber (AB9M) asked if we could salvage the 75 feet of hardline and with some connectors use it with the remaining hardline on the tower. Duane Benjamin (KC9PIM) suggested we bill the tower crew for the damaged hardline. We would like to have the hardline on the Corn Belt tower but not the antenna. It was damaged by lightning and the tower crew would charge us \$200 to remove it.

Rick Suhadolc (N9CKL) said he would see if we could get space on the city water tower near State Farm South.

We might be able to use the tower that Rick Kempf (WD9HRU) uses.

Keith Hanson (AC9S) noted that we use the repeater a lot and we really should find a way to keep it.

We also talked about using Watterson Tower, the EMA tower, and the tower at the Law and Justice Center. Tom reported that ISU is actively removing antennas from Watterson Tower and they did not want any on it. We are not in the good graces of EMA, so it is very unlikely that we could use either the EMA tower or the Law and Justice tower.

We also talked about using the tower at the Red Cross, but some questioned if it was tall enough to be effective all over the county.

Keith Hanson said we could check with STL, who has a tower at their office on Towanda Barnes road.

Gary Dearth (KD9F) said we have approval from the Red Cross to add a second tower, so maybe we could use it. We would have to coordinate the new repeater location.

Rick N9CKL, will check on placing an antenna on a city water tower.

Keith AC9S, will check with STL.

Gary KD9F, will review the FAA paperwork to see about using the new tower at the Red Cross.

CQ CQ looking for any vertical 10 meter stations. We have been meeting every Thursday night at 8PM on 28.450 Mhz using vertical polarization. Please join us. We encourage you to try vertical, but if you are horizontally polarized, you are welcome too, but signals may be difficult. Several of us regularly use vertical and we are finding that with simple verticals mounted only 20 feet off the ground our signals are over S9 to each other and often well over S9. This is a vast improvement compared to using horizontal yagis that are often pointed the wrong direction resulting in weak signals. We welcome you to experiment here on this net and as with the other, it is totally casual. To set the net apart from the other 10 meter net, we are calling it Vertical Thursday. Please join the fun.
