CIRC Aug Meeting Minutes

August 28, 2013

Vice President Ed Deutsch (KC9GF) opened the meeting at 7:00 pm. Ed said the minutes from the June and July meetings had been published in the Newsletter. There were no questions or corrections. Tom Planer (KJ9P) made a motion that the minutes be approved. After a second by Gary Huber (AB9M) the motion passed. Norm (N9ZKS) give the Treasurers Report. We have \$1,317.71 and a few outstanding bills. Mike Sallee (KC9FWL) moved that we approve the report. After a second by Dennis Mills (KE9UA) the motion was approved.

Old Business: Tom Planer (KJ9P) gave a report on the ARES/SKYWARN group. He sent out three reports to assist people in being the Net Control operator for the ARES Net. He is the McLean County Emergency Coordinator. He provided a CD to anyone interested in

learning more about being involved in SKYWARN. He also mentioned a couple of online classes for a refresher on weather spotting. He said he sent out QSL cards from Field Day and provided QSL cards for Josh Golladay (KC9UJS) to send for the special call sign while operating at the McLean County Fair.

Gary Huber (AB9M) discussed the N1SF club at State Farm. The club has been reformed with a new name. They are working on how they want to provide the equipment to the CIRC that they are not using. Gary will keep us informed as things are decided. Duane Benjamin (KC9PIM) said we can make a contract that shows the equipment we have from them is under our control and thus we can get it insured with the other club equipment. Tom, Gary H, and Jeff Lovell (KC9QQM) will complete an inventory of club and N1SF loaned equipment that we have.

We have equipment at Norm and Duane's homes and also at the Red Cross station. Tom will work with them to get a final list of all of our equipment. We can then discuss what to do with the equipment we do not need or want.

New Business: Ed said he liked the idea of having pictures and an article about member's ham shacks. We can place them in the newsletter (send to Norm) and on the website (send to Jeff). Just do your own write-up and pictures and send them along. He also said it would be a good idea to have the members take turns being Net Control for the Tuesday 9 pm W9AML net. Ed will send out the preamble that is used. We can add it to the website. Jeff said he could setup a calendar on the website and members could sign up to be the Net Control operator for the dates they want.

Dennis talked about the problems he is having with his neighbors and the Town of Normal over the antenna and tower he got a permit to install. Others commented on what rights we have as ham operators to add a tower and antenna on our property. He was given some suggestions to help with the legal issues, including contacting the special lawyer at the ARRL that handles such issues. Dennis will keep us informed of what happens.

Josh asked if the club is will to assist with the We Care Twin City Half Marathon on September 28th. We did this last year. A number of members volunteered to help. Josh will follow-up for us.

We had a good discussion about the Corn Belt Tower and the water tower on Hamilton Road. We discussed various issues, advantages, and costs. Other options like Watterson Towers are not available. We agreed that a number of items needed to be addressed and a committee was formed to define what needs to be done and the cost. Tom will lead the committee and it will include Chuck Kostelc (N9RZV), Jim Shaffer (WB9UWA), Rick Kempf (WD9HRU), Chuck Henderson (WB9UUS), and Rick Suhadolc (N9CKL). Rick will contact the IRA to discuss various issues.

Keith mentioned that the next Social Dinner will be Thursday, September 19 at Beningos Italian Restaurant (610 W Chestnut St, Bloomington). We will meet at 6 pm. Duane offered a wiener roast at his farm on Saturday October 19 at 6 pm for another Social Dinner.

Vertical Thursday

CQ CQ looking for any vertical 10 meter stations. We have been meeting every Thursday night at 8PM on 28.450 Mhz using vertical polarization. Please join us. We encourage you to try vertical, but if you are horizontally polarized, you are welcome too, but signals may be difficult. Several of us regularly use vertical

and we are finding that with simple verticals mounted only 20 feet off the ground our signals are over S9 to each other and often well over S9. This is a vast improvement compared to using horizontal yagis that are often pointed the wrong direction resulting in weak signals. We welcome you to experiment here on this net and as with the other, it is totally casual. To set the net apart from the other 10 meter net, we are calling it Vertical Thursday. Please join the fun.

Ham Radio Publications Pioneer, Visionary, Iconoclast Wayne Green, W2NSD, SK

Wayne S. Green II, W2NSD ("Never Say Die"), of Hancock, New Hampshire, died September 13. He was 91. A well-known and often outspoken figure during what some consider Amateur Radio's golden years in the 1950s and 1960s, Green helmed *CQ Magazine* for 5 years before becoming the self-proclaimed "El Supremo and Founder" in 1960 of 73 magazine, which he published until 2003.

"The purpose of [73] at that time was to get building equipment," more hams Green recounted in a radio interview several years ago. A hallmark of 73 was Green's iconic, rambling, and wide-ranging "Never Say Die" editorials, in which he rarely missed opportunity to tweak the ARRL and his magazine competitors for their perceived shortcomings. In 2012 Green contributed back issues of 73 to Internet Archive.

"Wayne will be remembered in many different ways by many different people, but he will be long remembered," said ARRL CEO David Sumner, K1ZZ. "He maintained his membership in the ARRL despite being a persistent critic. In the early days of packet radio he gave me some good advice as to how the ARRL should promote the new technology: 'Talk about it as if everybody's doing it, and eventually they will be."

Indeed, Green often was ahead of the curve in promoting such technologies as single-sideband phone, solid-state, FM, and the marriage of computers and ham radio, and he went on to found and publish *Byte* and other computer-oriented publications. "I live mostly in the future," Green was quoted as saying.

Former ARRL Contributing Editor Stan Horzepa, WA1LOU, once wrote in his "Surfin" web column, "We take computers and the Internet for granted today. I first became interested in computers when Wayne Green, W2NSD, started writing about them in 73 magazine in the 1970s. Back then, you had to build your own from scratch or from kits."

Green maintained a larger-than-life presence, even in the years after he faded from the Amateur Radio spotlight, and he never did really retire. "Hey old buddy, I will miss you," radio talk show host Art Bell, W6OBB, posted to Wayne Green's blog. "NEVER SAY DIE is a phrase that will be with me till it's my time." Green was an occasional guest on Bell's "Coast to Coast AM" overnight talk program. There hardly was an issue that Green would not confront, and he expounded a variety of unconventional science, health, and medical theories — from cold fusion and the moon landing to AIDS and cancer cures. He continued to write and speak frequently on these topics and others, as well as on public policy, even at hamfests where he was a guest.

The "Final" in his blog sums up Green's overarching philosophy. "Wayne Green passed away September 13, 2013 in a peaceful, painless transition from this life on Earth. An eternal optimist, and one who loved to share his never-ending zest for life, he was a friend to many and will be missed greatly. Wayne was not afraid of dying and was very much ready to embark on his next great adventure to the afterlife."
