#### CIRC meeting – January 28, 2015 Agenda

It's a bit early to put together a final agenda for the January meeting, but we should start thinking about items which will be on the agenda.

Our repeater (the 149.940 machine) has had some technical problems. Fortunately Jim Shaffer WB9UWA has been able to repair the repeater, finding only some connector problems so far. It is a reminder that our repeater is in a precarious position and may need to be replaced or relocated in the near future.

An active group of CIRC members has been working on a D-STAR repeater and have made substantial progress. We should learn more about what they've been working on and whether D-STAR could be an option if (when?) we need to replace our repeater.

Our dues structure was discussed at the last meeting. There was some feeling that our current dues were perhaps too high for some members. It was generally agreed that we did not want our dues to deter individuals from joining CIRC. Duane KC9PIM has a proposal which he will bring to the meeting as a starting point for discussion of the question. Bring your ideas to the January meeting.

Norm Huber is wearing dual hats as our CIRC Station Manager and our ARES coordinator. He will update us on current ARES activities, and also bring us up to date on the status of the club station.

We want to have a "Saturday at the Red Cross" day again this winter, so check your calendar and watch your email. We may get something together before the January meeting.

#### **CIRC Membership Proposal**

At the last CIRC meeting, members expressed some concern with the cost of CIRC membership. The discussions did not propose any specific actions with respect to the appropriate level of club dues,

but they did identify the competing components of our current membership structure.

On one hand, it is the goal of the club to increase and diversify membership. In short, we want to attract more members, especially younger members, to share the current goals and activities of the club and to continue these on in the future.

Competing with this goal, at least in part, is that the level of dues that we currently charge for membership in the club potentially inhibits growth in club membership. Younger individuals, individuals caught in the recent economic slowdown, and individuals who have not yet fully developed their interest in our hobby simply may not be willing to pay \$30 annually for club membership.

To better balance these competing forces, I propose, through a change in the By-Laws, that we separate the competing interests of Membership and Funding into two separate sections.

Following is a set of bullet points that outline such a change.

- Membership in CIRC shall be free. To be a member, an individual only needs to fully complete an application (Name, Contact info, licensing, if any, etc.) and agree to abide the laws governing amateur radio and the rules of this club.
- Membership is open to anyone, whether or not they hold an amateur radio license, but holding a club office or voting shall be restricted to amateur radio operators in good standing (with the FCC).
- 3. Recognizing the need to raise money for capital projects and ongoing operations of the club, the officers shall, at least annually, organize a volunteer fund raising drive amongst members to solicit, but not require, contributions from members in amounts, if any, to be set by the individual member.
- 4. Other than for internal control purposes, the club Treasurer or other officers shall not keep or publish lists of individual contributors and their contributions without the express consent of the contributor.
- 5. The club shall, as the opportunity presents, seek other funding from the public.

There may be variations of the above that the membership would find satisfactory or the

membership may decide not to make any changes at this time. There was a consensus at the last meeting that the officers would consider whether changes should be made and what those changes could be. This is one such proposal.

We do have the practical problem that current membership dues are payable at the January meeting. We will not have a December meeting to discuss this issue. So, if we are to make any changes this year, we will need to make and apply them all in the same January meeting.

#### **KP1-5 DXpedition**

Re: Navassa (KP1) DXpedition

Dated: 22 October 2014

The U.S. Fish & Wildlife Service has notified the KP1-5 Project that they will be the team to activate Navassa Island (KP1) in January 2015. The DXpedition will be a maximum of fourteen days. The exact dates in January will be determined by USFWS mission requirements and weather windows. Our experienced team of fifteen is complete and is ready for the challenge. The weeks ahead will be extremely busy as the team has less than 90 days before the DXpedition comes on the air.

January is the month of minimum bird nesting activity and this is the primary reason USFWS is asking that the operation be completed during that month. However, the weather is unpredictable in January and because Navassa is surrounded by cliffs, this may preclude a safe landing by boat. For safety reasons and in order to maximize our time on the Island and on the air, a helicopter operation is planned. Navassa is over 100 miles (160 km) from the nearest helicopter staging point and as many as ten round trips will be required at the beginning and end of the operation. Obviously, this means that there will be a significant cost for activating this #1 ranked DXCC entity.

In the next few weeks, we be working with USFWS and as details firm up, we will issue periodic press releases. Check our webpage, http://www.kp1-5.com for more details of the operation and how you may financially support this DXpedition.

The KP1-5 Project team has committed to fund 50% of the total costs. We are hopeful the DX community at large will fund the remainder. for The KP1-5 Project,
