

## Racine MegaCycle Club, Inc. 1999 Amateur Radio & Computer Auction

#### **Rules and Conditions**

- 1. Racine Megacycle Club, Inc. (RMC) makes no warranty, express or implied, on any of the items sold or given at the auction. All items are sold "as is as shown". All sales are final.
- 2. All participants are responsible for full payment of items purchased at the auction. All payments are in cash.
- 3. Items purchased at auction may be paid for and picked up either immediately after the auction or during an announced break in the auction. All items must be paid for and removed by the end of the evening. RMC is not responsible for items left behind.
- 4. For the purposes of this auction, an "item" is defined as a single item or lot put up for auction. Each seller may, at the time of registration, define how they want their items registered. For example: A seller may have a box of 15 connectors registered as one "item" of 15 pieces to be sold together. This seller may also have three "items" of five connectors each. Remember that RMC collects \$1 registration for each "item" to help recover the costs of auction time spent on each "item". In the cases above RMC would collect \$1 and \$3 respectively.
- 5. All items for auction shall be registered on the night of the auction and put in an inspection area for preview by potential buyers. Preview shall be available until the item is put up for bid.
- 6. Reserve Pricing (having a minimum amount the item will sell for) is allowed for items over \$25. The seller will set the reserve price (if any) at the time the item is registered. During the auction we will announce that an item has a reserve price, but will not disclose the amount until the bidding has exceeded it. Items that do not have the reserve price met by bidding will be returned to the original owner.
- 7. Racine MegaCycle Club, Inc. will collect fees from the seller for the items that are sold according to the following schedule:

15% of selling price.

- 8. Racine MegaCycle Club, Inc. will charge \$2 admission to each person 12 years and older.
- 9. The Racine MegaCycle Club, Inc. would appreciate all donations of money and/or items for auction. All donated proceeds go to the Racine MegaCycle Club, Inc. Remember that your contribution might be useful to someone else and benefit the Racine MegaCycle Club, too.
