With the new officers taking over in January, The topics planned to be covered are for Field Day 2001; with more planning and set up this year hopefully to overcome some of Murphy's law on antennas not working right, and the possibility of bringing VE testing to Morgan City using the ARRL VEC system. Late News Flashes

Two things affecting Amateur radio have come up as this letter was being produced. The first one involves testing, where exams that in 2000 were \$6.65 will now be charged \$10 later on in the year 2001 at both ARRL and W5YI VE test sessions, This was voted on by their respective boards to cover their test giving expenses. The current fee of \$6.65 is based on a provision in the Communications Act, adopted in 1984, that established a \$4 cap on reimbursement of out-of-pocket costs with an annual adjustment based on the Consumer Price Index. More recent legislation removed this cap. An FCC announcement of changes in its rules, reflecting the change in the law, is expected toward the end of 2000. The second one involves legislation that permits the enforcement of certain FCC Citizens Band regulations by state and local governments. In short, the measure authorizes states and localities to enact laws that prohibit the use of unauthorized CB equipment not consistent with FCC regulations. This would include the use of high-power linear amplifiers or equipment that was not FCC-certificated. FCC-licensed stations in any radio service, including the Amateur Service, are excluded from such state or local enforcement, and state or local laws enacted under this legislation must identify this exemption. President Clinton signed this legislation into law in Late November after passing in both houses of congress. For more information on the 11 meter bill, please check out this web site:
