

# Auckland Unitary Plan Update

The Submission Status

The Auckland Council has now posted some dates for the first part of our Submission 4498 Hearings. The posting is part of a large 9 MB spread-sheet (see <u>http://www.aupihp.govt.nz/</u>)

Very briefly the process is

- a) Expert Panel hearing: April 2015. This specifies that the whole panel will be dealing with all the issues of definition (such as "ensure that 'Amateur Radio Configuration' applies to the definition of 'aerial')" There are four specific matters under this category.
- b) Pre-hearing panel (specifically "split panel A") will meet in March 2015. These hearing will deal with the infrastructure issues such as aerial heights, zone issues, Assessment issues, and the like. There are 16 matters in this category.

At these meetings there will be an attempt to resolve issues so as to avoid the full Hearings process, which are scheduled for later in the year (currently expected to be November 2015). The steering committee will be discussing its approach in the next week or so. Because of the importance of NZART succeeding with the Auckland Plan – if we don't win, it is possible that other Councils could align themselves with the Auckland approach, and that might not be good for Amateur Radio in New Zealand – I rather hope that we will enter this process with the best professional advise available.

- Antennas:
- Tower: A champion is required to fit the rotator and quad. Gwynne has stored them
- It could be used for the Remote station.
- Cable length from HF2 along the fence-line required is 30m + 15m +12m = 60m. Either 9405 rotator cable or tow bar and electric cable will do for the rotator. We may have enough coax .
- 40 m centre pole: It may be extended temporarily with bamboo pole to make it a flat top.
- Bamboo poles: 4 are stored and need to be varnished. More poles are required.
- Dress rehearsal to erect the loop antennas on 21st Feb (before JWFD).
- A vertical could be mounted on the Nally tower, unless it is not used elsewhere.

## **Remotely Piloted Aircraft Systems/Drones**

Remotely piloted aircraft systems (RPAS) must use the right radio frequencies, so they don't cause harmful interference to vital radio systems such as air traffic control, cellular phones, or emergency services.

People who use the wrong frequencies for their RPAS can be prosecuted under the Radiocommunications Act 1989 and the Radiocommunications Regulations 2001.

The most commonly used frequencies that are legal for RPAS in New Zealand are 433 MHz or 2.4 GHz for remote control, along with 5.8 GHz for video and audio links. RPAS can use any of the frequencies in the General User Radio Licence for Short Range Devices and the General User Radio Licence for Aeronautical Control. These are the only frequencies that RPAS are permitted to use in New Zealand.

RPAS must also comply with the licence conditions set out in the General User Licences and the Radiocommuncations (Radio Standards) Notice 2010.

Because most RPAS equipment is developed offshore, it often exceeds the frequency and power limits required in New Zealand, and so it is illegal to possess or use here.

If you intend to buy an RPAS, ask the supplier for evidence of compliance with New Zealand requirements. This will be shown on the product by a supplier code number (SCN) or R-NZ label. http://www.rsm.govt.nz/consumers/remotely-piloted-aircraft-systems-drones/
