



## The Fox hunting page


• **Three** Transmitters are hiding at places also Identified with a white and orange prism-shaped flag at each place.



- Obtain a **control card** on which you must write your **Name**, **Age**, **Address**, and **Phone number twice** please.
- Hand this card in to the **Starter** who will give you the **next available start time** (in 5 minute intervals), but he will keep half of the card. Only after starting may you turn on your Direction Finding Radio, also called a "**Sniffer**".
- Plug in the headphones. This turns the sniffer on. Tune and listen for the foxes' call-signs (see below). As you turn around, the signal peaks when the ferrite rod is broadside to the fox (front and back). To resolve the ambiguity about which way to go, press the red button to activate the telescopic antenna as well. This suppresses one of the signal reception lobes as seen by the signal strength graph shown here. The greatest accuracy is obtained when the signal fades out completely. When you are very close to a fox, you will need to attenuate the signal (turn the volume down).



- Each fox broadcasts its call-sign in slow Morse code on 3.51 MHz, 3.52 MHz, and 3.53 MHz respectively. They are:
  - M O E sounds like "dah dah dah dah dit "
    M O I sounds like "dah dah dah dah dah dit dit"
    M O S sounds like "dah dah dah dah dit dit"




Signal Strength direction



- As you find each fox, note its alphabetic identifying **letter** (ignore any numbers), thus scoring 20 points for each.
- Time allowed is 1/2 hour. One point will be deducted for each minute late in returning. As you finish, we shall record your elapsed time, and compute your score. Control cards will be progressively displayed so that you may compare your score with others and discuss your strategies
- You must hand in your control card even if you abandon the course, otherwise we will think that you are lost and a search party may be sent out to find you.

**TIP:** Ask about "**triangulation**". This means: from two or three different known places on your map, plot the bearings to all of the foxes that you can hear. (For this you may need a compass to orient your map.) Go that little bit further along the road to take more bearings, thus making a precise intersection of these bearings to show where all of the foxes are hiding. Then study your map to plan how to run around the park by the shortest route, scoring 20 points for each fox as you go. This is faster than bush-bashing towards each fox in turn. Remember to keep an eye on your time out on the course so as to avoid point deductions for being late back.

#### Report of Committee Meeting held on 2nd December

- Gwynne reported that he has ordered two ARRL hard cover books for Subs raffle and for a later event.
- Wallace reported on a meeting with Hamish Keith, Acting Manager of Auckland Council's ECC whose relationship with AREC is defined by a Memorandum of Understanding with Richard Gamble manager of Northern District AREC who prioritises and disburses \$6,000 p.a. granted by ECC for AREC. Civil Defence assets were transitioned to Auckland Council Property Limited (ACPL) in 2010. ECC have no interest in this clubroom, per se. However he agrees that the building should be returned to the ownership of Auckland Branch so that we may obtain insurance. He will support our request ACPL.
- Support from Compass Communications has reached an impasse. Compass did not use our authority to directly debit our account; rather they cut the connection when we owed \$163 and now they are demanding a termination fee (\$199) and seem to be litigious about it. Their management failed to phone back as promised (3 times). The Committee resolved to shop elsewhere for an ISP that is fit for our purpose. We have proved that two other ISPs can link to our server using identical setup of modem and host.
- The Financial year will end on 31 October in future. This will allow more time for the financial accounts to be reviewed before the AGM that the Constitution prescribes shall be held in December.
- A Budget for 2016 has been recommended to the incoming Committee. A Safety Manual has been written in anticipation of an inspection by Health and Safety.
- At the November General Meeting, Wallace was tasked to shop for an alternative ISP. Vodafone have offered to be our ISP offering naked 60 Gb \$60 /month for 12 month contract, less \$100 sweetener. Wallace is to pursue this offer and he will define an acceptance test in writing before signing up.

Resolved ZL3TE / ZL1WAL 1 abstention

#### **Other Business:**

- Branch policy (April 2014) about the remotely controlled station was reiterated, that is, priority is given to Members' operating in the Clubroom. Remote operation allows registered Members to listen (many at once); the first comer may tune the K3. A time limit is set. Scheduling may be done via the memo window. Antenna options are being experimented with.
- An objection was made on the grounds of a breach of privacy when the Notice of this meeting had a list of Members' details (e-mail, phone, address, etc.) attached. The same list is posted on the notice board, to which no objection was raised. The Membership renewal form should ask: "With-hold details?" in future.

The meeting ended at 21:23 hours with supper provided by Ray ZL1AJR and Mrs Nicoll.



#### **SOTA**

Summits on the Air (SOTA) is an award scheme for radio amateurs and shortwave listeners that encourages portable operation in mountainous areas. SOTA has been carefully designed to make participation possible for everyone - this is not just for mountaineers!

There are awards for activators (those who ascend to the summits) and chasers (who either operate from home, a local hilltop or are even Activators on other summits).

Warren, ZL2AJ has been instrumental in getting SOTA organized and accredited in New Zealand. He is the ZL SOTA manager. Warren has a web site with local Information. **www.zl-sota.org** He has a few stories and photos of his and others recent activations. To date, there have been 1,252 Qualifying summits in 9 regions of the North Island registered and assigned a SOTA Code. The ZL North Island List can be found here:

www.sota.org.uk/Association/ZL1 The Auckland Region has 26 eligable summits.

Some BASIC Rules, You must operate within 25 Meters of the summit, if you can not get to the actual summit due to any restrictions, Fence line, Private property etc... Operation from a vehicle is NOT permitted. Final access to the summit must be "Person Powered", Hiking, Bicycle etc. It's also a great way to get some excercise.

- Gwynne will buy two ARRL books to raffle. The Handbook is an incentive to pay subs on time; the Antenna book is an incentive to attend a future General Meeting when a good speaker is scheduled.

- Previous General Meeting: Video of 2006 DXpedition to Kermidec Island was shown as was well received.
- AREC: Wallace reported his meeting with Hamish Keith, Acting Manager of ECC for Auckland Council.
   ECC have a Memorandum of Understanding that effectively places individual Branches at arms length.
   ECC have no interest in owning this clubroom since assets were transitioned to Auckland Council Property Limited (ACPL) in 2010. A suggestion that the building should be sold back to Auckland Branch was supported. Wallace to follow up.
- Visitors: Keijo OH2BOZ from Finland. His photo is among miscellaneous photos on www.qsl.net/zl1aa/
- Web page: Has been updated. The date for the AGM (next week) is shown correctly now.
- Maintenance
- Meter reading: 47720.4
- Power outlets: Steve said that he will finish upgrading the electrics during the summer recess.
- Steps Steve will replace these using materials purchased with Ray's donation of \$200.
- Computers / network / phone line / Remotely controlled station:
- Compass Communications:
  - A letter was sent that outlines their failure to provide naked broadband fit for purpose (the Remotely operated station). Other failures were: inadequate technical support and no managerial call-back as promised (3 times). Our authority given to directly debit charges was not used; debts were allowed to amount until they sent a final notice, though not to our postal address. They disconnected the line. We tried two other ISPs with success using identical server and modem, thus isolating the problem to be with Compass. Subsequent phone calls led to an impasse and their demand for payment of the present debt (\$170). Termination required 30 days notice (+\$69) and a contract breaking fee (+\$199). This letter advises our termination of the contract and requests a waiver of all charges due to their breach of the contract.
  - o At the November General Meeting a motion was put to recommend to the Committee to shop around for an alternative ISP. Vodafone offer 80 Gb for \$60 per month less \$100 sweetner for a 12 month contract.

## **3XY, GUINEA**

(Press Release). Members of the Italian DXpedition Team will be active as 3XY1T from the Los Islands (AF-051, WW Loc. IJ39cl) between February 18th and March 4th. The latest news was sent out by the 3XY1T Team:

Everything is ready as planned for our departure on February 17th, 2016. We anticipate arriving at Los Island (AF-051) in the morning of Thursday 18th. The island does not have a power grid; our resort has a generator operating only during the night. We rented two generators for daylight operations; as a consequence, there might be occasional breaks for the maintenance of this equipment.

We received several requests for RTTY activity. In order to offer such a "mode new one" to as many OMs as possible, we shall concentrate our RTTY operations on a single band, i.e. 15m.

In analyzing statistical data, we noticed that there is a high demand for this country in VK/ZL. These stations are invited to use the cluster to warn us of possible openings.

Long-path openings to Japan will be closely monitored, and we suggest these stations to make use of propagation forecasts to optimize their chances.

We plan to have, as usual, our real-time online Log available via internet, with uploads every minute (barring connection problems). It can be accessed at the address <a href="http://win.i2ysb.com/logonline">http://win.i2ysb.com/logonline</a>.

Also, the online QSL request (OQRS) will be active as from the very first QSO. We advise to check the time/date of the latest online update, as shown on the Log entry page, before repeating a QSO.

Specific requests should be addressed ONLY to our pilot stations, Arturo/IK7JWY and Sergio/IK0FTA (for the 6m band). The pilot stations can check and correct possible Log errors.



## Lee Jennings, ZL2AL Memorial Activity Marathon

We are looking to encourage more ZL activity on the HF bands. The goal is simple: see how many days you can have four or more QSOs on any of the MF/HF bands, 630m to 6m during 2016. A minimum of 50 days will qualify you for a Bronze Certificate, 100 days Silver, 200 days Gold and 300 days Platinum. This is not a contest so the only requirement for a QSO is to log a call sign and signal report. After that the QSO can be as long or as short as you please. All HF QSOs using any mode count including ZL to ZL QSOs. You can also count all QSOs you make with a branch or club callsign (although you will need to obtain an extract of the log showing the QSOs you make).

If the challenge of four QSOs a day is not enough then there is the opportunity to endorse your award by making your QSOs on a single band, or using a single mode, operating QRP, or for working 100 or more DXCC entities. Do you want to explore propagation on a certain band, improve your CW skills, or work as many different entities as you can during the year? This award will (I hope) give you

an incentive to do this. In fact you could do a combination of all of them e.g. 17m CW while operating QRP and aiming for 100 countries.

Logs will be required to be sent to Mark, ZL3AB at the end of the year, preferably in ADIF format, although paper logs will be accepted. You do not need to extract the four QSOs for each day you wish to count from your log and send them to me as one file (although that would be helpful).

With the blessing of his family, the award has been named after Lee Jennings ZL2AL SK who was a very active HF operator, friend and mentor to many. He loved to encourage people to get active, set goals and then help them strive to achieve them which is what this award is all about.

#### The Rules:

Date: 0000 Friday 1 January 2016 to 2359 Saturday 31 December 2016 UTC (or 1300 Friday 1 January 2016 to 1259 Sunday 1 January 2017 NZDST if you prefer)

- 1) Object: To make a minimum of four QSOs per day for as many days as you can during the year
- 2) Bands: All MF & HF bands 630m to 6m including the WARC bands
- 3) Modes: All modes permitted e.g. CW, SSB, RTTY, JT65, PSK31, and any other digital mode
- 4) Meaning of QSO: A completed two way QSO with an amateur station swapping as a minimum Callsigns and a signal report appropriate for the mode used. The QSO can otherwise be as long or as short as you like. This can include QSOs made during contests and nets.
- 5) Callsign: You may claim QSOs using any callsign you are licenced to use during the marathon period including overseas operations such as being on a DXpedition. You may also include QSOs you make using a branch or contest club callsign.
- 6) Awards: A certificate will be sent to each Amateur who meets the Object as follows:
  - 1) Bronze 50 days
- 2) Silver 100 Days
- 3) Gold 200 Days
- 4) Platinum 300 days
- 7) Special Certificate Endorsements: Assuming you qualify for an award, you may if you wish request we endorse your certificate with any or all of:
  - 1) Worked 100 DXCC Entities: The QSOs submitted show contacts with Amateurs in 100 or more DXCC entities.
  - 2) Single Mode: All QSOs submitted must be any one of CW, SSB or a single Digital mode e.g. PSK31.
  - 3) QRP: All QSOs submitted must be 5W or less for CW or Digital, or 10W or less for SSB.
  - 4) Single Band: All QSOs submitted must be on one band.

Endorsements are applied for when you submit your log.

- 8) Judging: Mark's (ZL3AB) decision is final and no correspondence will be entered into.
- 9) Logs: To be eligible you must submit a log with the following information:
  - 1) Your name, address, email address, callsign(s) used, the number of days you claim meet the Object and any endorsement you wish to apply for.
  - 2) A list of your claimed QSOs with the date and time, your callsign (where you submit a log with more than one callsign used) callsign of the station worked, band and signal report.
  - 3) Logs can be in any electronic format and must be submitted by email to mark [at] zl3x.com by 10pm Sunday 3 January 2017 NZDST. ADIF or Cabrillo formats preferred. UTC time/date is preferred however logs may also be submitted using NZDST or NZDT provided this is clearly identified.
  - 4) Paper logs will also be accepted by post to: 12 Ruahine Place, Christchurch, 8083. Due to the tight deadline if you wish to post a paper log after the end of the marathon please contact Mark (ZL3AB) at the email address above or by post prior to the end of the marathon so arrangements for log checking can be put in place.
- 10) Results: will be published in the February 2017 CQ DX column in Break-In (which is why entries must be in by 3 January).
