**Membership:**

- The list of non-paying members of the Branch over the last three years was reviewed:
  - Members (10) who for two years have not paid their subscription were crossed off the list.
  - Those who have moved overseas are expected to rejoin if /when they return to Auckland.
  - Secretary to write again to nine members who have overlooked paying their subscription this year.
  - Last year there were 70 NZART members attached to Auckland branch of which 26 are financial Branch members. Of the remaining 34, most were either 'phoned or written to last year but there were 25 whose addresses could not be found. Some may be out of town, others SK.
  - This year there were 61 NZART members attached, suggesting that last year's letter had prompted 19 of them to have their records in SMART amended. 15 were written to and responses were received from six of them; four joined the Branch and one transferred to another branch.
  - Branch members are now 36; (41 in 2009); (47 in 2008) and (100 in 1981). This downward trending graph is the same shape as that published by NZART <http://www.nzart.org.nz/infoline/2010/infoline-207.html> where membership peaked in 1982 and has now halved.

## **Minutes of Committee Meeting** (Continued)

### **General business:**

1. **AREC matters:** Steve, Japie and Wallace will attend an event sponsored by the NZ Computer Society on 10 June. Steve Davis, ZL2UCX having had AREC and S&R experience will address the meeting.
2. **Program for General Meetings:** This month 19<sup>th</sup> June, Gwynne will give an account of the NZART Conference held on Queens Birthday weekend. Steve offered to talk about his recent tour as Electrician and 3<sup>rd</sup> Engineer on Arctic Sunrise in the Baltic Sea. For a future General meeting, a DVD is to be made showing action in an A830 cockpit.
3. **Maintenance** (in order of priority):
  - A maintenance book has been introduced to record items requiring attention.
  - Re-blocking done and guttering renewed
  - Doorstep repainted and curtains have been hung.
  - Graham O'Neill, ZL1ONL has built a trolley for more easily moving rigs into the locker under the bench at Station 1. This is considered most satisfactory.
  - Water-blasting done ready for painting windows and the south wall.
  - The barge board needs to be replaced to support the VHF antenna.
  - Painting base of clubroom.
  - Smoke alarm – George will purchase one suitable for connecting to the alarm system.
  - Sign at gate entrance needs cleaning / repainting and meeting dates and times to be updated.
4. **Antennas** (in order of Priority):
  - Poles have been erected ready for hoisting the 80m antenna that will be along the south boundary.
  - The high gain VHF antenna has been removed. The low gain VHF antenna awaits the new bargeboard.
  - A 10m half wavelength vertical antenna is temporarily positioned; but it is suitable for 25w only. Steve urged that instruction needs to be given to any would-be operators of this rig.
  - Realignment of the beam – wait until Steve returns in 3 months when his truck can be used.
5. **NZART AGM and Conference:**
  - AGM Saturday morning 5<sup>th</sup> June. After lunch. software defined radio (SDR) then AREC forums.
  - Trade exhibits are freely open to the public. Selwyn will be operating an exhibit showing "Amateurs operating".
  - On Sunday there will be AGMs and forums of special groups.
6. **ZL1LC G.N.Reed operating a field station as Branch 02.**
  - Selwyn will research the rules of the competition, with a view to recommend the following:  
"that the rules of the competition should state that a field station operating in one's area should be a financial member of the branch and should operate only with the consent of the Branch."
7. **Remote station:**
  - Wallace and Jeffrey are yet to meet about use of a Woosh link to the Clubroom.
  - Japie will provide an Ethernet switch for it. George will provide an ADSL 2+ modem.
  - George reported that Brian Wilson has cable and conduit to complete the telephone line from the break point (in the middle of Scarbros' yard) to the boundary, then along it and into the clubroom.
8. **Shelving for library and parts.**
  - The committee considered Wallace's proposal to position a bank of six shelves to be placed back to back behind the VHF station on which to store magazines that are presently in boxes and cupboards in various places within the clubroom. Shelves will be labeled. The other side of these shelves facing into the room can be used to store parts and equipment for sale. Thus the room will get a tidy up.
  - The temporary trestle table on which is laid out some estate "junk" will be moved away in due course.

# Precis of an address about NZART issues

## Entry level licence

The majority of Council members want the entry level licence. It has taken 2 ½ years already.

Proposing to release “E” (E for Entry) call signs in PIB46 (terms of amateur licence).

Australia have a Foundation licence which is of lower standard. It terminates after 2 years. Only 2 of 12 councillors favour this. Hasting Branch have proved that it is easy to get a full licence in one weekend.

Alternatively, one could run a course for 11 weeks @ 2 hours each to get through the material.

## Call-Book

A Call-book will be issued this year. It was suspended last year because there was a problem while trying to combine two lists: one held by MED and the other at NZART. Unless both lists have pure numerals, they could not be matched. Since the amateur licence became free, few people bothered to update the database at MED. Thus SMART was introduced and it was supported by telephone help to encourage members to update their changes of address. A list appears on the NZART web site so that members may check their details and those of their friends. Do this immediately.

Another problem relates to Silent Keys. MED will not accept verbal notification of a Silent Key. Even a clipping from a newspaper is not acceptable. Only immediate family may notify MED using form 10. The NZART database is better.

It costs \$16,000 to print the Call-book. A reduced size Call-book is being considered in future years because this costs only \$8,000, so this leaves money to produce a CD ROM that will include VK call-signs also.

## Membership

Membership is below the critical level of 1800 to support NZART HQ. Membership is now 1400. Another 200 have not renewed their subscription. (See the decline at <http://www.nzart.org.nz/infoline/2010/infoline-207.html>.) NZART have decided to ‘phone all these people. New members are needed.

The HQ lease is soon to expire. Business Manager, Debby Morgan has agreed to take over from her home at Paraparumu where she is funded to support NZART for 3 days per week and the Ulysses Motor Cycle club for 2 days per week. Thus both organizations will get support all week.

## MED

The frequencies 500-515 kHz have been allocated to Amateurs.

NZART also want the allocation of 615.25 MHz for amateur TV Channel 39.

This will not be allocated until TV1, TV2, TV3 have shut down – very soon.

Meanwhile MED have offered digital (multiple streams)

The digital spectrum has a guard band at the top end. This will be offered to Amateurs.

Currently 7 to 9 TV stations are operating on low power throughout NZ.

MED has no problem with Remote HF. Apparently somebody complained that these were unmanned and thus breached licence conditions. In future, remote stations have to be licenced and must demonstrate that it is properly controlled. This means that a questionnaire will be appended to the licence so as to find the person responsible to shut it down if it causes interference. A fee of between \$50 and \$150 will be charged.

## Archives

A CD-ROM is being made that will contain Break-in magazines and articles that were not published.

Earlier Break-in magazines have to be scanned first, then they will be included.

Break-in used to be sold in magazine shops for \$7.50 each. 150 copies were given to the distributor but only 50 were sold. Printing cost is \$2.00 each. Some specialist magazine shops were only selling 10.

Unsold copies were spoiled because the corner was cut off to claim a refund. Consideration has been given to gifting them to waiting rooms.
