IF YOU ARE IN THE AREA AND HAVE CHECKED IN BEFORE, YOU ARE NOT CONSIDERED A VISITOR. WE WELCOME YOU AS A LOCAL CHECK IN. **FIRST TIME VISITORS** WILL HAVE AN OPPORTUNITY TO CHECK IN AFTER ROLL CALL.

THE FREQUENCY IS NOW OPEN FOR EMERGENCY TRAFFIC.
