MINUTES  
of  
PUGET AMATEUR RADIO SOCIETY MEETING  
Oct. 16, 1997

The meeting was called to order by President Lorie Graff N7LC0 with the Pledge of Allegiance led by Lester Ellis KC7TQP. There were 12 members present, and 4 guests. Members and guests introduced themselves.

The program was presented by Patrick Dayshaw WA7VNI, a member of the Western Washington DX Club. He gave a very instructive talk on the basics of HF propagation, and how solar activity affects the various ionosphere layers, which in turn affects HF propagation.

Following the program, Lorie announced that the bid forms for the IC-H10 headsets and matching switch boxes were available for those who were interested. Refreshments were then served.

The meeting was then re-convened for the business meeting. A motion was made and seconded to approve the minutes of the Sept. 18 meeting, as published in SPARKS, motion carried.

The Treasurer's report was then given. A motion was made and seconded to approve the Treasurer's Report, motion carried. The Treasurer requested that the club approve a policy of not publishing the complete report in SPARKS, and the suggestion was made to delete it altogether from the newsletter. The complete Treasurer's Report is available on request to any member of the club any time.

Pres. Lorie then introduced the proposed 1998 budget, as proposed by the Board and enclosed in the last issue of SPARKS. A motion was made and seconded to approve the budget as proposed, motion carried. Treasurer Jim Von Seggern KC7FEH requested permission to change a budget category from Corporate Fee to Fees and Licenses, to simplify the record on the computer. No objections were raised.

Pres. Lorie then stated that the Board had previously voted to recommend to the membership that the meeting site be changed to the Blakemore Building in Bellevue, starting January 1998, due to the fact that the current site was for sale and might not be available next year. Since the Board action, we have

received information that that room will only accommodate 25 persons, and thus might not be suitable in the long term. Lorie recommended that for the present we continue in our present location and hope the building does not sell soon. It was suggested by Charles Beckmeier KC7GMF that we could investigate the possibility of a meeting site in a Bellevue Fire Dept. station, since they often have meeting rooms. This will be pursued by the Board.

Jim Von Seggern has asked to be relieved from the duties of Trailer Committee chairman. Lorie will be asking for a volunteer to take over that function, and Jim stated that there is a need not only for someone to periodically inspect the trailer, but we need to have several names posted for notification in case of emergency. Jim will consult with the new chairman regarding how to inspect the rebuilt front end for dry rot.

Lorie announce that the club will receive a donation of an HF transceiver in the next 2-3 months from an anonymous donor, which will be used to establish an operating station in the trailer. Cameron Etezadi KFORV has indicated interest in being responsible for making the trailer available on weekends for those who might wish to use the radio.

Kirk Bellar KE7TN suggested that the club attempt to acquire a club call sign, to provide a recognizable call on Field Day and to provide a constant call in spite of changes in membership. Kirk said that at present K7PAR is available, and W7PAR will be available early next year. Ye can request up to 25 potential call signs, one of which may be assigned by the FCC. It also involves a \$50 fee every 10 years. A motion was made and seconded that the Board pursue this, motion carried. Kirk will collect the appropriate materials.

Jim Darby W7FYTI requested that members look in the Seattle and Eastside papers for the notices of the coming club meetings, which he is now sending to the P-I, Times, Eastside Journal and Eastside Week.

The meeting was then adjourned.

Bob Adams KJ7BP Vice-President

Bob spent 40 years at Boeing as a flight data test engineer, and retired in 1992. After retirement he finally had time to work on his code which led to his amateur license shortly after retirement, and he currently holds an Advanced license. He has been Vice-President of PARS for the past 2 years, and is also active in the BEARS club, and Eastside Amateur Radio Support group (EARS). Bob and his wife Marge are also members of the Boeing Computer Society. He also still does some sailing, and is a licensed private pilot. He occasionally does consultant work for Boeing. He first became interested in ham radio in high school, but not being a technically oriented person he found it difficult to learn from the ARRL handbook. In 1994, he saw an article in Motor Home magazine about getting a No-Code Tech license, and with renewed interest he got the study guide and finally decided to try the code (which he passed!) He currently holds a General class license.

In addition to radio, Jim is involved in glass fusion and slumping, a hobby he shares with Arzetta. He also plays tuba and classical organ (a little). He has been an active PARS member and has worn several hats over the past few years as secretary, secretary-treasurer, newsletter editor, chairman of the trailer committee, and chairman of the Board.
