ARRL Board Adopts Guidelines and Recommendations on the Appropriate Use of Amateur Radio

On Friday, September 25, the ARRL Board of Directors adopted <u>guidelines on the appropriate use of Amateur</u> <u>Radio</u> on behalf of commercial, non-profit and government entities, as well as recommendations for additional steps to be taken by the ARRL to educate radio amateurs and others on how to prepare and train for public service and emergency communications while complying with the current FCC Rules.

At its meeting in July 2009, the ARRL Board created an ad-hoc committee to study the issue and prepare suggested guidelines. The committee submitted its report to the ARRL Executive Committee, which reviewed and revised the document. After additional discussion among Board members by electronic mail and teleconference, the Executive Committee submitted the document to the Board for formal adoption.

Entitled *The Commercialization of Amateur Radio: The Rules, The Risks, The Issues,* the document offers guidelines to assist radio amateurs and anyone wishing to utilize the capabilities of Amateur Radio in understanding the FCC Rules that prohibit communications in which the amateur has a pecuniary interest, including communications on behalf of an employer. While the FCC Rules in this regard have not changed in many years, there has been increasing discussion of the issue as growing numbers of employers and non-amateur organizations recognize the value of Amateur Radio as an emergency communications resource and encourage their employees to obtain amateur licenses. Also included are guidelines for evaluating the appropriateness of Amateur Radio volunteers providing communications services to commercial enterprises and other entities for which other communications systems are available.

"The guidelines are not intended to be the last word on the subject, and surely will not be," observed ARRL First Vice President Kay Craigie, N3KN, and chair of the ad-hoc committee. "The report includes several recommendations for additional steps that the ARRL needs to take to help amateurs and the organizations we serve to better understand the Rules and to ensure that what we do to prepare to be of service in emergencies is consistent with the current Rules."

Some Tech Talk

The NTSB has issued an urgent interim recommendation re: the fatal Metro collision in June. <<u>http://www.ntsb.gov/recs/letters/2009/R09_15_16.pdf</u>> The letter discusses the failure they found:

"Testing found that a spurious high-frequency modulated signal was being created by parasitic oscillation from the power output transistors in the track circuit module transmitter. This spurious signal propagated through the power transistor heat sink, through the metal rack structure, and through a shared power source into the associated module receiver, thus establishing an unintended signal path. The spurious signal mimicked a valid track circuit signal. The peak amplitude of the spurious signal appeared at the correct time interval and was large enough to be sensed by the module receiver as a valid track circuit signal, which energized the track relay. This combination -- of an alternate signal path between track circuit modules and a spurious signal capable of exploiting that path -- bypassed the rails, and the ability of the track circuit to detect the train was lost."

and makes recommendations for WMATA, and other involved parties.

Comment: Attention has long focused on the track signaling circuit that inexplicably failed to detect the stopped train. What was not know was why it failed; when AC track signals have been in use for a century. After a great deal of work on the scene and off, NTSB has part of the answer. The RISK here is this was and is the classic "all the eggs in one basket" protection scheme. It was a very sturdy basket, but...

Now the issue is how to retrofit real redundancy into this system...and how to pay for it.

On the Bands



Morse's Farewell

HARA Presentation By Paul Racine, KB0P

You may have heard the story of the first telegraph message that was sent by Morse, from Washington to Baltimore in 1844, but very few people have heard the story of his last telegraph message.



Samuel F.B. Morse was born in Charlestown, Massachusetts on April 27, 1791. An artist and painter, he developed an interest in the possibility of electrical telegraph during a long sea voyage from Europe back home to the United States, in 1832. The electric telegraph was invented and demonstrated during the late 1830's and the first commercial electrical telegraph line was officially opened on May 24, 1844.

Samuel F. B. Morse was almost 80 years old when Western Union decided to recognize his accomplishments by honoring him in a celebration. New York City was chosen as the location of the celebration, some 27 years after the introduction of the electric telegraph. Steam whistles blew from all the passenger ships as they arrived in port, all waving the flags of their country of origin. By the hundreds, telegraphers from around the world began arriving in New York City on Thursday

and the celebration began early in the morning on Saturday, June 10, 1871.

The skies were clear and the temperature reached 74° as about 10,000 people gathered for the event. The days scheduled included the dedication of a statue of Samuel Morse in Central Park, boat excursions around Manhattan, displays by local retailers and manufacturers of telegraph equipment, city tours, and to be concluded that evening with a reception by The Academy of Music, during which Mr. Morse would bid a farewell to the telegraph fraternity by sending a special message to be concluded with his signature.

The auditorium was filled to standing room capacity by those who were fortunate enough to obtain the highly sought after tickets. Even on the stage, there was seating for 500 prominent and extinguished guests as they all quieted themselves for the event. At about 8:00 PM, escorted by William Orton, the President of Western Union and the Master of Ceremonies, the aged Samuel Morse feebly stepped up on stage. The crowd cheered and the ladies in the audience waved their white handkerchiefs as Mr. Morse was seated at the table and telegraph apparatus that was specially prepared for this special event. Some



of the notable individuals seated with Morse were Cyrus Field, the founder of the New York Tribune; Claflin, the governor of Massachusetts (the birth state of Morse); and General Jefferson Davis, the former president of The Confederate States of America. A special surprise to Samuel Morse, his friend Annie Ellsworth was close by, who is the one that suggested to Morse to use "What Hath God Wrought" as the first telegraph message in 1844.


The small table and telegraph instruments in front of Mr. Morse was covered with a white cloth to conceal the setup to the audience. During the hour of introduction, speeches, and remarks, the telegraph instrument under the cloth was clicking away as Western Union was busy putting together the massive circuit in preparation for the historical message; cutting in lines and correcting circuit issues. In anticipation, the telegraphers who were sitting the closest to the stage were winking at each other as they were copying the traffic in their heads.

At 9:00 PM, as the white cloth was removed and the table and telegraph equipment was first revealed to the audience, Mr. Orton (the President of Western Union) announced that it was prearranged that all the telegraph lines going to the major cities and towns in the United States and Canada were connected to the telegraph apparatus on this table.

The beautiful and accomplished Miss Sadie Cornwell was then escorted to the table and positioned herself to send the body of Professor Morse's message to all the cities and towns, simultaneously.

"Greetings and thanks to the Telegraph fraternity throughout the world. Glory to God in the Highest, on Earth Peace, Goodwill to men."

As Miss Cornwell was escorted away from the table, the crowd went wild in anticipation of what was to come, next. Mr. Orton then escorted Samuel Morse to the telegraph table. Mr. Morse took his seat and reached out his arm toward the key. The auditorium went quiet and all held their breath as not to miss a beat. Then Morse, with a steady and firm hand slowly sent his signature,

When the last dot was complete, the crowd gave Samuel F B Morse a standing ovation and cheered for several minutes. Mr. Morse was visibly overcome by emotion, and as Mr. Orton quieted the crowd, he stated, "Thus the Father of the Telegraph bids farewell to his children."

FCC Issues *Public Notice* on Amateur Service Communication During Government Disaster Drills

On Tuesday October 20, 2009 the FCC released a *Public Notice* clarifying the Commission's rules relating to the use of Amateur Radio by licensed amateurs participating in drills and exercises on behalf of their employers. Entitled *Amateur Service Communications During Government Disaster Drills*, the *Public Notice* addresses participation by paid employees of organizations taking part in drills.

The Public Notice -- <u>DA 09-2259</u> -- affirms that the Commission's rules "specifically prohibit amateur stations from transmitting communications 'in which the station licensee or control operator has a pecuniary interest, including communications on behalf of an employer."

ARRL Regulatory Information Manager Dan Henderson, N1ND, offered "This *Public Notice* is intended to clarify a difficult issue. A wide range of unofficial -- and frankly some incorrect -- interpretations have been offered on this topic in various public forums recently. DA-09-2259 is the official FCC notice on this issue. Though issued jointly by the Wireless Telecommunications Bureau (<u>WTB</u>), the Enforcement Bureau (<u>EB</u>) and the Public Safety and Homeland Security Bureau (<u>PSHSB</u>) under delegated authority from the Commission, the *Notice* makes it clear that WTB is the Bureau at the FCC with jurisdiction over the Amateur Radio Service rules and their interpretation."

The *Public Notice* states that, in order to facilitate participation by employees who wish to engage in governmentsponsored drills and emergency exercises on behalf of their employers, a waiver can be requested from the WTB *by the government agency sponsoring the drill or exercise* (and not by the individual who wishes to participate in the drill or exercise). Such a request must follow established procedures for requesting a temporary waiver of the Commission's rules. The government entity conducting the drill must include in its waiver application the following information:

- When and where the drill will take place,
- Identification of the amateur licensees expected to transmit amateur communications on behalf of their employer,
- Identification of the employer(s) on whose behalf the amateur(s) will be transmitting, and
- A brief description of the drill.

"It should be noted," Henderson said, "that the waiver request must be filed and acted upon *in advance* of the drill. The waiver must be actually granted by the Commission *before* the amateurs participate in the drill. It is not enough to apply -- the waiver must be granted first."

The public notice also emphasizes that in an *actual emergency*, the Part 97 rules "provide that an amateur station may use any means of radio communication at its disposal to provide essential communication needs in connection with the immediate safety of human life and the immediate protection of property when normal communications systems are not available. In those specific circumstances, rule waiver is not necessary."
