The View from the World

IARU, ITU, and Emergency Communication

If you were to ask most Amateur Radio operators what entity is responsible for granting privileges to use portions of the radio spectrum the answer would likely be their own national telecommunication authority. Here in the US, that would be the FCC, of course. However, that's only partially true. The ultimate authority for the use of the radio spectrum is the International Telecommunication Union (ITU). (http://www.itu.int/en/pages/default.aspx)Every radio amateur should understand what the ITU is and why its work and decisions are important.

There are three sectors in the ITU: Radio-communication (ITU-R), Development (ITU-D) and Standardization (ITU-T). The <u>International Amateur Radio Union</u> (IARU) is a Sector Member of both the ITU-R Sector and the ITU-D Sector. The IARU participates in both sectors by attending meetings that involve issues that may impact the amateur or the amateur-satellite services.

The ITU-R Sector is important for radiocommunication services, including the amateur and amateur-satellite services. Every four or five years the ITU holds a World

Radiocommunication Conference (WRC) to revise the international Radio Regulations.

ITU-D is where much of the ITU's work on disaster response takes place. The development arm of the ITU considers emergency telecommunications an integral part of its projects integrating telecommunications/information and communication technology in disaster predication, detection, and alerting. Emergency telecommunications play a critical role in the immediate aftermath of disasters by ensuring timely flow of vital information, which is much needed by government agencies and other humanitarian actors that are involved in rescue operations and providing medical assistance to the injured. IARU's task in the ITU-D Sector is to ensure that Amateur Radio's role in disaster communications is understood and appreciated by the ITU members. The ITU-D Sector also conducts a worldwide conference.

The ITU also sponsors regional and global exhibitions called TELECOMS. An ITU Telecom offers a global Information and Communication Technologies (ICT) community platform that gathers stakeholders from across the telecommunications/ICT sector to connect, collaborate and create the future ICT landscape. Forums and seminars are conducted at the Telecoms and IARU has participated in such forums, usually on topics related to emergency communications. - IARU E-Letter, January 2011 issue, International Amateur Radio Union (IARU) (http://www.iaru.org/) Secretary Rod Stafford, W6ROD [Here (http://www.itu.int/emergencytelecoms/index.html) is a good site for information on ITU activities relating to disaster response, mitigation, and the Tampere Convention - K1CE]

FCC Adds New Country to CEPT Reciprocal Agreement for Amateurs

On Monday, February 7, the FCC released a *Public Notice* (DA 11-221), adding a new country to the CEPT reciprocal operating arrangements for US citizens who hold an FCC-issued General, Advanced or Amateur Extra class Amateur Radio licenses. US hams may now operate in Montenegro, as well as the other countries covered by the European Conference of Postal and



Telecommunications Administrations (<u>CEPT</u>), subject to the regulations in force in the country visited, to operate in those countries.

US amateurs with a General class license will be granted CEPT Novice Radio Amateur License privileges, in accordance with <u>ECC Recommendation (05)06 (as amended)</u>. US amateurs holding an Advanced or Amateur Extra class license will be granted CEPT Radio Amateur License privileges in accordance with <u>CEPT Recommendation T/R 61-01 (as amended)</u>. US hams who will be traveling to CEPT countries can now go to these links and see if any new countries have been added to the reciprocal agreements.

While operating an amateur station in a CEPT country, the US amateur must have a copy of the Public Notice, proof of US citizenship and evidence of their FCC license in their possession. They must show these documents to proper authorities upon request.

CEPT countries participating in *ECC Recommendation* (05)06 as of February 7, 2011 are: Belgium, Croatia, Czech Republic, Denmark (including Greenland and the Faroe Islands), Germany, Hungary, Iceland, Liechtenstein, Luxembourg, Montenegro, Netherlands, Portugal, Romania, Slovak Republic, Slovenia and Switzerland.

CEPT countries participating in *CEPT Recommendation T/R 61-01* as of February 7, 2011 are: Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark (including Greenland and the Faroe Islands), Estonia, Finland, France (including Corsica, Guadeloupe, French Guyana, Martinique, St Bartholomew, St Pierre and Miquelon, St Martin, Reunion and its Dependencies, Mayotte, French Antarctica, French Polynesia and Clipperton, New Caledonia, and Wallis and Futuna), Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia, Moldova, Monaco, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine and the United Kingdom (including Northern Ireland, the Channel Islands and the Isle of Man).

The Foster Heights Elementary School in Bardstown, KY successfully contacted the International Space Station by Amateur Radio at 14:04 UTC, January 28. The QSO was made through K4SSA, the amateur station of the Kentucky Space Science Academy in Bardstown. Reports are that the audience totaled about 100, including an observer from the Kentucky Department of Education. Older students served as control operators for younger students.

Students have been studying frequency and wavelength, radio waves, electrical circuits, electricity and magnetism, the electromagnetic spectrum, how to measure voltage and resistance and the Global Positioning System. Also studied are satellite orbiting, Amateur Radio satellites, radio communications, Morse code, and crystal and shortwave radio.

The contact was made as part of the Amateur Radio on the International Space Station (ARISS) program. The program is sponsored by AMSAT, ARRL and NASA.

ARRL Field Day: 2011 Field Day Packet Available

It's that time of year again -- time to start gearing up for ARRL Field Day, June 25-26, 2011! ARRL's flagship operating event -- always held the fourth full weekend in June -- brings together new and experienced hams for 24 hours of operating fun.

Field Day packets are now <u>available for download</u> and include the complete rules (including a change for 2011), as well as other reference items such as forms, ARRL Section abbreviation list, entry submission instructions, a Frequently Asked Questions section, guidelines for getting bonus points, instructions for GOTA stations and a kit to publicize your event with the local press.

There is one rule change for 2011. Starting this year, all stations operating in Class A may use a free VHF station without increasing their operating category. This is designed to encourage more activity on the VHF bands, especially 6 and 2 meters, during the best sporadic-E season of the year.

We have also included in the FD packet a brief one-page flier with basic "What is Field Day" information that may be reproduced as a handout for your information table.
