My First Field Day

(Editor’s Note: This is an article from the Mich-A-Con RF published in July of 2006. I hope this will give all the new hams an insight on what to expect at Field Day!)


I am a relatively new HAM and have never experienced Field Day so when I caught on to the excitement that seemed to be going on with the planning and preparation at our club meeting, I decided I should check out this event. I learned from the meeting that Field Day was a great chance for everyone to get on the radio and learn what amateur radio is all about. I found out that I would be able to try out all kinds of communications and equipment that I only dream about owning and operating right now. Sounds like fun to me!

I had kind of a long day at work so I decided I would just “stop by” for a little while and see what all the guys were doing at our Field Day Event. I drove out to the park and pulled in.... looking for our set up area.... there it is... the 40 foot tower painted orange and white just calling everyone over to see what is going on. (Bob, KC8TWG told me I would be able to spot it!) I pulled up and parked noting that our club had set up an informational area under the pavilion...we also have a camper parked close by... and looking to the sky.... a bunch of antennas strung up in the trees. I understand Lee (N8LT) shoots a mean wrist rocket! Dennis, (K8SWX) even brought his new portable tri-pod setup too.

I strolled around the area and got the grand tour from the guys... the 40 foot tower was held in place by the camper! A plate was welded on the base of the tower and the camper is parked on the tower base... ingenuity at work. I next stopped by to talk to Tom (W8JWN). He showed me how RTTY works... here we are out in a park on battery power.... looking at a laptop hooked to a radio and getting a bulletin from W1AW! (See the actual bulletin in this newsletter.)

I am just getting comfortable on 2-meter and now I am going to be talking to people around the country? Lee (N8LT) came over and sat down with me and Bob (KD8DJN) to help us make some contacts. (I was happy Lee was there just to explain what all the buttons on this rig did!)

Lee showed me how to tune in a station and explained that when I hear the voice in a low tone they get my voice back as a high tone... thus they may not hear it at all because the low tones tend to be easier to hear. We fine tune a station and call out and make a contact!

Mike (N9NBN) took over with us after some time and we made many more contacts. I was amazed at the different ways the two guys make contacts. Lee likes to start at the top of the band and had us work down slowly tuning in a station... very effective. Mike had us tune faster... listening for the unique noise telling us we were near a station....bringing him in ... making contact and moving on... equally effective!

I did have to work again on Sunday morning so I did not stay the night.... as a matter of fact I suddenly realized that it was after midnight! **TIME FLIES WHEN YOUR HAVING FUN!**

I feel I learned more in the few hours I was able to participate in Field Day than I learned so far in this awesome hobby, and I thank all the club members for the work and planning that went into the event. I cannot wait for next year!!! I plan to stay up all night!

Bob Rogers, KB4PYP, EC of Davidson County, Tennessee, reports that on the weekend of May 1-2, the Office of Emergency Management (OEM) requested ARES® support, with 23 operators responding. Rogers stated that their "SKYWARN net was in standby for most of the day on Saturday as we watched the approaching storms." The OEM went into full activation and Rogers was called in to the "War Room" at 7 PM where he remained until early Sunday morning, when he had to return home to deal with water seeping into his bedroom. The SKYWARN net remained active until the front passed.

By 5 PM on Monday, a Red Cross shelter at Bellevue Middle School had requested an operator to support communications needs as there was a lack of cell phone service. Two operators established communication systems to support the shelter for emergency medical support. The Cross Point Community Church also requested ARES® assistance with distribution of supplies. Seven ARES® members deployed there.

On Tuesday, May 4, Red Cross requested radio communication support for a relocated disaster headquarters at the abandoned Skyline-Madison campus on Neeleys Bend, where 12 ARES® members participated. Communication was established between Red Cross-Charlotte Road office and the Disaster headquarters. A report was sent to the Cheatham County EMA.

Rogers said "while operating our net in support of the Red Cross shelter operation I received a call from an ARES® member in Cheatham County reporting that his neighborhood was isolated by flood waters. He and his neighbors were running out of fresh water and food supplies. I called K1KY on our MTEARS frequency and obtained the phone number of the Cheatham County EMA office and reported to them that 75 people were in need of fresh water and food supplies. Two helicopters were sent with supplies by the afternoon to those stranded people."

Oregon Dust Storms Response

In Oregon, three separate SKYWARN net activations occurred on May 3. The activations were requested by the National Weather Service in Pendleton. During the morning, the Pendleton office issued Dust Storm Warnings and High Wind Warnings for a large portion of its County Warning Area (CWA).

SKYWARN nets were activated on two-meter repeaters (one repeater in eastern Washington and two repeaters in eastern Oregon). Alan Polan, KE4TRR, maintained communications between NWS-Pendleton and the SKYWARN net control stations that operated the nets in Yakima County and in Deschutes County via the repeaters. Polan used EchoLink to communicate with the net in Deschutes County on the 147.360 MHz repeater via the Bend EchoLink node repeater and the Umatilla EchoLink node repeater.

Measured wind gusts of 40 to 77 MPH produced blowing dust in the Yakima Valley, the lower Columbia Basin, and the foothills of the Blue Mountains. In some susceptible areas, there were very dense clouds of blowing dust that dramatically reduced visibility to as low as zero feet. The high winds also caused damage to property from trees blown down and large fallen tree limbs. Power outages also occurred. Dense clouds of blowing dust caused two multiple vehicle pileups on I-84 in Umatilla County. Another vehicle pileup occurred around 9 AM due to blowing dust near the town of Harrah in Yakima County. Unfortunately, a wind surfer lost his life on the Columbia River near Boardman, Oregon due to the wind-driven high waves on the Columbia River. -- Alan Polan, KE4TRR, Pendleton, Oregon
