Overview of the Event / How Was DCS Used: Blocked & re-directed vehicle traffic at major intersection; provided weather conditions (temperature, wind, changes in humidity, any indications of "glowing" or smoke) every 15 minutes via amateur radio from east edge of fire zone to LA Co. Fire Department battalion chief at the St. John Fisher Church incident command post. Also, staffed Lomita station DCS room, Rancho Palos Verdes EOC, and both incident command posts. Had some staffing at ICP on stand-by for additional situations.

Suggestions / Issues: If more of our members had taken the traffic control class, we could have provided more assistance. The Station 17 DCS coordinator was on an approved vacation the week of the incident; our activation probably would have been an hour sooner had he been in town.

Equipment / Modes of Communications Used: 2-meter repeater, 220 simplex, and 440 repeater; HT radios owned by members, plus equipment at Station 17 and Rancho Palos Verdes EOC.
