2012 Annual Exercise – Guidelines for Ham Radio Operations

Pre Exercise all areas

Notify all DCS and PVAN operators of exercise schedule. This is the responsibility of the RPV/PVAN Chief Officer (Alan Soderberg this year).

Distribute updated incident forms to all PVAN and DCS operators with instructions on the use of the form.

Exercise

Activate ECC and RPV EOC.

All DCS and PVAN operators check in.

PVAN/DCS operators transmits the message to the ECC (PVAN/DCS operator will generate the test message).

ECC forwards message to RPV and Lomita EOC using automated form.

Lomita EOC sends test message to fire stations 53 and or 106.

Fire stations 53 and or 106 respond to selected area.

The RPV EOC generates a test message and transmits to the ECC via the internet.

The ECC then transmits the message to all DCS and PVAN operators in the field.

As a back up for communication between the ECC and RPV EOC, two Public Works handheld radios will be used to communicate between the ECC and RPV EOC. One radio will be placed at the Management Section in the EOC and one radio will be placed at the ECC.
