

Meeting Call to Order:

Mike/N5WCS made a motion to approve the prior month's (December 2020) meeting minutes. It was seconded by Russ/N8HAR. Motion passed.

Motion as written from the December 2020 meeting: Dale/K8RO made a motion to fund the additional repeater work required that we just discussed. For this, we would allocate another \$2000 to the Repeater Project. Knowing that it is not expected that we will need that amount (current estimate is \$1,793), this will give some headroom if there are some other unexpected items which come up. Motion was seconded by Mike/N5WCS.

This is the 2nd approval for this motion. No discussion was had. The motion passed with all in favor.

Old Business:

Gregg/N8GEO brought up a clarification that if you pay club dues through PayPal, you do not need to add 88 cents. It is free to do, so just sent \$20 for your dues.

Repeater Site Update

Ken/KD8RJN, worked on installing the 2nd electronic thermostat in the remaining repeater cabinet. He set the temperature at 68 degrees in both cabinets. Changed the attachment method of the insulation boards to Velcro. When taking off a panel, please take the Velcro off from the top of the cabinet. If you pull from the board side, it will rip away from the board and then become unusable.

Gregg/N8GEO stated that he took all the club paper awards and such and put them in plastic envelopes and in folders. This is now in a box labeled as "Archives". Let us know if you have anything that needs to be archived. Dale/K8RO brought up the idea of maybe getting a club shared drive to store electronic files. Gregg also said he will bring a "Log" book to the repeater site to log activities performed during visits.

New Business:

Winter Field Day (Jan. 30-31, 2021)

Dale/K8RO brought up that we do have the Tucker Senior Center reserved for Winter Field Day (WFD). Discussions were had about interest in attending in person at the building. Building rules are that only 10 can occupy the building at a time. It was noted that the WFD rules are allowing for an aggregated club score for those working at home and reporting that their score should be included with the LCARC group. A couple people stated that they could come. We would not want to bring any food. It was determined that Dale/K8RO would send out a feeler to the group email to see the level of interest.

Dale will send out the results to the group. But for sure, no matter what the building choice, all persons can still send in their aggregate scores for the group.

Dale/K8RO stated that he will create a Zoom meeting for the January board meeting. He will send out the link on the club reflector.

Dave/N8HUL informed the group that his father, David Stuben/W8WWP, became a Silent Key just after Thanksgiving last year. He also stated that he is going to put in a request with the FCC to take over his father's call sign.

Meeting Call to Order:

The LCARC Vice-President (Dale/K8RO) called the January 13th, 2021 LCARC board meeting to order at 7:30 PM. Meeting was held via ZOOM video conferencing.

We talked about the repeater additional funds which were approved at the January club meeting. The engineering company was informed of the approval and that they are cleared to proceed.

The Wi-Fi at the repeater site changed to a 24-hour maximum logon time period. Thus, we lose our internet connection 24 hours after we reset it. So, we turned off WiresX from the repeater site and moved it back to Dale/K8RO's shack. We will work with the Sterling Heights Fire Chief on getting a new connection.

Gregg/N8GEO stated that he believed that Russ/N8HAR has agreed to continue leading the club swap for 2021. He also state that he will still be researching if/when to restart the club's VE testing. He will call Cliff to see about restarting the VE sessions.

We will **not** be doing the Winter Field Day event from the Tucker Senior Center on Jan. 30-31. Everyone who operates is encouraged to send in your logs with a reference to the LCARC club. John/N8FYL will send out the exact name to put in that field as all of the entries need to have the exact same spelling.

It was decided to not hold the February club meeting at the Tucker Senior Center. It will be held on the repeater and Zoom. Dale/K8RO will work out the connection between Zoom and the repeater.

Talked about the remaining open positions for the board. We will need to get a person for Activities Manager and ARRL Liaison. Keith/W8KD offered to take over the position of ARRL Liaison.

Gregg/N8GEO recommended that we continue our annual donations of support for the Tucker Senior Center, and the Knights of Columbus. Recommended to give each the same amount as in the past, which is a \$100. The board agreed to continue the donations for each at \$100.

Gregg/N8GEO stated that a prior donation from Vince/WA8BIJ was made to the club to purchase (~\$100) a complete set of amateur radio license study materials to be put into the Clinton Township library for the public's use. The discussion was around the club matching this purchase which was our original goal from the beginning. It was agreed to query the library to see how often the books are being used (checked out). Further, we should wait a little longer to get a better view of our options moving forward.

We will have a WinLink presentation for the February club meeting.

Discussed the electrical usage at the repeater site. The last bill was \$75 and we need to review the temperature settings for the heater as they might be able to be lowered. This is a learning curve to find the right balance of the minimum required heat to keep the repeater cavities stable.

Meeting adjourned at 8:47pm.

FCC Issues Enforcement Advisory: Radio Users Reminded Not to Use Radios in Crimes

From the ARRL News

The FCC has released an Enforcement Advisory for licensees and operators across radio services.

[Complete text of FCC Enforcement Advisory follows.]

FCC ENFORCEMENT ADVISORY

DA 21-73

Released: January 17, 2021

WARNING: AMATEUR AND PERSONAL RADIO SERVICES LICENSEES AND OPERATORS MAY NOT USE RADIO EQUIPMENT TO COMMIT OR FACILITATE CRIMINAL ACTS

The Enforcement Bureau (Bureau) of the Federal Communications Commission issues this Enforcement Advisory to remind licensees in the Amateur Radio Service, as well as licensees and operators in the Personal Radio Services, that the Commission prohibits the use of radios in those services to commit or facilitate criminal acts.

The Bureau has become aware of discussions on social media platforms suggesting that certain radio services regulated by the Commission may be an alternative to social media platforms for groups to communicate and coordinate future activities. The Bureau recognizes that these services can be used for a wide range of permitted purposes, including speech that is protected under the First Amendment of the U.S. Constitution. Amateur and Personal Radio Services, however, may not be used to commit or facilitate crimes.

Specifically, the Bureau reminds amateur licensees that they are prohibited from transmitting "communications intended to facilitate a criminal act" or "messages encoded for the purpose of obscuring their meaning." 47 CFR § 97.113(a)(4).

Likewise, individuals operating radios in the Personal Radio Services, a category that includes Citizens Band radios, Family Radio Service walkie-talkies, and General Mobile Radio Service, are prohibited from using those radios "in connection with any activity which is against Federal, State or local law." 47 CFR § 95.333(a).

Individuals using radios in the Amateur or Personal Radio Services in this manner may be subject to severe penalties, including significant fines, seizure of the offending equipment, and, in some cases, criminal prosecution. 47 U.S.C. §§ 401, 501, 503, 510.

The QSO party will replicate the camaraderie and social experience of attending HamCation and provide a way to have fun on the radio since HamCation 2021 will not be held due to Covid-19.

The <u>HamCation QSO Party</u> will be a 12-hour QSO Party on the HamCation weekend of **February 13**, 2021 from 10:00 am EST Saturday to 10:00 pm EST Saturday. It will be a CW and SSB on-the-air operating event on 80, 40, 20, 15, and 10 Meters, during which anyone can work anyone!

Categories will be High Power (more than 100W output), Low Power (100W output or less) and QRP (5W output or less). All participants will be single operators, as there is no multi-operator category.

Information exchanged during a QSO will be NAME, STATE/PROVINCE or COUNTRY and the outside temperature at your QTH. We are including temperature at your QTH as a way of highlighting Orlando's mild February weather.

There will be special event stations to heighten the fun and challenge of participating in the QSO party. Nine Special Event 1x1 stations will be active that will spell out "HAMCATION". They are: K4H, W4A, K4M, W4C, N4A, K4T, W4I, K4O, W4N.

Scoring and Reporting:

- Each QSO will count as 1 point. Stations may be worked once on each band and mode.
- All entrants will report their scores on <u>www.3830Scores.com</u>.
- Submitting of logs is not required, nor will they be collected. Final results will be based on the information submitted to <u>3830Scores.com</u>.
- Guests operating at a station must use their own callsigns and submit their scores individually.

Plaques and Certificates:

- ICOM-sponsored Plaques will be issued to the top winner in each Category.
- All Participants who work all nine of the 1x1 HamCation stations will be able to download an ICOM-sponsored certificate for this special achievement.
- All participants will be able to download an ICOM-sponsored certificate for their participation in this historic event.

The annual <u>State QSO Party Challenge</u> recognizes all radio amateurs' participation in the U.S. State and Canadian Province QSO parties. It is open to any radio amateur who participates in any of the approved State QSO Parties (SQPs). Participants must simply submit their scores to 3830Scores.com to be included in the Challenge.

Participants are recognized for reaching five levels of achievement – Bronze, Silver, Gold, Platinum and Diamond. Using the submissions to 3830Scores.com , each callsign's cumulative score is calculated by totaling up his/her number of reported contacts and multiplying by the number of SQPs entered year-to-date. The use of the number of SQPs entered as a multiplier is to encourage radio amateurs to enter more state/province QSO parties. The use of the number of contacts as a metric is to encourage participants to operate longer in each SQP, increase the effectiveness of their station and improve their contesting skills. To qualify for an award level, the participant must have participated in at least two State QSO Parties. Each State QSO Party entry must have at least two QSOs. The first SQPs of most years are the Vermont, Minnesota and British Columbia QSO Parties on the first weekend of February.

The "Worked All QSO Parties" awards (WAQP) program is administered by the <u>State QSO Party Group</u> and it is sponsored by Icom America. These awards are available to all licensed amateur radio operators who meet the specified award requirements. To qualify, all applicants must adhere to the State QSO Party Challenge AND

WAQP program rules. Awards include certificates for participating in at least 50% of the SQP Challenge approved contests with a goal of participating in ALL of the approved contests. The WAQP requires that the operator submit a log with at least TWO valid contacts to the contest manager in addition to the 3830scores.com scores submission. <u>Click to view the WAQP Program Rules</u>

When I did it with Zip 48045 (the zip code for the Tucker Senior Center), and a "within 50 miles", it reported 13 sessions spanning the time until a year from now. I have included the blurb about then two in December to the right in the space normally filled with Upcoming Swap information.
