Possible Expansion For Repeater System

Keith—N1FTE is in the process of considering the possibility of expanding the PRG to the north. A plan is in the works to locate a 440 machine on a 300 ft tower owned by Citadel Broadcasting in the town of Litchfield. If everything works out, the new repeater would have coverage from Augusta to Portland and from Boothbay Harbor to Norway. This new machine would be linked full-time to the 444.600 repeater in Portland. Another inclusion may be a part-time link to a UHF repeater in Alfred, although no further information about this link is currently available. While most of the equipment details have been worked out, donations would be appreciated. At this time, link radios and 440 yagis are being sought. Mysterious "Noise" Being Investigated

Even though its appearance is usually brief and relatively uncommon, the mysterious "noise" that plagues the 444.600 machine continues to rear its ugly head. It is believed that this noise is being created by the mixing of multiple transmitters on top of One City Center. One weird observation of the "noise", is that it seems most prevalent in the presence of fog. While the effort to track down this pest is ongoing, a few things have been done to help alleviate the effect. The squelch has been turned up on the receiver and the kerchunk filter timer has been enabled for 250 ms. What does this mean for the user? You may notice slight sensitivity dampening with the receiver and also make sure you key up your rig for a good half second before you speak. We'll keep you updated on this most peculiar situation.
