

SPARC License Examination – May 2013

1. The Sterling Park Amateur Radio Club will conduct a VE Examination Session.
2. VE Examination Session Coordinator is Bill “Red” Free, N3TG, (Email: billfree@cox.net). The VE Examination Session Coordinator is also the POC for questions regarding the VE examination session.
3. The session will offer Tech, General and Extra exams by preregistration, first to club members and students in our class. Walk-ins are accepted on a limited basis. Total number of registrants is limited to 20 persons.
4. Date/Time: Sunday, 19 May 2013, 1300 – 1600. The exam will begin at 1 p.m. Please plan on arriving a few minutes early to see that your paperwork is in order.
5. Place: Office of the Sheriff, Eastern Loudoun Station, 46620 East Frederick Drive, Sterling, VA 20164.

8. The examination session will be conducted under the auspices of the ARRL VEC, IAW their processes and procedures.

ON EXAM DAY BRING THE FOLLOWING ITEMS:

1. A legal photo ID (driver’s license, passport, military ID).
2. When no photo ID is available, two forms of identification must be presented:
 - a. Non-photo ID/driver's license (some states still have them)
 - b. Birth certificate (must have the appropriate seal)
 - c. Social security card
 - d. Library card
 - e. Utility bill, bank statement or other business correspondence that specifically names the person; or a postmarked envelope addressed to the person at his or her current mailing address as it appears on the Form 605.
3. Students may bring any of the above items and/or a school ID, minor's work permit, report card, or a legal guardian may present a photo ID.
4. Bring your Social Security Number (SSN) or your FCC issued Federal Registration Number (FRN).
 - a. VEC’s are required by FCC to submit either your SSN or your FRN number with your license application form.
 - b. If you prefer not to give your SSN, then you may use your FCC issued FRN, if you have one.

5. If applicable, bring the original and a photocopy of your current Amateur Radio license and any Certificates of Successful Completion of Examination (CSCE) you may hold from previous exam sessions. The photocopy(s) will not be returned. VERY IMPORTANT if currently licensed.
6. Two number two pencils with erasers and a pen.
7. A calculator with the memory erased and formulas cleared is allowed. You may not bring any written notes or calculations into the exam session. Slide rules and logarithmic tables are acceptable, as long as they're free of notes and formulas. Cell phone must be silenced or turned off during the exam session. The phones' calculator function may not be used.
8. Bring a check, a money order or cash to cover the exam session fee. The ARRL VEC Exam Fee is \$15.00 (for one attempt at all three license elements). If a candidate fails an element at an exam session and wants to re-test for the same element, an additional fee will be required.
