THE AMATEUR



Exams: NCVEC Releases New General Class Question Pool



The new General class question pool is valid from July 1, 2011 through June 30, 2015.

The Question Pool
Committee (QPC) of the
National Conference of
Volunteer Examiner
Coordinators (NCVEC)
released the new General

class (Element 3) question pool on Tuesday, December 7. This new question pool -- including graphics and diagrams -- will become effective for all General class examinations administered on or after July 1, 2011; it will remain valid until June 30, 2015. The current General question pool that became effective July 1, 2007 will expire June 30, 2011. The new General pool contains 457 questions, from which 35 are selected for an Element 3 examination. The current Technician class question pool that was effective July 1, 2010 is valid through June 30, 2014. The current Amateur Extra class pool that was effective July 1, 2008 is valid until June 30, 2012.

More questions and a much more difficult question pool. Take advantage of the upcoming General class.

ON THE AIR: SADDLE UP FOR THE 2010 ARRL CW ROOKIE ROUNDUP!



The ARRL's newest on-the-air operating event is designed to help newly licensed amateurs build their operating skills on HF. Three Rookie Roundups -- one each for SSB, RTTY and CW -- are held each calendar year. The CW running of the Rookie Roundup will take place Sunday, December 19 from 1800 UTC through 2359 UTC. This is a contest specifically for those new to Amateur Radio, similar to the ARRL Novice Roundup that ran from 1952 until 1995. The Rookie Roundup combines a competitive event with some on-the-air training, bringing the fun and

Elmering of the old Novice Roundup into the 21st century. The Rookie Roundup is a single-operator event only. Stations are allowed a maximum of 100 W. Elmering is encouraged and use of spotting networks is allowed.

A Note from the Chief Executive Officer As we put this final issue of ARRL Spectrum Defense Matters for 2010 to bed, the end of the year is just a few weeks away. If you have not done so already I hope you will consider making a contribution to the Spectrum Defense Fund before flipping the calendar over to 2011. At this point we are well short of our 2010 goal for the Defense Fund. Please help us close the gap.

Will the ARRL cut back on its spectrum defense program if you don't contribute? Of course not. We will do what's necessary, no matter what. And we will continue to be careful stewards of the funds you make available to us, either through your membership dues or additional voluntary contributions. We don't spend money on this or any other program just because it's there.

So, why should you contribute? To tell us you agree that defending your access to the radio spectrum is as important to you as we

think it is. To be a part of a team that includes volunteers in dozens of countries who work through the IARU to protect and even expand your operating privileges. To relieve the stress on other parts of the ARRL's operating budget that may not be as key to the survival of Amateur Radio but that are essential to the richness of our experience and our ability to serve the public. Perhaps most important, to pay back the investment that previous generations of ARRL members made in securing the frequency privileges you enjoy today.

The coming year will see the completion of preparations for the next World Radio communication Conference, to be held in Geneva in January and February 2012. We hope for favorable outcomes on the agenda items we care about—but that will not be the end of it. This WRC will recommend an agenda for the next one, later in the decade. Will that agenda pose serious threats to amateur spectrum? Will it include the possibility of new or expanded amateur allocations? The answers will depend in part on work being done on your behalf today, in Geneva and within regional telecommunications organizations that cover the globe.


