Things never go the way you think they will. After many delays and even some derailments in our quest for a 2m repeater, Jim Sekinger, KC8HSD, agreed to transfer 146.835 to SAARA. Al Avnet, KB8AA, acquired Jim's equipment and has agreed to sell it to the club if we get approval to operate. OARC gave us conditional approval for a 2m repeater on 146.835. The 30-day comment period is almost up so we should have an answer soon.

In the meantime, we have begun work on two additional links to 146.805, the LAARA repeater -- one at Salem Community Hospital and one at Lowmiller Road. These will improve transmission and reception in Leetonia, Hanoverton, Kensington, and Minerva. Historically, we have had trouble communicating in these locations and they are all prone to flooding. We put a hold on our 440 activity while we wait to see how things turn out with the 2m. All of these purchases are being funded by the Homeland Security grant we received from the EMA.

Please let me know if you are interested in working in any capacity on the repeater project.

HEATHKIT'S AMATEUR RADIO PLANS TAKING SHAPE



Heathkit Educational Systems hopes to reenter the Amateur Radio market by the end of 2011. Back in August, Heathkit

announced its return to the kit business and actively solicited suggestions. The response from Amateur Radio operators convinced Heathkit to develop several Amateur Radio products.

"When we made the announcement on our web page about a month ago, we had no intention of entering the Amateur Radio kit market," Ernie Wake, Heathkit's Director of Sales and Marketing, told the ARRL. "The response was really overwhelming, exciting and scary. The scary part is that the brand name has so much loyalty that we don't want to disappoint the people who have such fond memories."

Wake said that Heathkit is presently working on developing a few Amateur Radio kits. "Initially, the kit line will include a few 'accessories,' like kits for a Dual Watt Meter, Antenna Tuners and the Cantenna," he explained. "Once we are a little more 'settled,' I think we will develop a QRP receiver. We won't rush to market just to get there. We want to develop a line of kits in the tradition of Heathkit. I'm hoping to have one or two kits by the end-of-the-year."

ARRL SEEKS TREASURER

Jim NcCobb, K1LU, is stepping down after 31 years as ARRL Treasurer. After more than 31 years of distinguished service to the ARRL as its volunteer Treasurer, Jim McCobb, K1LU, has decided to step down when his current term expires in January 2012. In consultation with and subject to the general supervision of the Administration and Finance Committee, provides for the investment and reinvestment of the surplus funds of the League in any bonds or stocks or other securities as would be selected by a trustee with the care of a prudent investor.

BILLS THAT MATTER IN CONGRESS

House Bill 81 is still in committee. It was referred to the House Committee on Energy and Commerce and then to the Sub-Committee on Communications and Technology.

Official Summary

On 1/5/2011 Representative Jackson Lee of TX introduced HB.81. On 2/1/2011, it was referred to the House Subcommittee on Communications and Technology. On 1/26/2011, Senator Joseph Lieberman introduced S.191, to the Senate.

The Amateur Radio Emergency Communications Enhancement Act of 2011 directs the Secretary of Homeland Security (DHS):

- (1) to study and report to Congress on the uses and capabilities of Amateur Radio Service communications in emergencies and disaster relief; and
- (2) in conducting the study, to utilize the expertise of stakeholder entities and organizations, including the amateur radio, emergency response, and disaster communications communities.

Senate Bill 191 was amended and has been placed on the Senate Legislative Calendar, General Orders. It is still awaiting consideration on the floor.

To direct the Department of Homeland Security to undertake a study on emergency communications.

A BILL

To direct the Department of Homeland Security to undertake a study on emergency communications.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the ``Amateur Radio Emergency Communications Enhancement Act of 2011".

SEC. 2. FINDINGS.

Congress finds the following:

- (1) Nearly 700,000 amateur radio operators in the United States are licensed by the Federal Communications Commission in the Amateur Radio Service.
- (2) Amateur Radio Service operators provide, on a volunteer basis, a valuable public service to their communities, their States, and to the Nation, especially in the area of national and international disaster communications.
- (3) Emergency and disaster relief communications services by volunteer Amateur Radio Service operators have consistently and reliably been provided before, during, and after floods, hurricanes, tornadoes, forest fires, earthquakes, blizzards, train accidents, chemical spills and other disasters. These communications services include services in connection with significant incidents, such as--
 - (A) hurricanes Katrina, Rita, Hugo, and Andrew;
- (B) the relief effort at the World Trade Center and the Pentagon following the 2001 terrorist attacks; and
 - (C) the Oklahoma City bombing in April 1995.
- (4) Amateur Radio Service has formal agreements for the provision of volunteer emergency communications activities with the Department of Homeland Security, the Federal Emergency Management Agency, the National Weather Service, the National Communications System, and the Association of Public Safety Communications Officials, as well as with disaster relief organizations, including the American National Red Cross and the Salvation Army.
- (5) Section 1 of the joint resolution entitled ``Joint Resolution to recognize the achievements of radio amateurs, and to establish support for such amateurs as national policy", approved October 22, 1994 (Public Law 103-408), included a finding that stated: ``Reasonable accommodation should be made for the effective operation of amateur radio from residences, private vehicles and public areas, and the regulation at all levels of government should facilitate and encourage amateur radio operations as a public benefit."
- (6) Section 1805(c) of the Homeland Security Act of 2002 (6 U.S.C. 757(c)) directs the Regional Emergency Communications Coordinating Working Group of the Department of Homeland Security to coordinate their activities with ham and amateur radio operators among the 11 other categories of emergency organizations such as ambulance services, law enforcement, and others.
- (7) Amateur Radio Service, at no cost to taxpayers, provides a fertile ground for technical self-training in modern

telecommunications, electronic technology, and emergency communications techniques and protocols.

- (8) There is a strong Federal interest in the effective performance of Amateur Radio Service stations, and that
 - performance must be given--
 - (A) support at all levels of government; and
- (B) protection against unreasonable regulation and impediments to the provision of the valuable

communications provided by such stations.

SEC. 3. STUDY OF ENHANCED USES OF AMATEUR RADIO IN EMERGENCY AND DISASTER RELIEF COMMUNICATION AND FOR RELIEF OF RESTRICTIONS.

- (a) Authority.--Not later than 180 days after the date of enactment of this Act, the Secretary of Homeland Security shall--
 - (1) undertake a study on the uses and capabilities of Amateur Radio Service communications in emergencies and disaster relief; and
 - (2) submit a report on the findings of the Secretary to Congress.
 - (b) Scope of the Study.--The study required by this section shall--
 - (1) include a review of the importance of amateur radio emergency communications in furtherance of homeland security missions relating to disasters, severe weather, and other threats to lives and property in the United States, as well as recommendations for--
 - (A) enhancements in the voluntary deployment of amateur radio licensees in disaster and emergency communications and disaster relief efforts; and
 - (B) improved integration of amateur radio operators in planning and furtherance of the Department of Homeland Security initiatives; and
 - (2)(A) identify impediments to enhanced Amateur Radio Service communications, such as the effects of unreasonable or unnecessary private land use regulations on residential antenna installations: and
 - (B) make recommendations regarding such impediments for consideration by other Federal departments, agencies, and Congress.
- (c) Use of Expertise and Information.--In conducting the study required by this section, the Secretary of Homeland Security shall utilize the expertise of stakeholder entities and organizations, including the amateur radio, emergency response, and disaster communications communities.
