Gentlemen:

Reference is made to the information submitted by you for use in determining your status for Federal income tax purposes.

The information submitted shows that you were incorporated January 16, 1947 under the laws of the State of California and are the continuation of a voluntary association which was in existence from 1921 to January 16, 1947. You were formed to encourage the study of the science of radio communication and to coordinate anateur radio activities. Your activities consist of holding periodical meetings to exchange ideas for the improvement of amateur radio communications and to discuss technical matters relating to radio communication. Your income is derived from membership dues, and expenditures are shown to have been made by you for dinners, rent, door prizes, stationery and postage, insurance, and for membership dues in the Amateur Radio Relay League. You state that no part of your net income inures to the benefit of any private individual.

Section 101(6) of the Internal Revenue Code provides for the exemption of:

"Corporations, and any community chest, fund, or foundation, organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of oruelty to children or animals, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting, to influence legislation."

Corresponding provisions of prior revenue acts contain similar provisions.

Inasmuch as you are not both organized and operated exclusively for one or more of the above-mentioned purposes, it follows that you can not be held exempt under the provisions of section 101(6) of the Internal Revenue Code and corresponding provisions of prior revenue acts. 2 - Santa Clara County Amateur Radio Association

However, it is the opinion of this office that you are exempt from Federal income tax under the provisions of section 101(9) of the Internal Revenue Code and corresponding provisions of prior revenue acts.

Accordingly, you will not be required to file Federal income tax returns unless you change the character of your organization, the purposes for which you were organized, or your method of operation. Any such changes should be reported immediately to the collector of internal revenue for your district in order that their effect upon your exempt status may be determined.

You will be required, however, to continue to file annually an information return, Form 990, with the collector of internal revenue for your district so long as this exemption remains in effect. This form may be obtained from the collector and is required to be filed on or before the fifteenth day of the fifth month following the close of your annual accounting period.

The collector of internal revenue for your district is being advised of this action.

The Federal Communications Commission on April 17, 1946, directed in Order No. 130-F that amateur station licenses which were validated by Order No. 130 dated November 9, 1945, and Order No. 130-A dated November 14, 1945, for 6 months, commencing November 15, 1945 and ending May 16, 1946, be extended for the duration of the term of the amateur operator license held by the licensee of the station. Under the provisions of existing orders the terms of certain amateur operator licenses have been extended so that they will expire between December 8, 1946 and December 7, 1947. Order No. 130-F extends the term of the station license to coincide with the term of the operator license, and since both will expire at the same time, the amateurs affected need not apply for renewal of station and operator license until the expiration date of the operator license. Applications for the renewal of an amateur station license and operator license are required to be filed not more than 120 days prior to date of expiration of the license and not later than the date of expiration.
