The other thing slowing us down is waiting for Mr. Waltrip to get his men in there to do the work we have asked, i.e. remove and cap toilets and sinks and install two electrical outlets in the radio room. I have asked him before to let me know what we can do for them if they cannot do it for themselves due to a manpower shortage. Mr. Waltrip has not done this either. We cannot do anything in those rooms until he gives us the okay, because of building code restrictions. He has removed all of the stalls in the bathroom/storage room. I have sent e-mails and phone calls to him about this matter. He responds but does not do what he says he will do. I am very frustrated by the slowness of this whole process. SCCARA is grateful for the opportunity to use these rooms, but we need to get moving and get things done. It has taken far too long. I don't know what else to do at this point. Mr Waltrip had promised that we would be able to give up our paid storage unit by now. I'm glad I have not given the present storage unit office a notice that we will vacate by the end of September. That would leave a lot more stuff to deal with.

We have another problem related to the radio room. The John Tanner estate has given us a deadline of Sept 4, to have all of John's stuff off of the property, so the executor and the realtor can ready it for sale. I was hoping that the store room over at the school would be ready by now, so that we could move all of John's things to the school. We can always sort through things at a later date. Right now, we have to get things off of John's property.

We have found a buyer for John's large tower. That tower will be moved within the next two weeks, once SCCARA accepts the offer.

There has not been much done over at Regional Medical Center radio room. Wally is in charge of that project, as he is repeater chairman. He will tend to that once the Hammer school situation is going forward. I will insist that things start moving over there by September, if not sooner. (Note - they also seem to be getting ready to do some roofing at the school.)

All we can do now is hang in there. I'm not happy with the way things are going and I feel most of you are not happy either. If you have any suggestions that will work, please let me know. We can't do anything if they won't let us, contract or no contract.

I would like to hear a few more people check in at the Monday night nets. Even if you can't or don't come to the meetings, you can be an active participant in the club by checking in at the net. It doesn't take that much time. Let's hear from you on Monday nights! Wally says the 10 M net check ins have been dismal lately, remember 28.385 8:00 PM Thursdays.

Remember, election of officers is coming up soon. Think about your officers for next year and nominate them.

We may have a special speaker for the September meeting. He will be coming to us from England. We will know more about this at the August meeting. If we can get this gentleman to be our speaker, I will give notice to other radio clubs in the area to increase the audience when he speaker at our club meeting.

SB-1714 Passes Legislature

SB-1714 finally worked its way through the California Legislature on Monday, Aug. 22. On that date the Senate agreed to the several amendments made after initially approving it almost three months ago. The Senate vote followed the Assembly's acceptance of SB- 1714 on Friday, Aug. 18. The bill is now on its way to Governor Gray Davis. We now must consider very seriously what will happen when the bill reaches the Governor's desk.

Governor Gray Davis, as we all know, pays close attention to the cost of legislation, and rightly so. The Senate Appropriations Committee estimated that the study called for by SB-1714 will cost the taxpayers some \$70,000 to \$100,000, and the Assembly analyst accepted that figure. Although that cost is small in the context of the overall state budget, it's large enough to attract notice. We should therefore try very hard to convince the Governor that it is in the best interests of the citizens of California for him to sign SB-1714.

We need letters!

Sample letter

(Note that any letter incorporating these ideas, particularly addressing the issue that it is going to cost the State some money to study this, and it is money well spent, should be helpful. State analysts estimate the cost of the studies required by the legislation at \$70,000 to \$100,000.)

Dear Governor Davis:

I am writing to you to urge your support of SB-1714, a bill designed to provide some relief to amateur radio operators who require antenna structures to pursue their interest in communications.

The proliferation of cellular telephones has caused concern in many communities about the appearance of commercial antenna structures. In attempting to deal with this, municipal governments have tended to lump together all antennas, ignoring the roles the Amateur Radio service has traditionally played in providing public service and backup emergency communications in support of the Governor's Office of Emergency Services and of municipal emergency service organizations.

I believe that this legislation addresses both the concerns of municipalities in maintaining for everyone a reasonable quality of life and the Amateur Radio service in maintaining its ability to communicate and to play the roles it always has.

The provision of the legislation for study and report by the Governor's Office of Policy and Research should ensure that every interest will be considered and that an ultimate result in the best interests of all Californians will be achieved. The funds required for the study, considering the enormous value that the State and municipalities have received from being able to call on Amateur licensees to provide equipment and volunteer hours in emergencies, is money well spent to preserve a valuable asset.

Please sign SB-1714 into law.

RF Safety Regulations Fully In Force

The time has come. Effective September 1, every US amateur will be required to be fully compliant with the FCC's RF Safety regulations. For many, perhaps most US hams, compliance means only reading and understanding the regulations themselves. Others, however, effective September 1 are required not only to read and understand the regulations, but must also perform a technical evaluation of their station in order to determine that their stations are compliant with the new regulations. Compliance isn't difficult in most cases; the vast majority of amateurs will find it to be a "slam dunk." However, compliance with the regulations is NOT optional. Even aside from the fact that

every US amateur is required to follow the RF safety regulations, in my opinion amateurs owe it to themselves, their families, their neighbors, and the general public to follow the regulations to the letter. Those who do not clearly understand their obligations can find a complete description of the rules on the ARRL web site, as well as tools to make your station evaluation quite painless. Text of SB-1714 as Amended:

SECTION 1. Section 65850.3 is added to the Government Code, to read:

65850.3. Any ordinance adopted by the legislative body of a city or county that regulates amateur radio station antenna structures shall not preclude amateur radio service communications. Any ordinance that regulates amateur radio station antenna structures shall reasonably accommodate amateur radio service communications and shall constitute the minimum practicable regulation to accomplish the legitimate purpose of the city or county.

SEC. 2. On or before July 1, 2001, the Director of the Office of Planning and Research shall do all of the following:

(a) Prepare and publish a technical assistance bulletin suitable for use by local officials and planners in the preparation and adoption of local ordinances that regulate the placement, screening, and height of amateur radio service antennas. In preparing this bulletin, the director shall consult with individuals

and groups with experience in amateur radio service communications and land use regulation, including, but not limited to, the American Radio Relay League, the American Planning Association, the League of California Cities, the California State Association of Counties, and the Federal Communications Commission.

(b) Prepare and publish a model ordinance suitable for adoption by the legislative bodies of cities and counties for the regulation of the placement, screening, and height of amateur radio service antennas. In preparing this model ordinance, the director shall consult with individuals and groups with experience in amateur radio service communications and land use regulation, including, but not limited to, those groups listed in subdivision (a).

c) Report to the Legislature and the Governor regarding any recommendations for changes to the state statutes regarding state or local regulation of amateur radio service antennas.
