
Three Director seats are up for election: Director Clark Murphy, KE6KXO (SK) Director James Rustermier, KI6ZSK Director (open)



More Than Seven Dirty Words

The FCC has launched a new podcast series, "More Than Seven Dirty Words" (https://www.fcc.gov/podcast). The new media outlet will feature interviews with FCC officials and staff in

addition to others in the communications arena. The podcast aims "to share untold stories, explain important policy issues, and maybe even do the impossible -- make telecom interesting," the FCC said in announcing the new media outlet. "One of the wonderful things about the digital age is the many ways to share information, so we're excited to launch this new FCC podcast,' said FCC Chairman Ajit Pai, who shares some banter in an introductory segment with program host, FCC Policy Advisor Evan Swarztrauber. Guests will share their personal stories behind FCC news headlines and break down various telecommunications related issues. The podcast's title is drawn from the first episode's introductory discussion, which touches on the court fight over George Carlin's "Seven Dirty Words" and the fallout from the 2004 Super Bowl halftime show. The first podcast, "Puerto Rico se Levanta," runs 22 minutes and focuses on the FCC's response to the 2017 Puerto Rico hurricane disaster. Each episode will be available at fcc.gov, as well as on iTunes and Google Play.

Brazil radio amateurs are gaining three bands

Brazilian telecoms regulator Anatel has released an updated frequency allocation schedule that will make a 60-meter band available to Brazilian radio amateurs. The secondary allocation of 5,351.5 to 5,366.5 kHz with 25 W EIRP will be open for Class A licensees in Brazil. Radio amateurs there also will gain access to the new 2200- and 630-meter bands, at 1 W EIRP and 5 W EIRP, respectively. Not only that, but Brazil's 160- and 80-meter primary amateur allocations are being expanded to 1.8 - 2.0 MHz and 3.5 - 4.0 MHz, respectively. The segments 1.85 - 2.0 MHz and 3.8 - 4.0 MHz will be open only to Class A licensees. The new bands and allocations are expected to become available on November 26.

FCC Grants ARRL Temporary Waiver Request to Permit PACTOR 4 Use in Hurricane Relief

The FCC has granted an ARRL request for a temporary waiver of §97.307(f) of the FCC's Amateur Service rules to permit the use of PACTOR 4 digital mode for Amateur Radio communication within the continental US related to Hurricane Florence relief. A formal order addressing the request for a 30-day waiver was released on September 17.

§97.307(f) of the Commission's Rules limits the digital data emissions of amateur stations operating below 28 MHz to a symbol rate not to exceed 300 baud, and in the 10-meter band (28.0 - 28.3 MHz) to a symbol rate not to exceed 1,200 baud, thus precluding the use of PACTOR 4.

PACTOR 4 is a data protocol that permits relatively high-speed data transmission in the HF bands, and many amateur stations active in emergency communications preparedness are capable of using PACTOR 4, which was used to great advantage, pursuant to FCC temporary waivers, in Hurricane Maria relief efforts, and, more recently in preparing for typhoon relief communications in Hawaii.

ARRL dispatched PACTOR radio modems with PACTOR 3 and PACTOR 4 capabilities to the Carolinas.

ARRL's request proposed limiting the use of PACTOR 4 to radio

amateurs in the continental US who are directly involved with the hurricane relief efforts involving the US mainland. "This request is without prejudice to the resolution of Docket 16-239 (the so-called "symbol rate" proceeding), which is presently pending and addresses the rule section discussed herein," ARRL General Counsel Chris Imlay, W3KD, wrote in submitting the request.

In the September 17 formal Order, the FCC noted that the 'symbol rate' proceeding is currently pending, "but there is consensus among submitted comments for eliminating the symbol rate limits." (https://docs.fcc.gov/public/attachments/DA-18-956A1.pdf)

In response to a 2013 ARRL Petition for Rule Making RM-11708, (https://www.fcc.gov/ecfs/filing/6017477458/document/752095 8815), the FCC proposed in 2016 to revise the Part 97 rules (https://apps.fcc.gov/edocs_public/attachmatch/FCC-16-96A1.pdf) and invited comments. ARRL had asked the FCC to amend the Part 97 rules to delete the symbol rate limits in §97.307(f) and replace them with a maximum bandwidth for data emissions of 2.8 kHz on amateur frequencies below 29.7 MHz.


