



# New Low-Power Limit for ARRL HF Contests Goes into Effect January 1, 2022

ARRL has set a new standard for what counts as low power for ARRL-sponsored HF contests. The new limit is 100 W, which is down from the 150 W limit that has been permitted in some events, including the ARRL November Sweepstakes.

With the exception of ARRL Field Day, this change goes into effect on January 1, 2022, for all ARRL-sponsored HF contests, as well as the IARU HF World Championship.

This change has been implemented to standardize low-power categories within the contesting community. However, on a more practical level, the typical modern HF transceiver has a maximum power output of 100 W.

# A Growing Number of Operators Are Completing WAS on 222 MHz

Until very recently, it had been some 35 years since the most recent Worked All States (WAS) was awarded on 1.25 meters. Former ARRL President Joel Harrison, W5ZN, in Arkansas; Marshall Williams, K5QE, in Texas, and John Swiniarski, K1OR, in New Hampshire stand at the vanguard of a new generation of VHF enthusiasts aiming at earning the Worked All States (WAS) Award on 222 MHz (1.25 meters). Harrison was issued WAS #11 on 1.25 meters on December 27, 2021, while Williams was issued WAS #12 on January 11, 2022, and Swiniarski was issued WAS #13 on January 12.

"Since the 1980s, a combination of the old guard and a new group have been pursuing this quest," ARRL Radiosport Manager Bart Jahnke, W9JJ, said. Harrison worked Tom Worthington, NH6Y, in Hawaii, for his 50th state, while Williams followed close behind, working James Colson, K7KQA, operating EME portable from Oregon, for his 50th state.

Jahnke said the honor of being the very first 1.25-meter WAS recipient went to Terry Van Benschoten, W0VB, in 1983, earning what was then "220 MHz WAS." Nine others joined the ranks between then and 1987.

"In recent years, several stations have been working hard toward joining the ranks of WAS holders on this ITU Region 2-only band," Jahnke said. Other stations that have recently worked 50 states and waiting on the last confirmations include K1WHS and WA4NJP. N9HF and N0AKC are nipping at their heels. No activity on 1.25 meters was available in some of the last few needed states, and portable operations by KA6U, KB7Q, K7KQA, and N7GP made contacts possible.

"Congratulations to [the recent award recipients], and to all those VHF+ state chasers -- and to the many activators of rare 222 MHz states -- on their achievements in this continuing quest for 222 MHz Worked All States," Jahnke said.

In 1988, when the FCC reallocated the lower portion (220 - 222 MHz) of the 1.25-meter band to the federal government and Land Mobile Service, amateur activity on the band stalled, while adjustments were made to equipment and band plans. During the past several years, so-called "weak-signal" activity, especially EME, has increased on the band with a renewed interest from existing and new band users.

Harrison, Charlie Betz, N0AKC, and Al Ward, W5LUA, have written an article, "The Quest for 222 MHz WAS," which contains tables, maps, and details on the propagation, locations, and equipment that made their operations possible. Ward was among the initial 10 WAS recipients for 1.25 meters. Plans call for the paper to be presented and published by the Central States VHF Society Conference in La Crosse, Wisconsin, July 29 - 30 and at other conferences. Harrison said, the paper also has "lots of history in it about the 1.25-meter band, the original 10, and the group now in the hunt along with ongoing 'roving' efforts of KB7Q and KA6U."

# Amateur Portion of the 9 cm Band Reduced

Amateur operation in the 3.45 - 3.5 GHz of 9 centimeters must cease by April 14, 2022. Secondary operations will be permitted to continue indefinitely in the remainder of the band, 3.3 - 3.45GHz, pending future FCC proceedings. On January 14 the FCC released DA 22-39, which announces the results of Auction 110 for the 3.45 - 3.55 GHz band. Release of this notice triggered FCC rules adopted last year requiring that amateur radio operations between 3.45 GHz and 3.5 GHz cease within 90 days of the public notice. In October 2021, ARRL President Rick Roderick, K5UR, urged Congress to direct the FCC to preserve Amateur Radio's secondary use of the 3 GHz band in a written statement responding to H.R. 5378, the Spectrum Innovation Act of 2021, before the US House Commerce Communications and Technology Subcommittee. ### **ANNOUNCEMENTS:**

Gary Mitchell, WB6YRU Newsletter Editor WB6YRU: two things:

Gary Mitchell WB6YRU will send the roster to Barbara shortly. Ideally, everyone would have renewed their membership by now. So far, only 17 out of 41 have renewed. Surprisingly, most of the Board has not renewed.

Treasurer: Per Gregg Lane KF6FNA via email from Goetz Brandt K6GKB: Checking \$11,107.24, Cash on hand \$216.04, Total \$11,323.28. Goetz is no longer able continue as treasurer and wants someone else to take over.

Newsletter: Gary WB6YRU, Regarding the roster, 17 of 40 members have renewed. Many officers have not renewed either. STATION TRUSTEE: Don Village K6PBQ: the station at the Red Cross will be open Saturday, Jan. 29 from 10AM to 4PM for anyone who wants to try out a different radio than theirs.

## STANDING COMMITTEE:

Newsletter: Gary WB6YRU: There's good news and bad news. Good news: We're getting notices more often about the club station from Don K6PBQ. Bad news: still nothing has been submitted about club elections. It's important to keep in mind that until in-person meetings resume, the SCCARA-GRAM plays a much bigger role. Gary WB6YRU said that he sure would like to see club officials make better use of it.

BBS: Sysop's report: Gary WB6YRU: Nothing new to report. Things are running normally.

Repeater Chairman's report: Wally KA6YMD Things are running normally. He is testing it daily on his walks in the areas of his house.

Website: Wally KA6YMD: Data is updated as soon as the data comes in to him. A little repair work was done.

Special Committee(s)

Membership: Chairman, Ben Shuford KK6CCU: Ben reported that he can wait until the pandemic is over or we can get volunteers to join the committee here and now. Ben requested help from the membership. Gregg KF6FNA asked if anyone wanted to join the committee. John W6JPP, said that he would be able to help in a month from now. Ben thanked John for the help. He also commented that there needs to be more than that to be on the committee. This is a little disappointing, and he will have to work on that.

## OLD BUSINESS:

Gregg KF6FNA: Regarding elections: Wally was collecting the ballots and should have a report.

Wally KA6YMD: I don't Have the numbers here, but more than half of the membership ballots have been sent in. to make the vote legal. There was one negative vote against the slate, and all other votes were in favor. All candidates were elected. Next month he'll have the formal tabulation.

Gregg KF6FNA: Antenna work on the roof of the Red Cross is progressing, but is on hold because of the pandemic. The antenna trailer to get work done soon, but it has been put on hold for now due to the pandemic.

Lou WA6QYS: The status for a room at Kaiser Santa Clara is

John W6JPP: Reported that there is a possibility that we could have a meeting room at the American Legion Hall on Minnesota near Meridian Ave. The room can hold 45 people at once. This would be a back up plan to the hospital meeting room. Barbara KD6QEI will check with George Williams at the Red Cross to see if meeting rooms are available in the evening.

### NEW BUSINESS

The treasurer, Goetz K6KGB: He has asked to be relieved of his position as treasurer due to health reasons. If there is anyone who is interested in being our treasurer, please let one of the officers know ASAP. Gregg KF6FNA can sign checks and can fill in as needed. Goetz is willing to do what he can until a new treasurer, but someone needs to step up. The Quicken program that is on the secretary's computer can run financial data just fine, and can be imported to any other computer. Gary WB6YRU suggested Wally KA6YMD for the position of treasurer. Wally said no, as he has quite enough to do already. Wally suggested that he could pick up the mail at the St. James post office and give it to the secretary who can send money items to the treasurer. Wally agreed to get the mail from the St. James post office.

Anything Else? Don K6PBQ made a motion to request the purchase a 24 hour clock, an MFJ 108B, with local time and universal time on it for the club station, for around \$30.00 to \$35.00. Motion seconded by Ned AC6YY.

Gregg KF6FNA: The motion passed.


