FCC Initiates Broad Inquiry on Rules to Delete or Amend

In a <u>Public Notice</u> titled "In Re: Delete, Delete," issued on March 12, 2025, the FCC is soliciting public input on any FCC rules in any service that members of the public believe should be deleted or modified "for the purpose of alleviating unnecessary regulatory burdens." This is the latest in a series of similar proceedings going back to 1996, when the Communications Act



was amended to require the FCC to periodically review its rules. https://www.fcc.gov/document/fcc-opens-re-delete-delete-delete-docket

ARRL, through its Executive Committee and FCC Counsel, is conducting a review of the provisions in Part 97 and other related rules that apply to radio amateurs. ARRL is also soliciting feedback from its members. Rules identified as outmoded, obsolete, or that for other reasons should be repealed or modified, will be included in ARRL filing to be submitted no later than the FCC deadline of April 11, 2025. The deadline for filing reply comments is April 28, 2025.

It is expected that the Commission will incorporate suggestions that it decides worthy of its consideration in a future Notice of Proposed Rulemaking (NPRM) that could be issued later this year. There will then be an opportunity for public comment on the specific rules that the Commission proposes for deletion or modification.

Announcements Gregg KF6FNA:

- Board of Directors Meeting will be February 17, 2025 on the 2 meter repeater immediately following our Monday Night Net.
- SCCARA's club station at the Red Cross is scheduled to be open the last Saturday of the month. For this month, that will be February 22.
- First flea market of the season will be Sunday, March 9, 2025 hosted by our friends at SVECS. Volunteers are needed.
- SCCARA will host the flea market on June 8, 2025. Please mark your calendars.
- SCCARA's 10 meter net is every Thursday at 8:00 p.m. on 28.385 MHz USB.
- Our 2 meter net is every Monday (except our meeting night on the 2nd Monday) on the W5UU repeater.
- Our next General Meeting will be March 10th. Doug will arrange to have our projector and show a short video on how to make your own PowerPole connectors followed by a hands-on opportunity to add connectors to your cables. The club will have tools, people with experience, and limited quantities of connector assemblies and some wire available (connectors and wire for purchase at the club's cost). Bring your cables and we'll do our best to help you add PowerPole connectors.
- Our SCCARA-GRAM editor asks for content to be submitted as soon as possible and the last Monday of the month at the latest. For this month, the last Monday is February 24.
- Field Day is June 28th and 29th this year. We will be operating from the club station here at the Red Cross. We hope to have a second beam up and in operation by that time. We'll be operating at least three radios concurrently. The club gets extra points for contacts made by operators under 18 years old, and we would love to have you bring kids, grandkids, etc. to operate. Licensed or unlicensed we'll find a way for everyone to participate.

Gregg turned the meeting over to Ned Tufekcic AC6YY for an interesting discussion of the (tr)uSDX radio.

The design was a collaboration between PE1NNZ and DL2MAN initially intended to be user assembled from a kit. Ned purchased a ready-made version online. Very popular with QRP operators outdoors. It is an all HF band / all mode transceiver with

all functions of a large radio, tuner, speaker, display, etc. in a tiny form that can fit in a shirt pocket. Ned made his own cables to interface to the computer for FT8. Powered from USB port, output power was 1/2 Watt. At 12v, >5 watt output. With 1/2 Watt output power, he made numerous FT8 contacts. Built in microphone and speaker performance not equal to a full size radio. Requires a resonant antenna to use stand-alone or a separate tuner.

The meeting was adjourned at approximately 8:40 p.m.

Pursuant to due notice, the Board of Directors of the Santa Clara County Amateur Radio Association met in normal session over the air on the W6UU 2 Meter Repeater. The meeting was called to order at 7:44 p.m. PST by President Gregg Lane, KF6FNA, as Chairman.

Roll call was taken.

Officers:

President Gregg Lane KF6FNA, Treasurer Ned Tufekcic AC66YY, and Secretary Doug Owens N6DPO were present. Directors: Lou Steirer WA6QYS, Wally Britten KA6YMD, Gary Mitchell WB6YRU, Janet Motha KF6PUQ, John Parks W6JPP, and Don Village K6PBQ were present.

A quorum of voting Board members were in attendance.

Gregg KF6FNA made the following announcements:

- Articles for the March SCCARA-GRAM should be submitted by the 24th of February
- The March general meeting will be on March 10th and will cover installing PowerPole connectors
- SCCARA's club station at the American Red Cross is open the last Saturday of each month. Members and guests can confirm operation on the W6UU 2 meter repeater.
- The first electronics flea market of 2025 will be on March 9th and hosted by our friends at SVECs. Volunteers are needed. Please contract Gregg KF6FNA or Lou WA6QYS if you are able to help.

President's Report, Gregg Lane KF6FNA:

The meeting minutes for January general and board meetings were published. Requested corrections or additions. None were offered. Minutes declared approved by acclimation.

Treasurer's Report, Ned AC6YY: Current cash and checking balance is \$11,974.20

Station Trustee's Report, Don K6PBQ:

Club station at the Red Cross is scheduled to be open the last Saturday of the month. We have been opening more frequently and encourage those interested to monitor the W6UU 2-meter repeater for announcements. The station provides back up operators and equipment to the Red Cross in the even of an emergency and they appreciate our higher activity level.

Editor's Report, Gary WB6YRU:

Not very much content is submitted for the SCCARA-GRAM.

There should have be renewal reminders sent by the Secretary and what Gary described as a grace period was ending in two weeks.

Doug N6DPO indicated that he did not send them and that unless Truman had sent them before leaving office they still needed to go out. Doug said he would take care of this.

BBS Report, Gary WB6YRU:

Gary reported that one of the other BBS system managers reported that our mail forwarding was working well since we installed the new Raspberry Pi computer.

Doug NôDPO asked what type of uptime we are seeing, are we still seeing the problem with the BBS going down or are those problems behind us with the corrective actions you have taken? Gary indicated that the problem of the system not being responsive has not been fully resolved but he has a work around in place so that if he knows it is not behaving, he can reset a couple of things. Gary asked whether anyone has checked in or taken a look at it? Paul KK6HWN reported the BBS was up and running but was down for a couple of days last week.

Doug N6DPO expressed concern about the BBS being down since it is promoted on our website and asked if there was an automated way to check when it is down.

Gary reported the problems began with the transition to the Raspberry Pi and indicated that the software seems to have a but hear and there but that as soon as we notice, we restart it. As for checking it, Gary reported any one of us can check it externally. Paul KK6HWN asked: If we find the BBS down, can we send Gary an email and he will reset it? Gary confirmed that he would appreciate any reports.

Repeater Report, Gregg KF6FNA:

Thank you Gotz N6GKB for working to get our coordination updated with NARCC

W6JPP stated the repeater was powered down and recommended that Ned AC6YY get us access since the County now owned the hospital.

Ned reported that the hospital was not yet owned by the County yet but said he would be going there in March as part of the team to get them converted to the County system. While he is physically there next month, he will try to speak to someone to find out what is going on.

Gary WB6YRU asked if we had any reason to believe the procedure we have used to get access have changed?

Gregg asked Wally KA6YOR and Lou WA6QYS to comment. Both indicated that we don't know--possibly so given how long it has been since we have been up there. It's a good plan to have Ned check into this.

Doug Owens N6DPO asked John who had informed him that the repeater had been powered down. John indicated is was someone he spoke with at the hospital while he was there for a family member.

Gary WB6YOR reported that our license and info on who we are was attached to the repeater so there is something fishy about this. Paul KK6HWN reported that the repeater coordination for the 2M repeater was not showing on the NARCC website. After some discussing it was determined that we are in possession of the coordination certificate and that it is likely the NARCC website was not current.

Website Report: Website is up and running well. No known issues

Old Business

Gregg asked Doug about LoTW status

Doug reported no issue with LoTW but the bigger question is how do we want to use it. At some point, we should transition to computer-based logging but we will need to consider everyone's preferences, etc. and suggested we address this at a future time.

Gregg mentioned that we hope to add a second beam antenna at the Red Cross. We'll provide an update at a later date.

New Business

Gregg asked for any new business to considered. None was brought forth.

Gregg KF6FNA declared the meeting adjourned at 8:39 p.m.
