

#### Board Meeting, May 19, 2025

Roll call was taken.

Directors: Lou Steirer WA6QYS, Wally Britten KA6YMD, John Parks W6JPP were present. Janet Motha KF6PUQ was excused due to 2 meter radio problems at her OTH.

A quorum of voting Board members were in attendance.

President's Report, Gregg Lane KF6FNA: Club pursuing go kit for POTA activations.

Secretary's Report, Doug N6DPO: As Gregg mentioned, we want to get a reading of who would like to operate with SCCARA on Field Day. Old Business

#### **New Business**

Gregg KF6FNA: Field Day: We should purchase a new end fed so we don't have to keep borrowing one from Goetz. (Goetz, has offered to provide his again if needed).

Doug N6DPO moved that we purchase a end fed antenna from myantennas.com and purchase 100 feet of coax if necessary.

John W6JPP seconded the motion AC6YY voted in the affirmative. KA6YMD voted in the affirmative WA6QYS voted in the affirmative K6PBQ voted in the affirmative

Gregg KF6FNA declared the motion approved

Doug N6DPO moved that we authorize up to \$400 for commercial filters to be purchased if we cannot successfully tune the existing filters to perform properly.

POTA go kit has been supported broadly. Gregg asked for volunteers to be on that committee. N6DPO, AC6YY, and W6JPP volunteered. The committee will approach the board after determining what is needed. N6DPO suggested Ned AC6YY be chairman. Gregg KF6FNA appointed a committee comprised of AC6YY (chairman), N6DPO, and W6JPP.

John W6JPP communicated that the Mayfair Chapter of the American Legion has invited us to operate during their Independence Day event. It is requested we operate all day and he believes we will need at least 4 SCCARA participants.

AC6YY suggested we bring our own canopy for shade.

Doug asked if this was an opportunity to recruit members. John indicated that we would have that opportunity primarily from the members of the Post. Doug said he will put together a poster and some literature.

Gregg asked if any issue with a generator, John indicated no issue.

KA6YMD reminded us that this is a directed controlled net. Too many doubles.

AC6YY recommended we use materials WB6YRU prepared.

Gregg brought up the HT loaner program. Lou recommended we get radios that can be programmed fairly intuitively without a computer in case of need to field program. Doug opined that we want to find radios that are reliable, we don't want to loan out radios that are problematic. Ned stated he thinks most all radios are the same in terms of programming complexity.

Gary Mitchell, WB6YRU, has resigned the board as of the previous day (May 18, 2025). Currently there is an empty slot.

Gregg KF6FNA declared the meeting adjourned at 8:48 p.m.


1) HF band-pass filters to reduce interference between stations, but limited each station to one band.
