President's Prose


Greetings!




ARRL Pacific Division Update

March 1998

RF Exposure Guidelines Effective Jan. 1

Compliance with the new guidelines should be straightforward for the vast majority of hams and should require few changes in current operating practices. These Amateur Radio rules deal with the general public for the first time in a new substantial manner; therefore, compliance is very important.

There are numerous information resources - an excellent summary of the guidelines is contained in October 1997 QST, pages 51 and 52. An article titled "How To Do a Routine Evaluation," starting at page 50 in the January 1998 QST, will answer most questions. Also, an ARRL book on this subject will be available soon.

FCC Items for Regulatory Review

Among 31 proposals by FCC staff for review released on Feb. 5, 1998, was this one involving the Amateur Radio Service:

"WTB Part 97: Streamline Amateur Radio Service. Seek comment on amending Parts 0, 1, and 97 of FCC Rules to privatize further the administration of the Amateur Radio Services and to simplify the licensing process."

Just what will come of these proposals is unclear, but ARRL is tracking the proposals closely.

US Participates in License Agreement

For many years efforts have been underway to secure US participation in the European CEPT agreement that permits licensed hams in European member countries to operate in other member countries without receiving prior, individual approval. Approval of the US request to participate came in late January at a meeting of the CEPT Radio Regulatory Working Group (WGRR), in Groningen, The Netherlands.

What this means, is that US amateurs also will not need to apply for reciprocal licenses in order to operate during short visits to most European countries. Similarly, most European hams visiting the US no longer will have to submit FCC Form 610A.

Under the arrangement, a US Technician license will be recognized as a CEPT Class 2 (VHF-only) license, with

full privileges above 30 MHz. Holders of Tech Plus through Extra tickets will be given a CEPT Class 1 license, with full privileges on HF and VHF. Novice licensees would not be eligible for a CEPT equivalent license since most CEPT countries don't offer a license of this type.

The time schedule for final implementation of the agreement hasn't been announced. Watch QST, the ARRL Letter, and this Update for further developments.

Featured classes will explore the theme 'Assessing Our Commitment', and will include instructors from throughout the state of California. The \$35.00 registration includes a Saturday evening reception and dinner.

Public relations (as opposed to public service) activities are those specifically directed at bringing Amateur Radio to the public's attention in a positive light—typically through the media (newspapers, TV, radio).

Applications for 1998 Scholarships

The Foundation for Amateur Radio, Inc., a non-profit organization with headquarters in Washington D. C., plans to administer sixty-six (66) scholarships for the academic year 1998-99 to assist licensed Radio Amateurs. The Foundation, composed of over seventy-five local area Amateur Radio Clubs, fully funds nine of these scholarships with the income from grants and its annual Hamfest. The remaining fifty-seven are administered by the Foundation without cost to the various donors.

Licensed Radio Amateurs may compete for these awards if they plan to pursue a full-time course of studies beyond high school and are enrolled in or have been accepted for enrollment at an accredited university, college or technical school. The awards range from \$500 to \$2500 with preference given in some cases to residents of specified geographical areas or the pursuit of certain study programs. Clubs are encouraged to announce these opportunities at their meetings, in their club newsletters, during training classes, on their nets and on their WWW pages.
