



From The ARRL Letter, August 3, 2007

## ARRL FILES FEDERAL COURT OF APPEALS REPLY BRIEF OVER BPL

On July 31, the ARRL filed its reply brief at the US Court of Appeals for the District of Columbia Circuit. This brief follows the FCC's brief that attempted to rebut the ARRL's challenge to the FCC's Broadband over Power Line (BPL) rules enacted in late 2004 and affirmed by the agency in 2006. According to ARRL General Counsel Chris Imlay, W3KD, "The FCC's brief does not accurately describe ARRL's arguments concerning harmful interference." The ARRL, in its reply brief, accuses the FCC of, "engaging in misdirection—rebutting hyperbolic arguments ARRL never made, refusing to address the precedents ARRL cited and attempting to rewrite the Orders as if they made factual rather than legal determinations."

The League's reply brief, according to Imlay, "focuses largely on the FCC's unprecedented failure to protect mobile stations from interference if the BPL operator reduces its radiated emissions by 20 dB below the Part 15 maxima, even if harmful interference persists thereafter. The reply brief also addresses the inapplicability of the 40 dB per decade of distance extrapolation factor applied to BPL system measurements in the high frequency bands."

The ARRL's reply brief looked at four main points: \* The FCC's failure to reconcile the Orders with the FCC's decades-old interpretation of Section 301. \* The FCC's failure to justify its nondisclosures of portions of the studies on which the Orders were expressly based. \* The FCC's failure to justify its refusal to consider contrary evidence, as well as a proposed alternative to its extrapolation factor for measuring interference. \* The FCC's failure to justify its summary dismissal of an alternative that could have accommodated BPL without causing the same harmful interference.

The ARRL's brief states that this case "is about an unlicensed operator's legal duty to cease harmful interference once it arises, not the standard for authorizing unlicensed transmissions."

For decades, the FCC has interpreted Section 301 to mandate two restrictions on unlicensed operators: The proposed operations will not have a significant potential for causing harmful interference, and; if harmful interference does occur, the unlicensed operations are to cease immediately. For the first time ever, the FCC excluded mobile operators from the second part of the mandate.

The FCC suggests in its brief that BPL emissions (that are reduced by the 10 or 20 dB that are the minimum notching requirements in the rules) will "never cause harmful interference to licensed mobile users, but there is no evidence to support this," the ARRL's brief states. The ARRL contends the FCC's brief "ignore[s] the express acknowledgement in the Reconsideration Order that 'harmful interference...may occur' even when BPL systems meet the FCC's technical standards and that when it occurs 'we will not provide further protection to mobile operations."

The FCC goes on to say, according to the ARRL's brief, that licensed mobile users "do not need the protection of the cease-operations rule because mobile users suffering from interference can move elsewhere." The ARRL contends that the FCC "has never before put the burden on the license-holder to move away from an unlicensed interferor, to the contrary, its rules require the interferor to cease interfering immediately. A BPL system deploys radiation-emitting devices ubiquitously throughout a service area, making it difficult to avoid harmful interference and impossible to conclude that harmful interference will 'never'

occur."

The ARRL's brief states that "the FCC cites nothing to defend the Reconsideration Order's ruling that Section 301 is inapplicable to 'unintentional radiators." The ARRL's brief points out that the FCC's brief "fails to defend the Reconsideration Order's holding that unintentional radiators like BPL devices 'as such' are outside the scope of Section 301's license requirement. The brief actually admits the contrary — that unintentional radiators are within Section 301." The FCC's brief mentions "but fails to acknowledge Section 302, which extended the FCC's authority to cover the manufacture and sale of interfering devices, is irrelevant to the scope of Section 301."

In its brief, the FCC failed to justify its "nondisclosure of significant portions of the technical studies on which the Orders rely." Instead, the ARRL said the FCC "attacks a straw man, suggesting that ARRL is after 'every internal document in its entirety that the agency's staff prepares in relating to a rule making proceeding."

The ARRL's brief states that the League only sought the full texts of the studies that the FCC "identified and cited as the basis for its conclusions. An agency may not cherry-pick the pages of the studies on which it relies, disclosing the ones that support its conclusions and redacting the others."

The FCC's brief requests that the Court defer to its "technical judgment in adopting an extrapolation factor to measure interference." The ARRL contends that the FCC "is not entitled to deference where it refuses to consider substantial evidence submitted to it -- in this instance, at the agency's invitation -- and fails to consider a responsible alternative proposal."

The ARRL points out three studies conducted by OFCOM, the UK-equivalent to the FCC. Each study reached a conclusion opposite that of the FCC and "plainly were significant to warrant consideration," the League's brief said. "ARRL's proposed sliding-scale extrapolation factor was an alternative entitled to consideration and a reasoned explanation for its rejection."

The ARRL makes the argument in its brief that it proposed a "win-win" solution: Authorize BPL, but "confine it to a generous frequency band that does not present these interference problems." It makes note of the fact that the largest BPL operator has designed its systems this way, and suggests that other operators could follow suit.

Yet the FCC in its brief brushed off these suggestions with a terse, two word sentence: "The other proposed 'solution' -- complete avoidance of all HF frequencies -- would needlessly restrict BPL design and reduce system capacity, without regard to whether there are amateurs that need protection from a particular BPL installation. This would result in a grossly inefficient utilization of Access BPL capacity, reducing the potential benefits of BPL and increasing its costs to the public, without a corresponding benefit or need."

ARRL, therefore, asked the Court in its brief "to enforce the FCC's 'duty to consider responsible alternatives to its chosen policy and to give a reasoned explanation for its rejection of such alternatives."

Pointing out the "multiple legal errors in the Orders," the ARRL stated in the brief that the FCC "require[d] a remand. When the Court remands the Orders, it should direct the FCC to give this alternative the careful consideration required by law."

#### **ARRL** elections

The Pacific Division director spot is uncontested, Bob Vallio W6RGG is asking to be re-elected. However, there are two running for Vice Director: incumbent Andy Oppel N6AJO and challenger Rob Brownstein K6RB. Here are their statements:

{These statements are by their authors and have not been checked for accuracy. They do not necessarily reflect the views of SCCARA. SCCARA takes no position on which might be best.}

Candidate Statement: Andy Oppel, N6AJO, for Pacific Division Vice Director.

It has been an honor and a privilege to serve as your Vice-Director since 2003, which included being a member of several ARRL committees:

1) The National Emergency Response Preparedness Committee (NERPC), which delivered a comprehensive study with specific recommendations to improve our readiness to respond to widespread emergencies.

Within the NERPC, I chaired the database group and personally wrote detailed specifications for an ARES registration database, which was subsequently built by ARRL staff and is now ready for use.

- 2) Since 2006 I have chaired the Technology Task Force, which has reviewed technical development work done by volunteer working groups and presented recommendations to the Board of Directors.
- 3) In 2003-04 I served on the ARESCOMM Committee, which presented recommendations for ARES digital communications to the Board of Directors at the 2005 Annual Meeting.

Although I work all modes and an occasional contest, as you can see I have a passion for emergency communications not only because it serves our communities well, but also because it is the best way to justify amateur radio to those who would like to take our spectrum away from us.

Prior service to the ARRL includes East Bay Section Manager 2000-2003 and Assistant Section Manager 1981-1999. I have completed ARECC Level I and II and FEMA courses 100, 200, and 700. I serve as Assistant Chief Radio Officer for Alameda County (California) RACES/ARES.

Professionally I am Principal Data Architect for Ceridian, have taught at U.C. Extension for 25 years, and am the author of two published books on database technology. I frequently offer the ARRL advice on information technology issues.

Vice-Directors cannot vote or address the floor at board meetings, so our influence is through background discussions and active listening. I know the process well and can make your ideas and opinions heard.

FAQs:

What is the Pacific Division? The ARRL is divided in 15 divisions, with each having a Director and Vice Director. The Pacific Division includes the East Bay, Nevada, Sacramento Valley, San Francisco, San Joaquin Valley, Santa Clara Valley, and Pacific Sections. In terms of real estate, it includes the entire

state of Nevada, Northern California (Monterey County and north along the coast, and Kern County and north inland), the entire state of Hawaii, and all the U.S. possessions in the Pacific (Guam, American Samoa, etc.).

What Do Directors and Vice Directors Do? The 15 Directors collectively set policy for the ARRL, much as the Board of Directors of any corporation does. Vice Directors provide support for their Director and serve when the Director cannot. Note that Vice Directors cannot vote and normally cannot address the floor when the Director is present at board meetings. However, there is a lot we can do to influence the Directors during the meeting (offering expertise in our field, conversations during recesses, and so forth). The most effective Vice Directors have well-developed skills in presentation, active listening, negotiation, and a willingness to seek and accept compromises.

How Does the Election Work? The ARRL will be mailing ballots and return envelopes to all full members within the Pacific Division (approximately 9,400 individuals) between September 24th and October 1st. Ballots must be returned to ARRL Headquarters via U.S. Mail by November 16th (ballots received after the deadline cannot be counted).

Candidate Statement: Rob Brownstein, K6RB, for Pacific division Vice Director.

I am Rob Brownstein, K6RB. June marked my 49th year of active ham radio operations. During those years, I operated CW, phone, and digital modes. We just come at it from different places. He's a specialist; and I am a well-rounded generalist. If you want broad rather than narrow, please give me your vote.

President's Report--Jim reported that the Red Cross has modified access to the radio room and the room outside it that is used for SCCARA board meetings. Two keys are now required, as well as badge access to the building after hours. Lou Steirer and Wally Britten have have sets. -Clark Murphy was asked to review the trip to the old RCA marine radio station KPH at P. Reyes.

Secretary's Report - The minutes were as published in the last SCCARA-GRAM, with the correction under old business that John Steinbach will resume using his real name, Don..

Treasurer's Report - - See the submitted report in this month's newsletter, covering balances, required reserves, expenses,

non-dues income, and donated equipment available to sell. The motion by Lou Steirer seconded by Don Village to accept the report passed without objection. -A discussion was held on disposition of the listed equipment. It was decided that Jim Tyranski will check current values on Ebay and Don Steinbach will attempt to verify operating condition, with the objective of having the equipment available for sale at the Electronics Flea Market in September. -There was also a discussion of ways to save money, including encouraging members to receive the SCCARA-Gram by email rather than post. The president will raise the suggestion at the general meeting.

Vice President's Report- -The Memorandum of Understanding (MOU) with the County covering ownership and operation of the 2M repeater was discussed by the RACES board. The draft changes are in the hands of the county lawyers. The Mayor and Vice Mayor of San Jose were at the RACES Field Day and have offered their support. -Fred reported that the radio shop replaced a cable on the 2M repeater to try to eliminate the crackling noise. It was the sense of the board that, as the licensee, SCCARA should obtain maintenance reports for all work done on the repeater. -The subcommittee looking into getting the 440 repeater back on the air has determined that the fastest, most reliable, and economical way is to purchase a new Kenwood TKR-850 (ham version). This has 16 programmable settings from 5W to 40W, and internal controller with CW ID, and can be connected to the existing controller. It will interface to IRLP and WinLink with an external computer. The cost will be \$1100 plus shipping. Don Steinbach moved and Lou Steirer seconded that \$1,500 be allocated to buy and install a Kenwood TKR-850 repeater at Regional Medical Center. After discussion about adding phone patch and signal strength capabilities at a later time as separate projects, the board voted 6-1 to pass the motion. Don Steinbach was assigned to arrange the purchase. -Doug Smith, who had tentatively been scheduled to speak at the August general meeting has been re-scheduled for September.

Newsletter Editor's report - -Gary requested advance information on speakers when available, since they are a major attraction for the general meetings. Wally also needs the information for posting on the web site. The newsletter is looking for any operational or technical articles for publication.

- The storage lockers need waterproofing before fall. A working party is to be arranged at the September general meeting.
- -The BBS is up and running. Two local BBs have recently shut down. There was a discussion about user familiarity, and it was noted that it has been a couple of years since the subject was presented at a general meeting.

Old Business- -The SCCARA Picnic is to be held on 9/15 (see article this issue). Activities will include the HF station, bingo, and a potluck barbecue. Lou and Gwen will reserve the spot. Bring chairs or eat with the ants! -Don Village reports that the SCCARA Holiday Party on 12/15 has been moved to the Creekside Inn, on West Alma near the Elk's Lodge and Tamien Station. The cost will be \$21 per person, including entr \(\Theta\), soup/salad, and bread. Selections will be steak, salmon, chicken marsala, or barbeque. The bar will not be open but we have the entire facility. Activities will include officer installation and gift exchange. This will also be the December general meeting. More details to follow. -The general meeting location for the rest of the year will be at the new Kaiser facility at Lawrence and Homestead. See this issue for detailed directions.


It'd be nice to know more about how our newsletter evolved and what we were thinking and doing back then. Can any of you long time members help?
