Electronic Flea Market

Please listen to the club nets for further information as it becomes available.




Wind Power

Some five years ago I was walking through the Brokaw Road Fry's store with window shopping as my main activity. No shopping list whatsoever, running amok with cash in hand. That's when I ran across a "last item on shelf" closeout special that was marked down some 40%. I was a moth drawn to a flame! There for the taking was a wind generator. Doesn't matter that I had never considered wind power before, my flea market instincts kicked in and the box was in the shopping cart.



Once I got home I opened the box to find a Sunforce 45444 600 watt wind generator. Assembly was incredibly straight forward, the three bladed fan having a four and a half foot diameter. Off to Home Depot for two ten foot lengths of 2 inch galvanized water pipe, the top section slipping into the socket provide at the base of the generator. Once aloft at twenty feet and able to spin freely, only the wiring remained to be done. Connecting the controller and the battery are clearly explained in the user manual and was easily accomplished. I bought an 8D truck battery for the

purpose. The generator, more properly called an alternator, uses magnets to create the field and a delta wound rotor to produce three phase alternating current. The controller converts the alternating current to direct current and does all the regulation to properly charge the lead acid battery.



My house being on a knoll on the side of a hill, wind is never a problem. In fact, often the wind is not needed if the batteries are fully charged, in which case the controller shorts out the three wires and after a bit of a thud, the blades stop spinning. So it all works and the batteries remain fully charged. I was so delighted with this installation that I recently bought a second one. Some four years after the first purchase and the price is even lower than my theft at Fry's. Now two generators are humming away.

These units are made in China and the workmanship is flawless. One very humorous feature of the user manual is the repeated advice to contact the manufacturer for spare parts or warranty claims. I say humorous because there is no address, no phone number, not fax number, no email address, nothing to let you know where you might send your request. Since they work flawlessly, this has not been a problem.

Kristen McIntyre, K6WX, Appointed ARRL Pacific Division Vice Director



Kristen McIntyre, K6WX, of Fremont, California, has been appointed Pacific Division Vice Director, ARRL President Rick Roderick, K5UR, has announced. The appointment came upon the recommendation of Director Jim Tiemstra, K6JAT, who succeeded longtime Pacific Division Director Bob Vallio, W6RGG, upon Vallio's election as ARRL Second Vice President.

McIntyre, who has served as ARRL Technical Coordinator for the East Bay Section, says on her QRZ.com profile that she's been interested in radio since she was about 5 years old. She got her Technician license in the late 1970s while a student at Massachusetts Institute of Technology. After letting her license expire, she re-licensed and obtained her Amateur Extra-class license.

She is also licensed in Japan, her second home, as JI1ZZ. She is president of the Palo Alto Amateur Radio Association and is currently a senior software engineer at Apple.

“Awesome” Activity for the 2018 ARRL International Grid Chase

“On-the-air activity for the 2018 ARRL International Grid Chase (IGC) has been awesome!” ARRL Contest Branch Manager Bart Jahnke, W9JJ, said this week. “The year also began with DXpeditions, as well as several contests at both HF and VHF, to boost numbers. Facebook and social media (Facebook, Twitter #ICG) are abuzz with chatter about the event, the excitement, the grids worked.”

Jahnke said the statistics show the highest overall activity on 40 and 20 meters -- not surprising in the winter -- and especially strong digital activity. He expects phone and CW activity to perk up this month and next, with the ARRL International DX Contest CW weekend February 17 - 18, and the phone weekend March 3 - 4. He also anticipates that February's statistics will come on strong as participants re-work January grid squares to boost their February scores. As of the January activity upload deadline of

February 10 at 2359 UTC, some 23,300 station sites were active in the IGC.

“The leader board reporting system continues to evolve, with much helpful participant feedback,” Jahnke said. That user input is improving how ARRL reports participation.

“From the statistics, it's clear that during this period of low sunspots and low winter E-skip and F2, most of the activity on the mid-to-lower bands is digital modes,” Jahnke said. “As we get into the summer E-skip season, we expect to see activity above 15 meters begin its ascent in the totals.”

Jahnke said it's apparent that participants are taking advantage of CW (and FT8 and other digital modes) on HF to overcome some of the weakened propagation on the low- to medium-frequency bands, and of FT8, JT65, and FSK144/MSK144 on 6 meters and above to rack up impressive totals. “Not to be outdone, in comparison to overall band totals, phone contacts on 80, 40, 20, and 17 meters are strong, and 2-meter and 70-centimeter contacts were strong in January as well,” Jahnke added. Several contests in January, including the ARRL RTTY Roundup and ARRL January VHF Contest contributed to these strong phone and digital numbers.

During January, IGC-eligible contacts matched in Logbook of The World (LoTW) topped 22,000 on 40 meters and 23,000 on 20 meters -- the two bands with the greatest activity -- with nearly half the contacts being made on digital modes in both bands. On the new 630-meter band, 31 IGC-eligible contacts turned up in LoTW.
