Wall Wart or Not

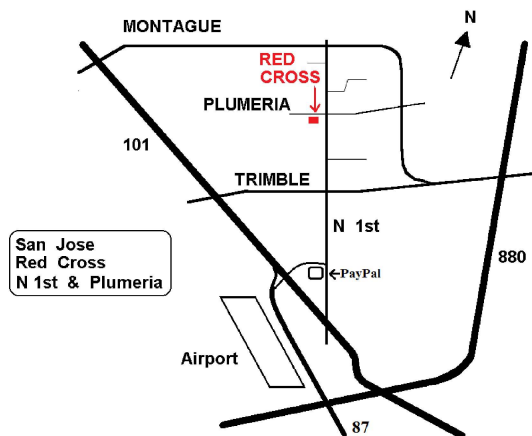

So sorry, I had to get that off my chest, a battle I will never win. The real subject of this article is the USB wall wart which is the backbone of laptops and cell phones. This has been standardized and the joke is that "the good thing about standards is that you have so many choices". Not only are there three speeds, USB1, USB2 and USB3, but the actual cable terminations come in at least five different configurations. My real complaint is that I almost always have the correct USB cable, but not the wall wart.

Step in PBS's "This Old House" which offered this simple solution, namely "Snap Power USB Charger Outlet Wall Plate Cover." You simply remove the wall power outlet cover held in with a single central screw and replace it with the new cover plate which has fingers that reach in and touch the plug wiring screws. Reinstall the center screw and you are done.

Your wall outlet now has a USB power port! Strategically placed around the house and you don't need USB wall warts anymore. Check it out, you'll like it.

Field Day 2022: 500,000 Contacts Already Reported

2022 ARRL [Field Day](#) wrapped up nearly a week ago, and ARRL Headquarters has already received over 2,400 entries submitted via the online [Field Day Entry web application](#). Early analysis reveals that most of the entrants participated as Class D -- home stations, and Class E -- home stations using emergency power.

As of June 29, the breakdown of Field Day entries by Class showed 2,723 total entries, with 272 in Class A, 361 in Class B, 32 in Class C (mobile), 1,524 in Class D, 484 in Class E, and 50 in Class F.

So far, a total of over 517,000 contacts were reported for the event and those numbers are changing daily. In 2021, there were 1.5 million contacts made during Field Day activities.

Many participants were keeping their hopes up for better propagation, as early forecasts were looking promising. ARRL Contest Program Manager Paul Bourque, N1SFE, said that propagation aside, there was substantial activity. "While band conditions might not have been the greatest, there was a good amount of activity on the bands this past weekend. Many participants seemed to agree that the recent rule changes, capping transmitter power output to 100 W, were a good idea," he said.

Kristi Milluzzi has made a commemorative Field Day cake for each of the last three years, featuring the event's logo. She recently married Andy Milluzzi, KK4LWR, of Clermont, Florida. Andy is a member of the ARRL Public Relations Committee, and co-advisor to the ARRL Collegiate Amateur Radio Program.

Dustin Lomax, KF7FK, reported in his Soapbox comments that it was his first Field Day in which he used CW, adding that “CW was a fun change of pace that really helped make the most of marginal band conditions in WWA [Western Washington].”

There is still plenty of time to submit your 2022 Field Day entry. Participants who submit their entries using [ARRL's Online Submission Form](#) can earn 50 bonus points and will receive an email confirmation of their completed entry. Be sure to check the [Entries Received web page](#) to verify your entry's status. If it indicates “Pending documents,” the required dupe sheet (or in lieu of that, a Cabrillo log file) or other supporting documentation of claimed bonus points is missing.

Participants can edit or add documentation to their online submissions by using the link provided in the confirmation email. Field Day entries must be submitted online or postmarked no later than 2059 UTC on July 26, 2022.

2022 Field Day was highly promoted thanks to the efforts of many ARRL Division and Section volunteers, amateur radio clubs, and their members. Many states and counties obtained special proclamations from local governments designating the weekend (in some cases the whole week) as Field Day and Amateur Radio Week, recognizing the many contributions of amateur radio operators during emergencies and with serving their communities.

ARRL treated participants with a live video stream from W1AW, its Headquarters' station, throughout Field Day. Life Member Karl Schwab, KO8S, of Warren, Michigan, was delighted with making contact with W1AW during Field Day. “I heard W1AW calling CQ Field Day on 20 m SSB,” wrote Schwab. “I responded and then heard, 'Kilo Oscar Eight Sierra, you're 5 Foxtrot Connecticut.' I responded with my report, and got in their log. ... After Field Day, and uploading my log, I went to the ARRL website and there I found a 4-hour video was available on YouTube, showing W1AW during their Field Day activities. While watching this video, at hour 2, minute 55, I heard and saw my live contact with them! [This] was a special moment for me. Southern California Exercise Tests Winlink Global Radio Email

For 2 days in mid-June, over 100 amateur radio operators were joined by the United States Geological Survey (USGS), local and county law enforcement agencies, and the EmComm Training Organization (ETO) for participation in a functional earthquake exercise in southern California, known as SoCal Shifting 2022.

The goal of the exercise, which took place June 18 - 19, was to test the operational capability and readiness of the Winlink Global Radio Email® system using amateur radio frequencies.

Oliver Dully, K6OLI, District Emergency Coordinator of the Amateur Radio Emergency Service® (ARES®) Los Angeles Northeast District, said the exercise came together quickly over 5 days, with the help of the Los Angeles County Sheriff's Department Disaster Communications Service (DCS), the San Diego ARES, and the Ventura County ARES.

Dully said, “Amateur operators routinely hold weekly tests but need to be network-aware and used to the battle rhythm during emergencies to move traffic in [a] more timely manner.”

The exercise scenario included a cluster of earthquakes occurring on June 18 at 10:18 AM Pacific Standard Time, and amateur radio operators were asked to send a series of messages ranging from a Did You Feel It (DYFI) report to a Field Station Report (FSR).

Dully said the exercise was a great success, stating: “Participants were only given a short 3 days' notice, so the great success of the SoCal Shifting 2022 functional exercise again demonstrates the value of regular, mission-focused training and collaboration.”

Dully said the numbers from the final after-action report were outstanding:

The ARES Los Angeles Northeast District tactical call sign received 372 messages from 101 participating stations during this exercise. Seventy-six of those stations sent all four messages, 16 sent three, the remainder sent two or fewer. The Winlink check-out was most often overlooked.

Over 95% of stations correctly located themselves in North and Central America. Three stations missed a (-) sign in their longitudes in some (but not all) of their form submissions. Two stations elected not to send latitude and longitude.

Over 95% entered the correct exercise name in the DYFI form. That was of special importance, as it helps USGS aggregate and analyze exercise data.

FCC Legacy CORES System Has Been Retired

The Federal Communications Commission (FCC) retired the Legacy version of its COmmission REgistration System (CORES) on July 15, 2022. CORES is the FCC's public-facing database that enables and tracks certain types of FCC and FCC applicant actions, including amateur radio applications and licenses. Its implementation has enabled routine amateur applications and licenses to be issued overnight instead of over weeks, as was the case with earlier methods. The [updated version of CORES](#) is now available. (<https://apps.fcc.gov/cores/userLogin.do>)

In essence, CORES is designed to identify those who hold certain types of FCC licenses and FCC authorizations, including amateur licenses, and organize them in an easily accessible manner under a common FCC Registration Number (FRN) regardless of whether one holds a single such authority or thousands. The new CORES, in addition to assigning individual FRNs, allows holders of multiple FRNs to aggregate them under a single account where the licenses and authorizations, fees and payments, and related actions can be administered from within the same account.

In effect, new CORES can be conceptualized as an electronic interactive file folder. The updated version of CORES has been available since 2016, and its use is now mandatory for all amateur licensees when submitting amateur-related applications.

The Legacy CORES website now re-directs users to the Commission's updated CORES site. Although some functionalities in the old system will continue to work for a short time, the FCC has urged all users to transition to the updated CORES system to take advantage of its enhanced security and functionality.

Register with the FCC

Licenses that do not already have an FCC CORES Username Account must create one with a unique username (a valid email address) and password. After creating the account, when logged in, users should associate their existing FRN or FRNs with this account. Instructions for doing so are on the [FCC Registration Help web page](#). One's FRN is printed on all current amateur applications and licenses, and will not change. FRNs can also be found by looking up one's call sign in the Commission's ULS (<https://wireless2.fcc.gov/UlsApp/UlsSearch/searchLicense.jsp>) or by using the FCC's [Advanced Search web page](#). (<https://apps.fcc.gov/cores/publicHome.do?help=true>) (<https://apps.fcc.gov/cores/advancedSearch.do?csrfToken=>)

The FCC has posted [tutorial videos](#) to assist with the transition. ARRL VEC Manager Maria Somma, AB1FM, recommends viewing "Getting Started With the New CORES," which explains how to register for a CORES Username Account, and "Associating an FRN to a Username," which instructs Legacy CORES users on how to link one or more existing FRNs to a username. 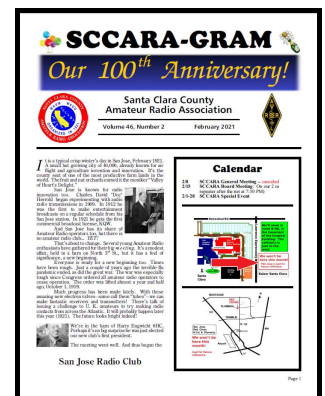

Newsletter Notes

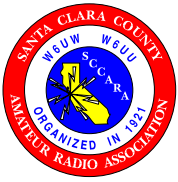

As you all know, the pandemic put a damper on in-person celebrations. So this is pretty much all we have to show for it.

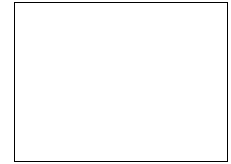
If you have something you would liked to have added, you can still send it in for a future edition. We'd still like to see it.
