

Five militants still active in Srinagar: IGP Kashmir

'Cooperate with medicos, don't blame them for COVID-19 miseries'

Srinagar, May 17: Doctors and paramedical staff across Kashmir have been working overtime to handle the second wave of the COVID-19 in the Valley and people should cooperate with medicos rather than blame them for their miseries.

Some videos have gone viral on social media where the attendants can be seen accusing doctors of not treating their patients without the COVID

An analyst while talking to

Precious Kashmir said, "People should understand that doctors and paramedics are also human beings and they are frontline Covid warriors, they are not superhuman, nor are they virus proof. If we start losing them who will treat a common man?

He said, "At present situation is grim in every district. The administration should make the Rapid Action Test (RAT) kits available in all the hospitals and health centers. A medico said, "Since the COVID-19 pandemic has hit Jammu and Kashmir we have been working 24x7 to provide treatment to the patients who are in distress. It's unfortunate

that some attendants get into an argument and scuffle with the medicos.'

He said that these are tough times and we have to cooperate with each other to fight this virus. "This is not the time to blame each other for our miseries Entire world is battling CO-VID-19 and J&K is not the only place that has been hit by the pestilence," the medico added.

An official said, "Most of the big hospitals in Kashmir

are accommodating the CO-VID-19 patients. High and low flow oxygen beds have been set up in the tertiary care hospitals and all possible efforts are being put to save the precious human lives.

He said that the Lieutenant Governor Manoj Sinha is monitoring the situation personally and is taking feedback continuously. "The lockdown is helping in breaking the transmission chain. People have to cooperate with the administration and doctors. These are testing times and we have to come out of it. We have to be firm and resilient," the official added.

An expert said, "We should understand that COVID is an emergency. As on date except for vaccines there is no protection for COVID-19 and doctors are aware of it that's why they are asking the patients to get a Covid test done before consultation."

He said, "We have to fight COVID-19. Fighting with each other won't serve any purpose. Doctors are our assets and we have to preserve them."

Advisor Baseer Khan reviews functioning of oxygen manufacturing plants

Visits Hospitals and takes review of arrangements, augmentation of bed capacity and telemedicine setup in the hospitals

SRINAGAR, MAY 17: Advisor to Lieutenant Governor, Baseer Ahmad Khan today visited the oxygen manufacturing plants at Rangreth Industrial Estate and Sanatnagar Industrial Estate and directed the officers to ensure continuous supply of medical oxygen to various hospitals amid the COVID-19.

During his visit to the oxygen manufacturing plants, the Advisor said that the plants should be utilised to the optimum capacity as the medical oxygen is an important commodity in the fight against COVID. He said the demand should be met on regular basis and efforts should be put to enhance the productions.

Director Industries Kashmir while giving details about the functioning of oxygen generation plants said that they are reviving a defunct oxygen generation plant in collaboration with FCIK. He said that this would increase the cylinder capacity by 500 per day.

The Advisor directed the officers to make concerted efforts so that the defunct plant is revived in shortest possible time.

Advisor passed on spot diretions to the district administration



to deploy adequate security to the oxygen generation plants. He also passed directions to the Chief Engineer PDD to ensure continuous power supply to the plants so that no disruption occurs and urged that the necessary back up should be provided to these units.

Advisor also visited the SMHS Hospital and Kashmir Nursing Home and reviewed the bed capacity and other facilities being provided to the Covid patients. He was informed that bed capacity has been increased by 20-30 percent in Government Medical Colleges, Associated Hospitals and SKIMS keeping

in view the capacity of the oxygen generation plants. The Advisor also directed the

officers to ensure that Covid call centres are working round the clock. He reviewed the functioning of telemedicine at various hospitals and directed the officers to ensure that call centres are working round the clock to ensure that patients other than Covid are being given proper advice and treatment. He said that telemedicine is the safest interactive system between patient and doctor in these testing times.

Commissioner SMC informed about readiness of two wellness cen-

tres at Srinagar and said that all arrangements are being put in place to ensure their functioning as soon as possible

Advisor laid special emphasis on adoption of COVID-19 appropriate behaviour and said that it is the best way to stop transmission of the virus and its variants and added that stringent implementation of COVID appropriate measures remain the key to stop virus transmission. He also added that physical-distancing measures and movement restrictions can actually restrict the COVID-19 transmission.

Muslim volunteers bury Christian who died of Covid-19 in Kargil

Kargil, May 17, KNT: Amid Covid-19 scare, Muslim volunteers in Kargil region of Ladakh buried a Christian who died in hospital from Coronavirus.

Local sources told news agency Kashmir News Trust that an NHPC employee Samir Akaa from Ranchi Jharkhand posted in Kargil was tested Covid-19 positive and admitted at Covid-Care Hospital last week.

The infected employee was

Christian by faith who succumbed to Covid-19 in the hospital at Kargil.

Muslim volunteers after receiving information about the death of a Christian stepped in and buried the deceased near Chaman Mode, adjacent to Muslim graveyard.

"We responded immediately regardless of the faith of the deceased after coming to know about the death of this man. We have seen many difficult situations, even cases where children refuse to touch their father's body," said one of the volunteers

Free ration distribution drive continues at Shopian

SHOPIAN, MAY 17: The Department of Food Civil Supplies and Consumer Affairs (FCS&CA) continues the distribution of free ration among the BPL and AAY Categories in the Shopian district as per the government directions and provisions of Disaster Management Act.

As the second wave of Covid-19 pandemic has rendered thousands jobless, the UT Government has decided to distribute 5 kg grains per soul free of cost to all the beneficiaries of the State National Food Security Act over and above their regular quota in May and June 2021.

In this connection, the FCS&CA Shopian has distributed 7658 quintals of food grains free



of cost among the BPL and AAY Categories under Pradan Mantri Garib Kalyan Anna Youjna (PMGKAY).

Besides, it was also given out that the department has distributed 10200 quintals of rice(NFSA), 350 quintals of Atta(NFSA), 4500 quintals of rice(JKFES), 200 quintals of Flour (PMGKAY) among the beneficiaries of Shopian district as on now.

The government is providing ration to the registered consumers at their doorsteps as per protocol to avoid public gatherings and observe social distancing during collection and distribution of the essentials.

Avail vaccination of two doses at interval of twelve weeks: Microbiologist

To mitigate the impact of third wave of virus, vaccination important for all

SRINAGAR, MAY 17: With prolific sampling of people for SAR COV2, the work pressure on GMC Microbiology Lab has also increased manifold but everything is being managed very diligently and smoothly by the concerned GMC administration and Laboratory Staff while working without relenting, said Dr Lenah Bashir, Lecturer Microbiology, Government Medical College, Srinagar.

She said the Microbiology Department is guiding physicians in diagnosis of the Covid Virus through testing the samples collected at GMC Microbiology Lab and other identified centers.

While mentioning the mild and severe symptoms of the disease, Dr Lenah said that cough, cold, loss of taste and smell, and fatigue are mild symptoms whereas breathlessness is a condition of severe infection. "Severe symptomatic patients should be shifted to hospital for treatment and monitoring".

Regarding infection detection, she said two types of swabs are collected including nasal and throat swab. She added that Rapid Antigen Testing or RT-PCR will identify the presence of infection. However, she stressed that any individual who will test negative through RAT testing should also go for RTPCR testing.

testing.

While sharing the details regarding availability of results, she said that RAT results are made available within fifteen minutes while RTPCR takes two days time due to its procedure and heavy load of samples. To cope up with the demand, the lab is working continuously without any break, to give results within least possible time.

Dr Lenaĥ said that Real Time revere transcription Polymerase Chain Reaction (RT PCR) is the gold standard for SARS COV2 detection. "This molecular test targets more than one gene of SAR COV 2 I.e N gene & RdRp gene", she informed about detection of multiple mutants by RTPCR. Moreover, she said "these targets are considered best for invitro diagnostic detection, hence, it will show similar sensitivity and specificity in such situation", she further added.

Regarding double mutant covid virus, she said that double mutant strains



of SAR COV2 are showing heightened infectivity and escape from the body's immune systems, hence increases lethal infections. "Previously infected people have a greater chance of re-infection due to double mutant", she said.

The Microbiology expert confirmed that vaccines are safe and requested people not to deny themselves of covid vaccination and avail the opportunity to get inoculated with two doses at the interval of twelve weeks. Depriving oneself of vaccination is an unwise decision some people make as they fall for misconceptions spread by Social Media, she said while dispelling unverified conceptions.

She maintained that adherence to SOPs and Guidelines by normal and symptomatic persons will help to control contagious Corona virus.

While speaking about the threat of third wave and mitigation measures for it, Dr Lenah Bashir emphasized on extended lockdown, Abiding of lockdown rules, Avoiding gatherings and mandatory masking. "More importantly vaccination is to be made available to all", she said. Besides, she said that hospitals have to be strengthened further.

Testing capacities have already been expanded and is being taken care of by the administration in terms of manpower as well as facilities, she maintained.

Regarding Black Fungus, she said, "it is a fungal infection which affects people with weakened ability to fight infections like diabetes, malignancy etc." and advised to strictly monitor blood glucose levels of such individuals and judicious use of steroids.

In this regard she said not to hesitate to seek medical attention and relevant microbiological investigations.

The Mission Director stressed that the principle aim of the Mission is to aid rural women in securing the livelihood for themselves besides institution & capacity building of the aspiring entrepreneurs, lending financial services to them and convergence of different entrepreneurship schemes extended by various departments or government agencies by organising the aspiring women into Self Help Groups (SHGs). Pertinent to mention here that out of around 120 erstwhile blocks the Mission is under implementation in 96 blocks with 14 more blocks to be targeted this year. Almost



46000 SHGs comprising about 3.95 lakh rural women have been constituted under the Mission. These SHGs have been lended a credit amount of around Rs 600 crores with an interest subvention of Rs 1.04 crore. This accrued more than Rs 130 crores as savings for its members. These SHG members are also being provided with accidental and life insurance cover under PM Suraksha Bhima Yojana and PM Jeevan Jyoti Bhima Yojana. She emphasised that the Mission has a target of organising 85000 SHGs involving around 9 lakh rural households for which the total outlay of Rs 755.32 crores has been envisaged.

Hailstorm aftermath

Fruit crops in twin Kashmir districts suffer over 40% losses: Govt

Srinagar, May 17 (KNO): The fruit crops in twin districts of Kashmir have suffered over 40 per cent of losses with the department concerned stating that the report compiled will be forwarded to Divisional Commissioner, Kashmir and Principal Secretary Horticulture department by today (Monday) evening.

According to the news agency— Kashmir News Observer (KNO), the frequent hailstorm in the last couple of days caused extensive losses to the apple orchards and other fruit crops across the Valley, leaving the growers worried.

Manzoor Ahmad, a fruit grower from Kulgam district stated that the frequent hailstorm has left the entire community anguished as it has led to the huge losses yet again. "In the last couple of years, the growers have been suffering huge losses due to one reason or another," he said.

Meanwhile, Director Horticulture, Kashmir Aijaz Ahmad Dar told KNO that South Kashmir's Kulgam district and Handwara area in north Kashmir's Kupwara district have suffered 40 per cent losses due to the

"We have collected the data after assessment two to three days back. The fresh damage to fruit crops due to hailstorm has not been compiled yet. The previous data collected has been compiled and the report will be sent to Divisional Commissioner, Kashmir P K Pole and Principal Secretary Horticulture Navin Kumar Choudhary by

today only," he said.

The damage to fruit crops occurred almost everywhere in the Valley, but some pockets in Kulgam and Handwara have suffered extensive losses, which takes the figure up to around 40 per cent losses as per the assessment done so far.

He added that the losses to fruit crops in other districts vary as somewhere the damage is five per cent while at some places it is about ten per cent and not more than that. Chief Horticulture Officer (CHO)

Kupwara, Farooq Ahmad Tantrey said that the apple orchards are mostly affected in the recent hailstorm while walnut crops suffered a bit less



losses as compared to the other crops.

"Almost all the fruit crops have suffered over 40 per cent losses in Handwara area of the district," he said, adding that the figure of losses is less in other areas of the district.

Chief Horticulture Officer (CHO) Kulgam, Muhammad Iqbal Baba said that the worst hit villages in the districts include Awgam, Zazripora and Puniwah where damage to the maximum extent has taken place. Other areas where moderate hailstorm hailstorm has been reported are Nowpora, Daderkoot, Checki Hanjan, Hanjan, Sheganpora, Sofi-pora, Akipora, Behibagh, Srandoo, Arreh, Mohammadpora, Tazipora, Khandypora, Batapora, Jadipora Dedipora, Shurath, Laroo, Kharvot, San-

gus, Akipora, Awhatoo, he said. The hailstorm yesterday (Sunday) caused damage to the crops in Sanigam, Bogam, Tchensar and Schuch, he said, adding that the field agency has been asked to prepare the damage report in consultation with PRIs and revenue agencies and submit the same to his office for onward submission to

He said that according to the advisory related to post hailstorm sprays, the orchardists should make spray of fungicides (per 100 liters of water). In this connection, Zineb 68%+Hexaconazole 4% WP (100g) or Metiram 55% +Pyraclostrobin 5% 60WG or Mancozeb 75WP (300g) or Zineb 7WP (300g) can be used.

In addition to the above, the or-chards may be sprayed with urea @ 2% (200g per 100 liters of water) 3 days after the above spray. The advisory asks for maintaining proper orchard sanitation and removing fallen leaves from the orchard, he informed.

Moreover, Dr. Lateef Ahmad, Scientist Agrometeorology an expert said that hailstorm is an instant climate phenomenon, saying that the marginal farmer or people having small fields can prevent the losses due to the hailstorm.

"Hail guns and anti-hail nets can help in preventing the losses to the fruits due to the hailstorm. Per shot

of hail gun costs Rs one lakh, which helps in converting the hailstorm into rains," he said.

He added that anti-hail nets are also one of the tools to prevent the losses due to the hailstorm, adding that the anti-hail nets can help in preventing losses at small fields while the losses can't be prevented at commercial land as it would take time to put up an anti-hail net over the land in a shortest possible after the weather

forecast by the concerned agencies. He said that the government should consider starting Agri Insurance for the farmers, saying that it could prove fruitful for them. He also stated that at present research is going on at NIT to come up with a sensor-based umbrella, which will help in preventing the losses.

Another expert termed the hailstorm as 'global pandemic', saying that putting up the hail nets on the crops spread over several acres of land is almost impossible, adding that one cannot put up the net over the huge land in a hurry rush after getting the latest weather advisory—(KNO)

DAK sounds alert over black fungus in COVID-19 patients

Srinagar, May 17: Doctors Association Kashmir (DAK) on Monday said a rare but deadly fungal infection called mucormycosis is infecting COVID-19 patients.

Sounding alert, DAK President and influenza expert Dr Nisar ul Hassan said if left untreated the disease can be fatal for COVID patients. "Cases of mucormycosis, commonly known as black fungus are being reported in several states of the country among recovering and recovered

COVID-19 patients," he said. Dr Hassan said chances of fungal infection increase in COVID patients, who are diabetic and are taking steroids. "Diabetes lowers the body's immune defenses, COVID exacerbates it and then steroids act like a fuel to the fire," he said. He said COVID itself leads to

lymphopenia, therefore predispos-



ing patients to opportunistic fungal infection. "The use of ordinary water in humidifiers which are used during oxygen therapy could be another factor," he added

DAK President said in order to prevent this life-threatening disease in COVID patients, doctors should use steroids judiciously

steroid. "People who have diabetes should keep their sugar levels in control. And, use sterile water for humidifiers during oxygen therapy," he said.

He said the fungus is ubiquitous and is found in soil, air and decaying food, adding despite being common in the environment, it does not

body's defenses have been weakened; the fungus gets a chance to infect with devastating results. "After inhaling fungus from the air, it can go into the nose, sinuses, eyes and brain leading to loss of vision and even death in some cases. It can also affect lungs," Dr Hassan said.

He said symptoms include pain and swelling in eye or face, headache, nasal discharge and black crusts in the nose. "Treatment of mucormycosis involves removal of all infected tissue through surgery and following with antifungal am-

Most of the candidates currently engaged in the colleges on the basis of court orders are 'ineligible', sans required qualification (PhD or NET degree), they said.



No Black Fungus case detected in in recent months: Top Medico

JAMMU, MAY 17: As if the Covid pandemic wasn't enough, another scare has gripped the public. An infection by the name of Black Fungus is targeting people in some parts of the country after recovering from Covid-19, and if not treated in time, it is as deadly as its name. Thankfully, Head of Ophthalmology Department at Government Medical College Jammu, Dr Satish Gupta has assured that nothing much is lost and that Black Fungus has always been there.

Dispelling the apprehensions the HoD said, 'So far we have not witnessed any case of Black Fungus Infection in the recent months. The only patient we have had came in the month of November, last year, and was successfully treated. request all those recovered from Covid-19 to keep cautious and continue observing Covid appropriate

Dr Satish Gupta said that Black Fungus usually targets Covid-recovered persons with uncontrolled diabetes or those who have administered prolonged or unsupervised dosage of steroids. 'Cancer patients, those who have undergone organ transplant and people with weak immunity are more susceptible to Black Fungus" he

The doctor advised the public not to confuse Conjunctivitis with the Black Fungus Infection and said, 'Conjunctivitis is a routine infection

and is easily curable; while the latter has recently caught public's attention due to Covid and needs timely intervention'. He particularly advised the susceptible population to keep diabetes under check and warned all against unsupervised use of steroids.

The symptoms of Rhino-oculo Cerebral Mucormycosis, the medical term for Black Fungus Infection, includes stiffness or blood stained/ black discharge from nose; pain, bulging (proptosis), restriction in movement, drooping of eye/s, swelling, black lesion around eye/s and loss of vision; and death if in case the

infection reaches brain. The doctor appealed the public to keep following Covid appropriate behaviour so as to avoid Covid and post Covid issues altogether.

Dr Satish Gupta informed that all Covid-related queries and doubts can be cleared on the helpline number 0191 2571616. Public can also call Divisional Control Room at 0191-2520982, 2549676, 2674444, 2674115, 2674908. 'Moreover, J&K Government has started a live phone-in health programme on Gulistan channel which is aired twice daily- from 8:30 am to 9 am and 8:30 pm to 9 pm. Eminent doctors respond to public queries during the programme. Anybody from the public can call on the above-mentioned Divisional Control Room phone numbers and seek information related to Covid treatment, home isolation and other non-Covid health problem', he said.

Div Com directs for close check on overcharging of essential medicines

'Sufficient stock of covid related drugs including Remdesivir available'

JAMMU, MAY 17: Divisional Commissioner, Jammu, Dr Raghav Langer today reviewed the stock and supply position of essential drugs, pulse oximeters, here at a meeting of Drug Controllers and Wholesale dealers of Pharmaceuticals.

The meeting was attended by UT Drugs Controller J&K, Lotika Khajuria; ADC Jammu, Deputy Director Health Services, Assistant Controllers Drugs, besides President, Secretary and other members of Jammu Pharmaceutical Distributors Association and other concerned.

At the outset, the Div Com reviewed the stock position of covid related drugs, Bipap & High flow Masks, Sanitizers, covid related medical equipments (oximeters, oxygen concentrators etc). It was informed in the meeting that sufficient stock of essential drugs is available and supply is also being maintained.

The Divisional Commissioner directed the concerned to ensure that there was no shortage of covid related drugs, masks, sanitizers, oximeters etc. He also passed directions for ensuring close check on overcharging for essential medicines, masks and oximeters.

The Drugs Controller informed that sufficient quantity of Covid related drugs are available. She informed that over 11,500 vials of Remdesivir are available in the Jammu division and they are also receiving regular weekly stocks.

It was also informed in the meet ing that Pulse Oxymeters and Oxygen concentrators have been notified as Drugs under the provisions of Drug Control order DPCO, 2013 w.e.f April 1, 2020. It was further informed that the MRP of Pulse oximeters and oxygen concentrators shall be monitored under para 20 of DPCO, 2013. The government shall monitor the MRP of all the drugs, including non scheduled formula-tions and ensure that no manufacturer increases the MRP of a drug more than 10 percent of MRP dur ing preceding twelve months.

The Drugs Controller has also issued a circular that any person found violating the provisions of Para 20 of DPCO shall invite action under Essential Commodities Act

The Divisional Commissioner directed the Drug Control Depart-ment to constantly review the compliance status of prices fixed by NPPA(National Pharmaceutical Pricing Authority) and under the Medical Devices Rules, 2017.

Paramedic battles Covid surge with indomitable spirit

SAMBA, MAY 17: Facing a deluge of very sick patients and overfilled hospital, Samba Staff nurse Anuradha Choudhary said she keeps her growing fear at bay by focusing on her patients as the coronavirus pandemic rages around her.

Anuradha Choudhray works as a staff Nurse in the Accidental Hospital Ghagwal, Samba district and provides care to patients in the hospital. Although only 31, she has been in the job for a decade.

"I have been working for so long and now because of Covid situation it has become very challenging for us to operate but still we try to give

good care" she said. "We feel very good doing this but sometimes we also feel scared. However, despite all that we try to forget everything else, keep nourishing nice feelings in our hearts and try to

be passionate towards the patients. Wearing a white protective suit and mask, Anuradha gently holds the hand of an elderly woman resting on a bed and monitors her oxy-

Her family is supportive of her work, she says, but she is afraid of bringing the virus home. "Sometimes they feel scared that I work in such risky conditions and then come home in the evening... but they still support me and I also feel good that they appreciate me for working in

"Our workload has gone up five times. All the nurses are now putting in extra hours of work. We always come on time, but we are never able to leave on time," she said.

Speaking about the workload said "I've been a nurse for long and worked in the past during disasters which would bring an influx of patients to emergency, but what is unfolding now is unprecedented. Now I'm so tired at the end of the day, that I can fall sleep anywhere. I don't even need a bed.

'Nursing is described as the noblest profession in the world and 'we are called 'sister' for a reason. Our patients think of us as family" she said with a smile.

"Whenever a new patient is admitted to hospital, a nurse is the first person they meet and they form a special bond with us. The covid patients coming in the hospital are very afraid, so we try and motivate them," Anuradha said

She also feels proud when her acquaintances appreciate her work. "A neighbour recently told me that earlier she used to light one clay lamp every day at dusk to pray for the long life of her family. Since the outbreak of the virus,' she tells me, she lights an extra lamp for my wellbeing. And that makes my job, and life, worthwhile" she said with twinkling eyes.

Anuradha asks everyone to continue taking precautions and doing their part. "This is real, and we need to take this seriously. Your protection isn't just for yourself. it's for the people around you and



those you love. Wear a mask and wash your hands.

Black fungus: care and don't panic

Covid has been making deeper inroads into urban and rural areas of Jammu and Kashmir along with most parts of India. The pestilence has claimed many lives, around 900 people alone in Jammu and Kashmir in little over a fortnight. Around 70000 people have been infected during the time also.

The virus has been ravaging even as 70%-80% of those affected with it recover on their own without many side-effects. About 20%-30% of patients affected with symptomatic Covid-19 might require hospitalization. Among them, the condition of some can get worse and require treatment in an intensive care unit (ICU). Worst case scenario has been for the people with comorbidities such those having uncontrolled diabetes, heart or respiratory diseases and malignancies. Older age and obese people do not fare good either.

Amid all this, there is new fear—contracting a severe disease--mucormycosis. Also known as 'black fungus', is not any new infection but the number of cases has increased due to Covid-19 in India, according to the Director AIIMS Randeep Guleria who also warned against the spread of the "rare but dangerous fungal infection."

As per experts, at higher risk of contracting the disease are those having poor immunity, uncontrolled diabetes. Other risk factors include steroid treatment and among other people prone to it are those having malignancies, HIV/AIDS and those who have been treated with medicines such as deferoxamine for iron overload conditions. This disease as per the experts can affect the face, infecting nose, orbit of eye, or brain, which can even cause blindness.

Other forms of the fungus include the pulmonary form in which the lungs are mainly involved and less commonly disseminated mucormycosis, where it spreads throughout the body. Government of India, in an advisory issued on May 9, said the black fungus may turn fatal if uncared for. It also said the infection mainly affects people who are on medication that reduces their ability to fight environmental pathogens.

With Covid-19 cases increasing, it's paramount that protocols of infection control practices are followed at hospitals. Scrupulous hygiene and care of the equipment inside the ICU should be done in order to reduce the risk of fungal and other infections. It is also very important for those with diabetes to keep their sugar levels under very good control. If steroids have to be used, their judicious use is recommended and for as short a period of time as possible, strictly at the advice of the doctors.

FUNDAMENTAL Rights: An Introduction



FUNDAMENTAL RIGHTS

ne rights of individuals have long been an issue in South Asia. In 250 BC, in response to the Kalinga war between Asoka's empire and Kalinga Empire, the great Buddhist emperor banned torture. In 12th & 13th centuries, the Kandyan Kings of what is now Sri Lanka abolished capital parliament in their realm.

The constitution of India 1950 is the supreme law of the land in India. It establishes the basic frame work of the Government, delineating the division of power between the Central & State Government, & establishes the functions of various governmental organs, including the judicial

The part III of the constitution guarantees an array of fundamental rights. Individuals can enforce these rights in courts when they are violated by the action or inaction of a government authority or official, but not when they are violated by other private individuals or companies. However certain fundamental rights are enforceable against private individuals as well. Article 14, Right to Equality, is the basic Fundamental right enshrined in the constitution. The core of the Article 14 is 'Equality before law'. Every person in India regardless of his or her socials, political, or economic position is equally subject to the jurisdiction of the courts, 'Equal protection of laws' is the twin sister of 'Equality before law'. It means that every person should enjoy the protection of the law without adverse discrimination or special treatment. 'The more simple way to put it is, the law will provide like treatment for people in similar circumstances'.

Article 19, Right to freedom, is one more prominent fundamental right. It provides various freedoms. Freedom of speech expression, assembly, association, movement, residence & profession. However none of these rights is absolute. Each may be curtailed by law in the interest of the general public, security of the state & public order.

Article 20 guarantees certain protections against conviction for offences. It says that a person can only be convicted of an offence if the act charged against him or her was an offence centes the law on the date of the commission of act. It further provides that person shall be punished for the same offence more than once. It also provides protection against self- incrimination, protecting an accused person from being compelled to be a witness against him or herself.

Article 21 is one of the most important constitutional provisions. It confers on every person right to life & personal liberty, & the Supreme Court has interpreted Article 21 to be very broad in scope. Article 21 has been interpreted to guarantee right including rights of prisoners, the right to legal aid, the right to speedy trial & the right to claim compensation for the violation of the rights in

Article 22, deals with protection against arrest & detention, & is important for its direct & immediate bearing on the rights of the accused & detainees in Indian law. It provides that a person who is arrested be informed, as soon as may be, of the charges against him or her & provided with the right to obtain counsel. Furthermore, it provides every person who has been arrested with the right to be produced before the nearest magistrate within twenty four hours of arrest. Article 23 lays down prohibition of traffic in human bengs & forced labour.

The last but not least, Article 32, provides 'Right to constitution remedies'. Article 32 confers the right to take proceedings in the Supreme Court for enforcement of fundamental rights. It empowers the Supreme Court to issue direction orders or writs, including the writ of habeas corpus. Article 226, empowers the High Courts to make such orders for the enforcement of fundamental rights.



LANCET editorial on India's fight against Covid biased and misguided

read the editorial in The Lancet titled 'Indias Covid-19 emergency published on May 8, 2021.

Let me quote from the article,
"India will see a staggering 1 million deaths from COVID-19 by Aug 1. If that
outcome were to happen, Modi's Government would be responsible for presiding
over a self-inflicted national catastrophe."

over a self-inflicted national catastrophe."

It is reminiscent of news reports in the British colonial era in India. To justify their forceful occupation of India, there was an orchestrated attempt of the western media and their political leadership to portray India as the country of fakirs and snake charmers that didn't deserve independence.

When India's Independence Bill was being debated in the British Parliament in 1947, Winston Churchill had angrily remarked, "Power will go into the hands of rascals, rogues, and freebooters."

rascals, rogues, and freebooters."

While the Covid crisis is indeed alarming in India, the article is suitable for a politically motivated tabloid rather than a reputed academic journal. As an Indian, I felt indignant with the vitriolic rant leading to poor portrayal of my country.

poor portrayal of my country.

Being in the frontline for last one year in Mumbai, I have been witness to death, disability, disaster and despair. I have lost several of my own near and dear ones. However, the issue is much larger than what the editorial conveys. The solutions are much more complex than one can imagine. It is time for an end game and not the blame

In order to create a sensation, the editorial mentions statistics of mortality and morbidity to suit the purpose. Mark Twain had once described three grades of lies – "Lies, damned lies, and statistics"!

Let me present the Indian statistics in a different manner. The USA with a population of 0.3 billion has lost 0.6 million citizens, Brazil with its 0.2 billion population has lost 1.5 million lives, the UK with its population of 0.06 billion lost 127,000 citizens and France with a population of 0.06 billion lost 106,493 of its citizens.

India, with its 1.3 billion population, has lost 262,000 Indians and I accept that the numbers are likely to rise further. One may argue about under reporting in India due to low Covid testing in many parts of the country. Therefore, let's look at the case fatality ratio (CFR) – the number of deaths divided by the number of confirmed cases. India's CFR of 1.1 per cent is less than

India's CFR of 1.1 per cent is less than that of the US, France, Italy and Germany. India's Covid-19 recovery rate is among the highest in the world. However, this cannot be a reason for any complacency.

The US started vaccination on December 14, 2020 and vaccinated 256 million people to date. The UK started its vaccination drive on December 21 and vaccinated 53 million till now. Australia started on February 22 and vaccinated 2 million till today.

India started its vaccinated 1811 today.

India started its vaccination drive on
January 16, 2021 and has vaccinated 180
million citizens as of today, which is nearly
9 per cent of its entire population.

There are more reasons to appreciate the Indian government. It lifted the ban on export of HCQ and exported HCQ and Paracetamol during the height of the epidemic. Despite shortage of vaccines in India, our government had the magnanimity to export 66 million doses abroad on humanitarian grounds.

The editorial makes several contradictory remarks and one of them says that the "local governments have begun taking disease-containment measures, but the federal government has an essential role in explaining to the public covid appropriate behavior".

The fact is that the government has launched a massive multi-pronged Covid awareness campaign and developed a dedicated portal to share all the statistics – https://www.mygov.in/covid-19.

I am also surprised that the author is unaware of the several viral genome sequencing data published by the Indian labs. Needless to say, this virus keeps mutating very frequently just like any other influenza virus. Contrary to the claims in the editorial, the central and state governments regularly conduct press conferences to share the emerging data or newer information

In India's federal structure, as per the Constitution, health care is a state subject. I do agree that dramatic reduction in the Covid case load during the winter led to a false belief that the pandemic was getting over.

I also agree that many states were not prepared for the second wave that turned out to be a Tsunami. Even if they had planned, it would be impossible to create an efficient system in less than six months.

States like Kerala, Maharashtra, Karnataka and Delhi that have better health-care systems suffered the most. If we take example of the worldwide mortality, the countries with the best health care infrastructure (the US, France, Italy etc.) seemed to have the highest mortality. In short, biology trumped technology and pharmacology

With virtually no effective medical treatment currently available, state and central governments have resorted to lock-down multiple times in this entire pandemic. The arm chair critics may not realize that lockdowns are politically challenging decisions. Let us not forget that these measures have profound socio-economic impact that may turn out to be more hazardous than Covid itself especially among the impoverished groups.

I am appalled by the editor's statement that "government's attempts to stifle criticism and open discussion during the crisis are inexcusable".

I am confident that the editor has never watched the Indian television debates where such criticisms are made. In fact, the vehement criticism of the Indian vaccines by some political parties made some gullible citizens believe that the vaccines were useless, leading to lukewarm response in the beginning.

Now let's discuss about the large political rallies and failure of the Election Commission of India in deferring the polls. The editor blamed the Indian government for failing to heed the warning of the second wave of the pandemic. If that is the case, predictions are being made of a much larger third wave in India. Will the editor please let us know when India could have conducted the elections safely? Is the author aware of the consequences of indefinite postponement of elections in the politically sensitive states of West Bengal, Tamil Nadu and Kerala?

I agree that the Kumbh Mela shouldn't have been held this year and it could have



been the super spreader event. Kumbh Mela is one of the largest voluntary religious congregations of human beings on earth that happens every 12 years in the months of January to April. Let me share some more information to put things in perspective.

The entire Kumbha area was spread over 150 sq km and over 9 million people voluntarily visited it between January and April 2021. The maximum number of people visiting the Kumbh area on a single day was 3.5 million. On that day of peak foot fall, the population density in the Kumbh area was estimated as nearly 23,000 people per sq km.

With nearly 17 and 13 million population, respectively, Delhi and Mumbai are India's two largest cities. The population density of Mumbai is approximately 30,000 per sq km, of which nearly 40 per cent live in the slums. That means Mumbai and many metropolitan cities lives with Kumbh like situation every day. Dharavi, a locality in Mumbai, is Asia's largest slum that has a population density of nearly 277136 per sq km. Compare it to London that has a population density of 6000 people per sq km.

Mumbai's local trains, the life line of

Mumbai's local trains, the life line of the city, carry 7.5 million people (population of Hong Kong) every day with nearly 6,000 passengers packed into a 12-car rake during the peak hour. When the lockdowns were lifted during the pandemic (February and March, 2021), nearly 4 million passengers travelled every day in the Mumbai local trains.

While the developed world may look down upon these as uncivilised conditions, it probably gave this population a distinct advantage. In August 2020, a seroprevalence study reported presence of antibody among 54 percent of the slum population and 16 percent of the non-slum population.

The study concluded that asymptomatic spread of the infection led to significantly lower infection fatality rate among slums compared to non-slums. The reasons why slum dogs fared better than the millionaires were because of the population density, poor hygiene and non-adherence to Covid appropriate behaviour.

Similar high prevalence of protective antibodies was reported in the other parts of India as well – Delhi (56 per cent), Mumbai (up to 75 per cent), Hyderabad (54 per cent) and Bengaluru (57.9 per cent). In contrast, the highest level of anti-

In contrast, the highest level of antibody achieved in New York, London and Paris was 20 per cent, 13 per cent and 12 per cent, respectively. Is Indian's high level of herd immunity responsible for the low case fatality rate?

Herd immunity (also called population immunity) is due to the presence of antibodies that occurs when a population acquires it through either the infection (asymptomatic or symptomatic) or vaccination.

While I admit that allowing infection to ravage the population is not the best way to achieve Herd immunity, it is also true that long term safety and efficacy of the vaccine is presently unknown.

Murmurs are already happening in the scientific community that the concept of natural herd immunity is being actively suppressed to promote vaccine companies. Having said that, with vaccine as the only hope to combat the spread, it is time to make it more affordable and accessible.

Ironically, while thousands are dying every day, Word Trade Organization has failed to prevail upon member countries to waive patents and intellectual property rights linked to vaccines and technologies. The waiver is being fiercely opposed by many developed countries such as the UK and the European Union. Even an international association of pharmaceutical manufacturers warned WTO that waiving the patents and copyrights will be counterproductive and dangerous.

Politicians have become the favourite punching bags for the journalists who are desperate to hit the headlines. Bad journalists always scour through the speeches of politician and pick up the most sensational sentence to create a narrative that suits them.

With hopelessness all around, society tends to hold the political leadership as the ultimate cause of their miseries. I agree that political leaders are accountable and they cannot shift the blame for this failure. However, there are many stakeholders in this pandemic whose accountability needs to be questioned. How about those researchers whose misleading recommendations were later proven to be ineffective or even harmful? What about those journals who shortened the publication pipeline to improve citation index only to end up with substandard articles? We can't forget the retraction of an article from a reputed journal claiming effectiveness of HCQ.

We still remember the allegations of pharma industry – journal nexus in publishing pharma funded studies of questionable benefits. What about the pharma companies who failed to communicate about lack of efficacy or appropriate usage while selling lopinavir, ritonavir, oseltamivir, remdesivir, interferons, tocilizumab, hydroxychloroquine, azithromycin etc? Will the scientists, institutions and the rich nations apologize to the world for holding on to the patents/copyrights of the lifesaving drugs and equipment while thousands die every day?

The Lancet editorial made a ludicrous statement that the "government has seemed more intent on removing criticism on Twitter than trying to control the pandemic". It is obvious from my narration above that India has done the best it could do.

The Lancet editorial seemed to be solely for the media attention and trending on twitter while maligning India globally. In the word of German Scholar, Max Mueller, "If I were asked under what sky the human mind has most fully developed some of its choicest gifts, has most deeply pondered on the greatest problems of life, and has found solutions, I should point to India." Wait till India recovers, it will lead the world soon.

"Our brains sculpt who we are and the world we experience...Neuroscientists have their work cut out for them because the brain continues to mystify as if it were a distant planet light years away," writes Dr Sanjay Gupta, CNN's Emmy Awardwinning Chief Medical Correspondent, in "Keep Sharp - Build a Better Brain at Any Age" (Headline Publishing Group) that also contains a brain training programme at whose core is the S.H.A.R.P. protocol.

The brain is "arguably the most enigmatic 3.3 pounds of life. Researchers even found a new kind of neuron recently -- the rosehip -- and still don't know what it does. It seems to exist only in human brains but not in rodents, which may explain why so many mice brain studies never translate to humans. Our brains can be extraordinarily selfish and demanding as well. Of the total blood and oxygen that is produced in our bodies, the brain steals 20 percent of it, despite being only roughly 2.5 per cent of your body weight. There can be no life without a brain".

"Time to meet your inner black box," writes Gupta, who, in 2009, at the beginning of the Barack Obama administration, withdrew himself from consideration as the US Surgeon General for professional and per

sonal reasons.

Along the way, he debunks common myths about ageing and cognitive decline, explores whether there's a 'best' diet or exercise regimen for the brain, and explains whether it's healthier to play video games that test memory and processing speed, or to engage in more social interaction.

Discover what we can learn from 'super-brained' people who are in their 80s and 90s but show no signs of slowing down and whether there are truly any benefits to drugs, supplements and vitamins. Gupta also addresses brain disease, particularly Alzheimer's, and answers all your questions about signs and symptoms, and shows you both how to ward against it and how to care for a partner in cognitive decline.

The key to moving ahead, the author writes, is mastering the S.H.A.R.P. protocol: Slash the sugar, Hydrate smartly, Add more omega-3s from natural sources like wild cold-water fish, Reduce portions, Plan meals ahead.

Once you have done so, you're ready for the 12-week regime that will help you achieve five important goals:

* Move throughout your day and build an exercise routine into your life. * Find new ways to stimulate your

* Find new ways to stimulate your brain through learning and challenging your mind.

* Prioritise getting restful, routine

sleep at night and incorporate daily destressing practices into your routine.

* Introduce a new way of nourishing

your body.

* Connect authentically with others and maintain a vibrant social life.
So, let's get down to brass tracks.

"I've designed this programme to be as practical and easy to follow as possible. Most important, it will end up being tailored and highly individualised for you," Gunta writes

Weeks 1 and 2: Dive into the five. Move More; if you already exercise regularly, keep it up but try something different to surprise your body and use new

Love to Learn by participating in cognitively stimulating activities. Sleep hygiene; if you get fewer than six hours of sleep per night, you can start by increasing this to at least seven hours - the





bare minimum if you want to have normal, healthy functioning physiology from your brain on down.

Eat Sanjay Style. As the author explains, he eats "only when the sun is shining". Some have called this chrono eating - 'chrono' meaning relating to the body's sense of time and its circadium rhythm throughout the twenty-four hour solar day. I believe when you eat is also important, not just what you eat".

Connect with People; elevate your social life. For those who feel isolated, call someone you haven't spoken with in a while and invite a friend over for dinner.

Weeks 3 and 4

Add more to your routine by choosing at least two of the following options: A 20-minute power walk after lunch most days of the week, have at least two of your meals each week feature cold water fish like salmon or trout, download a meditation app and use it daily, avoid colas.

Weeks 5 and 6

Add more to your routine by choosing at least three of the following options: Start a gratitude journal and list at least five people or situations you are grateful for, add 15 more minutes to your exercise routine, try a yoga or Pilates class, avoid all processed foods, add a relaxing activity to your bedtime routine such as engaging in mindfulness medication.

s medication. Weeks 7 and 8 Add more to your new routine by checking off all five of the following ideas: Look for opportunities to volunteer in your community, schedule a check-up with your doctor if you haven't had one within the year, write a handwritten letter to a younger loved one in the family, read a book in a genre or subject area that interests you but that you're not used to reading.

Weeks 9 and 10

Ask yourself the following questions and adjust accordingly based on your answers: Am I getting at least 30 minutes of exercise at least five days a week, am I learning something new that challenges my mind and demands developing different skills, am I getting more restful sleep on a regular basis and managing stress better, am I following the S.H.A.R.P. dietary protocol, am I connecting with friends and family members regularly?

Week 11

Think about how you'd want your family members to deal with a diagnosis of dementia, including Alzheimer's disease.

Make a list of all things you've done differently these past several weeks and ask yourself: What worked? What didn't work? Where can I improve? Then use the week to

"Keep the big picture in mind at all times. This will help you not only maintain a healthy lifestyle but also get back on track if you occasionally cheat. It's a cliche, but it's true. Progress is better than perfection," Gupta writes.

"There will always be a place for good old-fashioned habits like eating more vegetables and working out regularly. But for those time-tested habits coupled with what's in store for us tomorrow will ultimately make for the best life - one that we will want to remember and will be able to remember. Keep sharp," Gupta concludes.

Maximum casualties reported in Maharashtra (974), followed by Karnataka with 403 daily deaths. As per the government data, 6,91,211 people were vaccinated on Sunday, taking the total number of people vaccinated to 18,29,26,460. The CoWIN digital portal has been reconfigured to reflect the change in dose interval of Covishield vaccine to 12-16 weeks. However, the already booked appointments for the second dose of Covishield will remain valid and will not be cancelled by CoWIN. "The cancellation of the selection process was challenged by the appellants by invoking the extraordinary jurisdiction of the Court. The writ Court dismissed the petition recording that as the petitioners were only prospective candidates, they have not acquired any indefeasible right to seek selection/appointment on the basis of the advertisement alone and therefore the cancellation of the selection process do not infringes any of their legal right." a division bench of Chief Justice Pankaj Mithal and Justice Vinod Chatterji Koul.

"There is no arbitrariness in the cancel lation of the selection process as the court records that it stands admitted to the appellants that the respondents (bank) had the authority to cancel the selection process.

The division bench observed that the stand of the bank that the recruitment process in question had gone wrong "stands substantiated by the records.

'The respondents (bank) have construed the recruitment district wise and framed the merit list accordingly. Moreover, the respondents have not applied a rule of reservation in selection process which certainly was incurable," the court said, adding, "Therefore, the cancellation of selection process is justified and is not arbitrary."

As regards the argument that reservation is not applicable, the court said it is a debatable

However, the court said that in such circumstances if the process as a whole has been cancelled it cannot be said to be illegal or arbitrary. (GNS)

The Committee was constituted by the Jammu and Kashmir government following an order by the Supreme Court on March 23, 2020 and May 07, 2021, directing the States and the UTs to decongest jails to ensure social distancing among the prisoners.

At the outset, the Committee appreciated the efforts of the prison department for not only managing the COVID-19 breakout in the prisons but also for maintaining hygiene in the iail premises. The Members of the Committee discussed and deliberated upon the proposed category of prisoners, who may be considered for grant of interim bail for 90 days in view of the present circumstances. The Committee decided to release all the jail inmates who were earlier released on parole or on interim bail for 90 days as per the directions of the Supreme Court in March 2020. Justice Magrey directed the Member Secretary, J&K Legal Services Authority to coordinate with the other two members of the Committee to find out the category of convicts/UTPs who can also be released pursuant to the directions of the Hon'ble Supreme Court. Such an exercise shall be completed within a week and the report be placed before the Committee. Justice Magrey directed the DGP (Prisons) to coordinate with the Health department to ensure vaccination of jail inmates as well as staff on priority. Besides this, the Committee directed the jail authorities to take appropriate steps by ensuring that the inmates and the staff wear masks and maintain social distancing and by keeping the frequently visited areas like kitchen, bathrooms etc. hygienic to prevent the spread of Covid-19.

Justice Ali Mohammad Magrey, further directed the Legal Service Institutions across the UT of J&K to provide the services of Panel Lawyers to the inmates who are eligible to be released from the custody by moving applications on their behalf.

It also called for the additional release of prisoners on paroles or interim bail orders for which DGP Prisons and member Secretary JKLSA were asked to workout modalities with in the stipulated time.

The Committee also suggested the creation of additional accommodation or temporary accommodation within or outside jail complexes for ensuring strict adherence to Standard Operating Protocols (SOPs) of COVID-19 issued by the medical experts.

Further, the high powered committee also decided to discontinue all the visits of outside visitors including NGOs but while doing so the families of the jail inmates will have excess to meet the prisoners by use of virtual mode or by

Frequent sanitization of jails and better medical facilities were also decided to be ensured in all the jails of J&K.

The Committee decided to accelerate to hold awareness campaigns among jail inmates regarding SOPs to prevent the spread of CO-VID-19 pandemic. The Committee further decided to ensure safety of prisoners by frequent testing and complete vaccination of jail inmates along with the jail staff. It also called for measures like transportation of released M inmates by providing them proper transport \forall \tag{ facilities in view of Corona curfew.

Speculation has run high that Samsung would reveal its US investment upon the summit between South Ko-rean President Moon Jae-in and US President Joe Biden to be held in Washington on

Samsung, the world's largest memory chip producer and No. 2 foundry firm, has been mulling building a \$17 billion foundry factory in the US, with Texas, Arizona and New York mentioned as possible candidate sites, reports Yonhap news agency.

Kim Ki-nam, who heads Samsung's chip business, is expected to visit the U.S. as a member of President Moon's business delegation for the summit and may confirm the plan after meet



ing with U.S. officials, sources here said.

Samsung was the only South Korean firm to join a White House online meeting last month to discuss global semiconductor shortages. The company has reportedly been invited again to a virtual meeting to be hosted by U.S. Commerce Secretary Gina Raimondo on Thurs-

day. The tech giant already runs a chip facility in Austin, Texas, but the need for emerged after its rivals moved ahead for capacity

expansions. Semiconductor Taiwan Manufacturing Co (TSMC) recently announced that it will invest \$100 billion over the next three years for ca-

pacity expansion. The world's top contract chip maker already unveiled last year it would set up a \$12 billion plant in Arizona, but speculation has been growing that the company may build five additional fabs with ad-

vanced nodes. Intel, the world's leading semiconductor seller, also announced that it will invest \$20 billion to expand its chipmaking capacity and teased its re-entry to the foundry business.

Samsung's US investment will also be in line with its vision of becoming the world's No. 1 player in the logic chip and foundry sectors by 2030. The company last week said it will spend an additional 38 trillion won to expand its previous investment plan of 133 trillion won unveiled in 2019.

Credit card expenses by Indian subsidiary of a multinational corporation liable to GST

New Delhi, May 17: Credit card expenses made by employees of an Indian subsidiary for furtherance of business here would come under the purview of Goods and Service Tax (GST) with applicable 18 per cent rate.

According to a recent ruling by Tamil Nadu Appellate Authority for Advance Ruling (AAAR), any expenses made by employees of an Indian subsidiary of a multinational corporation that is later reimbursed by the overseas holding company qualifies as service and hence needs to be taxed un-

der GST here. The AAAR termed reimbursement of credit card expenses made by employees of Indian subsidiary by the overseas holding company as advance for any such service extended by its Indian operations. As business services are taxable, so such ex-



The AAAR ruling came on case concerning ICU Medical India LLP, a subsidiary of ICU Medical Inc.

Apparently, the holding company had provided credit cards to the employees of its Indian subsidiary for business expenses that were required to be made in India and abroad. Any such expenses made was later reimbursed by the holding company.
The AAAR termed such transition to qualify as supply of service. Further, the said services qualify as import of services and there-

fore the subsidiary is liable

to pay 18% GST.

The AAAR ruling would set the precedent for applicability of GST on all such similar transaction between the parent overseas entity and its Indian subsidiary.

Bank NEFT transfers will not be operational coming weekend

Mumbai, May 17: If you planning an online money transfer using the banking system between Saturday midnight and Sunday, you are well advised to either cancel or postpone such transfers.

The Reserve Bank of India (RBI) on Monday said that due to NEFT system upgrade, this service will not be available from 00:01 hrs to 14:00 hours on Sunday, May 23, 2021. This would mean that dur-

ing this period any money transfer involving NEFT system would not be available for use by bank customers. But, the RTGS system will continue to be operational as usual during this

It may be mentioned that a similar technical upgrade for RTGS was completed on April 18, 2021.
"A technical upgrade of

NEFT, targeted to enhance the performance and resilience, is scheduled after the close of business of May 22. 2021. Accordingly, NEFT service will not be available from 00:01 hrs to 14:00 hrs on Sunday, May 23, 2021," an RBI communication to banks said. The communication advised banks to inform their customers to plan their payment operations accordingly.

Are OMCs shifting to alternate day fuel price revision mechanism:

New Delhi, May 17: Oil marketing companies seem to be moving towards a revised fuel price revision mechanism, shifting to the practice of changing petrol and fuel rates every alternate day rather than undertaking changes on a daily basis.

In the last few days, pump prices of petrol and diesel have been revised every alternate day but the practice had not helped consumers as even under this system prices have only moved up making the fuel dearer.
On Monday, OMCs kept retail price of petrol and diesel unchanged. So pet-

rol still costs Rs 92.58 per litre and diesel Rs 83.22 per litre in Delhi, the same as previous day. Across the country as well, the petrol

and diesel price prices remained static on Monday but its actual retail prices varied depending on the level of local levies in respective states

The price pause on Monday came after petrol and diesel prices were raised by 24 and 27 paise per litre, respectively, on Sunday. Prior to Sunday, there was no price revision on Saturday. Similarly, while fuel prices were raised on Friday, it remained unchanged in the previous day.



"It seems oil companies are giving a sense of relief to consumers as fuel prices are not being raised on a daily basis. But still prices are not actually falling but being raised on very alternate day too this month," said an oil sector expert not willing to be named.

He said that the practice of daily price revision, started after deregulation of petrol and diesel prices few years had been done away by OMCs for past several months giving clear indication that administrative price regime is still working for the sector. Under daily price revision, OMCs

revised petrol and diesel prices every morning benchmarking retail fuel prices to a 15-day rolling average of global refined products' prices and dollar exchange rate. However, in a market where fuel prices need to be increased successively, alternate day price revision seems to be the flavour.

It is worth noting that with 9 price increase in May, the retail price of regular petrol has already reached closer to Rs 99 a litre in Mumbai. Petrol prices are already over Rs 100 per litre in several cities in Madhya Pradesh, Rajasthan and Maharashtra, Premium petrol has been hovering above that level for some time now.

Petrol prices have increased by Rs 2.03 a litre Delhi in May in the nine increases so far. Similarly, diesel prices have risen by Rs 2.49 per litre in capital this month. IANS had reported earlier that OMCs may begin increasing the retail price of petrol and diesel post state elections as they were incurring losses to the tune of Rs 2-3 per litre by holding the price line despite higher global crude and product prices.

With global crude prices at around \$ 69 a barrel mark, OMCs may have revise fuel prices upwards again if there is any further firming up.

Vedanta calls for EoI to transport 800 tpd 02 from Sterlite unit

At UNSC, India condemns rocket attack that killed Indian nurse

United Nations, May 17: While mourning the death of an Indian nurse in Israel, India's Permanent Representative T. S. Tirumurti on Sunday condemned the rocket attacks from Gaza that killed her.

Speaking at a rare Security Council meeting held on a Sunday, he, however, also reiterated India's support for the Palestinian cause and condemned the retaliatory attacks by Israel.

Soumya Santosh, who is from Kerala, was killed in Ashkelon inside Israel by the rocket launched reportedly by the Iran-backed Hamas organisation from Gaza last week. She was working as a caregiver for the elderly.

The Council met in a vir-

tual session as the situation in the Israel-Palestine-Gaza region spiralled into a violent crisis, with reports that before the session, Israeli air strikes had killed at least 40 people, some of them chil-

At least four people were killed in Israel as some Hamas rockets pierced Israel's Iron Dome anti-missile defence system.

Referring to Santosh, Tirumurti said: "India has also lost one of her nationals living in Israel in this rocket fire -- a caregiver in Ashkelon. We deeply mourn her demise along with all other civilians who have lost their lives in the current cycle of violence.

indiscriminate rocket firings from Gaza targeting the civilian population in Israel, which we



condemn, and the retaliatory strikes into Gaza, have caused immense suffering, and resulted in deaths," he

While reiterating New Delhi's "strong support to the just Palestinian cause and its unwavering commitment to the two-State solution", Tirumurti also expressed "strong condemnation of all acts of violence, provocation, incitement, and destruction".

He called for an immediate de-escalation of the situation to stop "any further slide to the brink" and the resumption of dialogue between the parties to the conflict.

He said that Jerusalem has a special place in the hearts of Indians and added that attempts should not be made to change the status quo in East Jerusalem and its neighbourhood.

He mentioned the presence of an India-associated in Jerusalem's old city. New Delhi had restored the Al Zawiyya Al Hindiyya, the

Indian hospice associated with Indian Sufi saint Baba Farid, he said.

The holy places in Jersualem, including the Haram al-Sharif, also known as the Temple Mount, that is sacred to Muslims, should be

protected, he added.

The triggers for the current wave of violence is the attempt by some Israelis to evict Arabs from homes in East Jerusalem and the entry of Israeli security forces

into the Temple Mount.
At the UNSC session presided over China's Foreign Minister Wang Yi, Secretary General Antonio Guterres said: "Fighting must stop. It must stop immediately. Rockets and mortars on one side and aerial and artillery bombardments on the other must stop. I appeal to all parties to heed this call."

"It has the potential to unleash an uncontainable security and humanitarian crisis and to further foster extremism, not only in the Occupied Palestinian Terri-

tory and Israel, but in the region as a whole," he warned. He drew attention to the Israeli bombing of the offices of the US news agency Asso-ciated Press and Qatari TV network Al Jazeera in Gaza City and said: "Journalists must be allowed to work free of fear and harassment.'

"I am appalled by the attack on a refugee camp in Gaza, in which 10 members of one family were killed. Humanitarian installations must be protected," he said, but added: "Israeli civilians live in fear of rockets launched from Gaza."

Holding the meeting on a Sunday itself showed the isolation of the administra-tion of US President Joe Biden which had vainly tried to stop the Council from discussing the situation. After blocking a session on Friday, it was forced by other members to agree to the meeting on Sunday.

Biden is facing a split in his party over his Israel policy with a vociferous group

of Democrats condemning his backing for that country, even as many in the party continue their strong support for Israel.

US Permanent Representative Linda Thomas-Greenfield said that "the United States has been working tirelessly through diplomatic channels to try to bring an end to this conflict" and is "intensively engaged with Israeli, Egyptian, and Qatari officials, as well as the Special Coordinator (of the UN, Tor Wennesland) and his team - all of whom are working to define and establish conditions for a sustainable calm".

In a break from the four years of former President Donald Trump, she, however, called for an end to "evictions" - including in East Jerusalem - demolitions, and settlement construction east

"Critically, all parties need to uphold and respect the historic status quo at the holy sites," she added.

Without condemning any of the attacks by either side Thomas-Greenfield said: "We've also been alarmed by violence impacting journal ists and medical personnel. whose roles are crucial and must be protected and re-

"It's time to end the cycle of violence. The United States calls on Hamas and other Palestinian groups in Gaza to immediately halt rocket attacks and other provocations. UK further eases Covid-19 restrictions

London, May 17: People in England, Scotland and Wales can now sit indoors in pubs and restaurants and can hug each other again, in the biggest single lifting of coronavirus restrictions since the start of the UK's successful vaccination campaign. While bars and restaurants in England and

Wales are reopening their indoor seating areas for the first time in months on Monday, Scottish venues where this was already possible can now serve alcohol indoors again, reports dpa news agency.

Larger groups of people in the three na-

tions can also meet socially: for indoors the limit in England is now up to six people or two households; for outdoors the maximum is 30.

After consistent guidance since spring last year to avoid direct contact with people not in their own family or so-called "support bubble", UK Prime Minister Boris Johnson advised citizens that they can now make

their own "informed decisions" and be "cautious" when it comes to hugging loved ones.

Other recreational venues such as cinemas, museums, theatres and concert halls are also allowed to reopen in England, Scotland and Wales, although there are capacity limits on large events.

A highly anticipated lifting of the international travel ban has gone into effect in England and Wales, allowing people to travel based on a traffic light grading system.

For "green" countries, British travellers do not have to quarantine when they return home if they test negatively for coronavirus; "amber" or "red" countries mean people do have to quarantine, in the latter case in specific government-approved hotels.

Green list countries include Australia, Brunei and New Zealand, but also countries closer to home include Portugal and Iceland. Two areas of Scotland, Glasgow and Mo-

ray, will maintain stricter restrictions, such as no meeting in private homes and maintaining social distancing, due to a rise in cases of the coronavirus.

Colombian protest leaders present demands to govt

At least 42 people have



died during the protests, according to the latest figures from the national ombudsman's office.

The strike committee has counted at least 50 deaths and more than 500 missing

The country's Defence Ministry says around 1,700 have been injured so far, including more than 900 security personnel.

The protests were initially against a controversial tax reform that has since been withdrawn. Most demonstrators have now turned to other issues, such as opposing a planned health care reform and advocating for the country's fragile peace

The Economy Minister and Foreign Minister have both resigned as a result of the protests.

ICCC president Vijay Thomas said their initiative aims at garnering donations not only from the 1.6 million Indo-Canadian community, but also businesses and cities across Canada.

"The money will be used to send oxygen concentrators and generators and we will find new pathways to send oxygen to India. We want to ensure that oxygen reaches tier 2 and 3 cities and towns before they get severely hit by the virus, Thomas said.

Saudi Arabia to lift travel ban from Monday

Riyadh, May 17: Saudi Arabia will lift the travel ban which was imposed last year in the wake of the Covid-19 pandemic from Monday, with authorities saying that they were ready to operate international flights

at full capacity. In an announcement on Sunday, the Interior Ministry announced that May 17 will mark the full opening of all borders - air, land and sea, reports Xinhua news agency.

The Kingdom will allow people who received Covid-19 vaccines to travel along with those who recovered from infection in less

than six months, it said. The decision was based on the recommen-

dations by the competent health authorities. Some categories of passengers will be excluded from the quarantine, including Saudi citizens, their spouses and children. Along with passengers who received Co-

vid-19 vaccines, official delegations, as well

as diplomats and their families residing with them will also be excluded from the institutional quarantine. But the excluded categories, except for the vaccinated individuals, will be required to undergo home quarantine, with an empha-

sis on the need to obtain a valid health insur-

ance policy to cover the risks of the corona-

Meanwhile, Saudi Arabian Airlines said in a statement that it has completed preparations to operate flights to 71 destinations from 95 airports, including 28 domestic and 43 international destinations, reports Arab

The General Authority of Civil Aviation said that around 385 flights are expected to operate throughout the Kingdom's airports on Monday.

The Interior Ministry however, added that said travel to a number of Covid-affected countries, directly or via another nation, is still banned without prior permission.
The countries are India, Libya, Syria, Leb-

anon, Yemen, Iran, Turkey, Armenia, Somalia, the Democratic Republic of the Congo, Afghanistan, Venezuela and Belarus.

Aid ship rescues over 300 people in Mediterranean

Rome, May 17: The aid ship Sea-Eye 4 has rescued about 330 migrants attempting to make the perilous journey across the Mediterranean in the past few days, the private vessel's German operator announced on

The latest rescue operation conducted overnight brought 99 people on board, most of whom said they are from Syria, dpa news agency quoted Sea-Eye as saying on Twitter. The crew was now nearing "the limit" of their capacities to care for the rescuees, Sea-

Eve wrote. The Sea-Eye 4 set out last last week and has been picking up migrants travelling on boats unfit for the high seas

Among the people brought aboard the vessel at the weekend were children, an eightmonth-old baby and a pregnant woman, the group said.

The ship, refitted in the northern German port city of Rostock and belonging to the association founded in Regensburg, Bavaria, in 2015, had started its mission to rescue distressed migrants in the central Mediterranean Sea at the beginning of the month.

The mission is supported by United4Rescue, the Alliance for Civilian Sea Rescue, and the aid organization German



According to UN figures, more than 500 eople have died so far this year until the beginning of May trying to cross the central Mediterranean to Europe, usually departing from Libya and Tunisia and aiming for Italy.

The private sea rescuers criticize the Libyan coast guard for intercepting boat migrants and bringing them back to the wartorn country, where they are threatened with human rights violations.

Politically, however, the rescue operations of the private organisations are controversial, with some claiming they encourage the illegal smuggling of people across the Medi-

'Death rate higher': Assam CM asks senior docs to work late night

Guwahati, May 17: With the Covid related mortality rate seen higher in the night, Assam Chief Minister Himanta Biswa Sarma on Sunday asked the authorities to engage senior doctors on duty at this time. Sarma, and Health Minis-

ter Keshab Mahanta have been conducting surprise and frequent visits in different medical colleges, hospitals and Covid care centres across the state to supervise the Covid management.

After making a surprise visit to the Gauhati Medical College and Hospital, Sar ma, who had held the health portfolio during the previous Sarbananda Sonowal government, told the media that it has been one of the priorities of the government to step up critical care services during the night and odd hours in all the medical colleges and main hospitals of the state.

The Chief Minister also ex-



pressed his gratitude to doctors, nursing staff, and other paramedical staff for their round-the-clock services.

In view of the rising cases of Covid-19 and its cascading effect on Assam, Sarma asked the Superintendents of Police in all 34 districts to sternly enforce the preventive directives for containment zones to reverse the strengthening containment of Covid-19.

Sarma also asked the Deputy Commissioners to ensure delivery of critical care treatment to the Covid patients during odd hours in their respective districts. He asked them to visit Medical College Hospitals and Civil Hospitals in their respective

jurisdictions.
The Chief Minister asked them to arrange conveyance for transportation of Covid positive patients from their home to Covid care centre, and provide essential com-modities worth Rs 2,000 to the poor people living in containment zones.

The number of active cases in Assam rose to over 43,377 on Sunday night. Assam has so far reported 3,28.629 Covid cases, while 2,179 persons have succumbed. Of the 34 districts in Assam, the situation in three districts -- Kamrup Metro, where the active case tally stood at 1.197 on Sunday night, followed by Cachar (262) and Dibrugarh (240) -- is serious.

The statement said that the chargesheet against the five persons against whom Prosecution sanction is received is being submitted in court.

The CBI had earlier arrested IPS officer SMH Meerza in connection with the case, who is presently out on bail. He is the fifth accused.
The CBI said that it has

received the prosecution sanction against the four arrested leaders on May 7.

Meanwhile, State Transport Minister and former Kolkata Mayor Hakim told the media after he was arrested from his Chetla home in South Kolkata earlier in the day, "They have not given any notice and now they have arrested me. They didn't even seek the permission of the Speaker. We will fight it in the court.'

Along with Hakim three others were brought to the CBI regional office at Nizam Palace in the morning.

The CBI officers with large central forces went to the houses of the leaders and the ministers in the morning at around 9.30 a.m. and brought them to the regional office without even allowing them to speak to their law-

Sisodia told the press that the Delhi government has requested the Centre to provide vaccines for 18-44 age groups at least equal in number to the doses provided for the 45 and above age groups.

"We want to vaccinate both sections (18 to 44 and 45 and above) at the same time so that all age groups of people in Delhi can be administered vaccines before the third wave of Covid pandemic starts," he added.

"The allocation of vaccines

is being done under the supervision of the Centre and we have requested the Centre to make the system transparent. All states must be aware of how many vaccines they would be getting and how many vaccines other states would be receiving at the same time. The Centre should also direct vaccine manufacturing agencies to maintain transparency in allocating vaccines for the government (states and the Centre) and to the private

agencies," Sisodia added. The Delhi government has also requested the Centre to inform it about the number of vaccines to be supplied in the months of June and July so that the state administration can prepare for the vaccination drive.

Covid medicines case: Delhi HC questions police's clean chit to politicians

Asking it to act with responsibility, the bench told the Delhi Police: They have no business to buy medicines and hoarding them to earn some goodwill. Now it seems that you are not interested in getting out the truth.'

Nadal beats Djokovic for 10th Rome Open title



Rome, May 17: World No 3 Spaniard Rafael Nadal on Sunday won his 10th Italian Open title, after overcoming a second set comeback from No. 1 Novak Djokovic in the final to triumph 7-5, 1-6, 6-3 in two hours and 50 minutes.

The victory gave second seeded Nadal the 36th ATP Masters 1000 crown, equalling top seeded Djokovic's all-time record, since the series was established in 1990.

In the 57th meeting of the ATP Tour's one of the most prolific rivalries, Djokovic was facing second seed Nadal, winner of 20 Grand Slam singles title winner, for the ninth time at the Foro Italico.

Nadal improved to 4-2 in Rome finals against Djokovic with the victory, and brought his ATP head-



to-head record against the Serbian to 28-29 overall.

In the men's doubles final, second-seeded Croats Nikola Mektic and Mate Pavic powered their way to their sixth Italian Open trophy, overcoming a tough challenge from fifth-seeded Rajeev Ram of the USA and Briton Joe Salisbury and

winning the final 6-4, 7-6(4). Djokovic had spent nearly five hours on court on Saturday, first winning his rain-delayed quarter-final against Greece's Stefanos Tsitsipas and then the semi-final epic against Italian Lorenzo Sonego, to reach the final. Nadal, on the other hand,

needed an hour-and-a-halfto take down Reilly Opelka

Djokovic, who was bidding to record his first win on clay against the Spaniard

since the 2016 Rome quarterfinals, showed little signs of fatigue in the opening set.

The Serbian raced to a 2-0 lead, staying aggressive and keeping the points short. But Nadal broke straight and his forehand speed steadily climbed as the set unfolded, earning 15 of his 21 winners. Nadal claimed the deci-

sive break late in the set, taking advantage of a shaky service game of the Serbian at 5-5 to claim the lead, sealing the set.

But a dip in Nadal's intensity gave Djokovic the opening he needed in the

However, the Spaniard held firm and raised his level in the final set, reeling out forehand winners to take a 4-2 lead. He converted his second championship point after Djokovic sent a backhand long, sealing the victory.

Spark Sport customers watched over 3.4 million hours of cricket as the Blackcaps rose to the number one Test team in the world," it further said.

Williamson and other players and staff were in India for the Indian Premier League (IPL), which was suspended midway due to raging Covid-19 pandemic in India. They then went to the Maldives before flying out to England. After a successful county championship

stint with Durham, batsman Will Young will also link up with the team on Monday and undergo isolation at the Ageas Bowl be-

fore joining his teammates for training.

lation on Sunday and return to Mount Maunganui to see his family before a plan is made around his departure to the UK." it said.

"While in England they will operate in a 'controlled team environment' to limit outside contact and risk of transmission. All tour members will complete a daily self-reported health screening as well as undergo-ing regular Covid testing."

resigns after Nazi analogy

German football chief Keller

Berlin, May 17: German football federation (DFB) president Fritz Keller resigned on Monday after comparing vice president Rainer Koch to a Nazi

Keller, who at first resisted resigning, stated last week he was ready to leave his position after he compared Koch to Nazi judge Roland Freisler at a meeting in April. Further details of the comparison are not known.

In a statement, Keller said he was "taking per-sonal responsibility" for his "lapse at the executive committee meeting, which is to remain the sad low point of the DFB's desolate leadership situation", DPA reports.

Keller's apology earlier this month was not accepted by Koch, while he also lost a no-confidence vote from regional federation chiefs.

Freisler attended the Wannsee Conference, which set in motion the Holocaust. Later, he was appointed president of the People's Court, where he handed down around 2,600 death sentences from 1942 to 1945.

"The DFB must change. It must regain its credibility, confidence in its integrity and performance," Keller said, but pointing out he "resistance and walls" within the federation when trying to "professionalise and modernise" existing structures.

single sports federation in the world with more than 7 million members, has been scandal ridden for years most notably concerning the affair around dubious payments in connection with Germany's hosting of the 2006 World Cup.

Wolfgang Niersbach resigned as DFB president in 2015 over the World Cup affair, and his successor Reinhard Grindel quit in 2019 over accepting an expensive watch. Keller was Grindel's successor.

Keller said he didn't "succeed in achieving a trust-ing, reliable and collegial cooperation within the bodies of the DFB," and mentioned that after a second tax raid at DFB headquarters he realized that "far too often it was about internal power fights, securing advantages, and working on one's image in the public life."

He added that implementing his programme was re-peatedly made "difficult or impossible in many places.

had to fight legally for the implementation of transparency and for the right to be provided with information that were a matter of DFB interests,

Keller said. Keller acknowledged his misconduct was "shameful" for the federation, but his resignation "will not solve the problems within the DFB and football".

However, he said that the discussion about necessary changes at the DFB initiated in recent days gave him hope and called for short-term measures such as a personnel renew at DFB's highest ranks and the clarification of "all possible irregularities and misconduct at the DFB by external, publicly recognised specialists"

Last Tuesday, the DFB announced that the contract of secretary general Friedrich Curtius would be terminated.

ICC clears India's two home Tests of 'spot-fixing' influence

Dubai, May 17: The International Cricket Council (ICC) has cleared India's two home Tests -- against England in 2016 and against Australia in 2017 -- of any influence by spot-fixers, saying that a TV channel's allegations had 'fundamental weaknesses

The match against England was played in Chennai while the game against Australia was held in Ranchi.

The ICC has concluded its investigation into the documentary programme 'Cricket's Match Fixers' broadcast by Al Jazeera on 27 May 2018. No charges will be bought under the ICC Anti-Corruption Code against any of the five Participants to the Code who featured in the programme due to insufficient credible and reliable evidence," an ICC

statement said on Monday The ICC said that it hired four bet-



ting and cricket specialists to study the passages of play. The four, the ICC added, couldn't find anything wrong.

"To assess whether the passages of play highlighted in the programme were unusual in any way, the ICC engaged four independent betting and cricketing specialists to analyse the claims. All four concluded that the passages of play identified in the programme as being allegedly fixed were entirely predictable and, therefore, implausible as a fix," said the statement.

The 2018 documentary had alleged that a group of English and Australian cricketers were involved in spot-fixing.

"All five Participants to the Code who featured in the programme have been interviewed by the ICC Integrity Unit and there is insufficient evidence based on the normal thresholds applied through the Code to lay any charges," the ICC said.

The England and Wales Cricket Board (ECB) had earlier denied the allegations, saying the evidence used in the reporting was poor.

However, Alex Marshall, the ICC General Manager (Integrity) said that the ICC is open to review the allegations if substantial evidence comes forward."Should any new substantial evidence come to light I will re-examine the case. But at present I am comfortable with the conclusion of the investigation and the thoroughness with which it was undertaken," he said.

Dubai Asian boxing: So far no visas for 20-member Indian team

New Delhi, May 17: India's participation in this month's Asian Boxing Championships in Dubai looks doubtful as its 20-member team hasn't got the visas, the Boxing Federation of India (BFI) secretary said on Monday.

The competition is scheduled to start on May 21. The Indian team includes 10 women boxers.

"The Indian men and women's boxing teams haven't got visas to travel to Dubai. We are, however, trying our level best to send the teams," BFI secretary Hemanta Kalita told IANS

Originally, New Delhi to host the continental competition, but last month the

Asian Boxing Confederation shifted the tournament. to Dubai because of the raging Covid pandemic in India, particularly in Delhi. With Covid-19 crisis deep-

ening in India it is unlikely the BFI will send even its staff to officiate in the Asian meet. "Since we were co-host it was planned to send of-

ficials to Dubai, but not

now. The situation is
