

BYLAWS OF WIT RADIO

ARTICLE I NAME

The name of this organization is WINNEBAGO **INTERNATIONAL** TRAVELERS COMMUNICATIONS AMATEUR RADIO SERVICE, an International Club of WINNEBAGO **INTERNATIONAL** TRAVELERS. For purpose of brevity, they shall hereafter be referred to in this document as **WIT Radio** and WIT, respectively. ~~Furthermore, WITCARS may also be identified by a Service Mark of "WIT Radio" or "WIT Radio (WITCARS)".~~

ARTICLE II MAILING ADDRESS

The contact for **WIT Radio** is the **WIT Radio** Secretary. ~~which will usually be listed in the WIT CLUB NEWS.~~

ARTICLE III EMBLEM

The emblem of WIT **Radio** shall be the same as the design of the WIT **Radio** patch.

ARTICLE IV PURPOSES AND OBJECTIVES

In addition to the purposes and objectives of WIT, the prime interest of WIT **Radio** shall be to make available to city, state, federal and international communities, those services of WIT **Radio** membership, their equipment and technical knowledge of radio communications in the event of an emergency, should such arise. To provide communications on rallies, caravans and network operations for the express purpose of handling traffic for persons within WIT but not limited to WIT.

ARTICLE V WIT **Radio** MEMBERSHIP

Membership in WIT **Radio** is open to all WIT members in good standing, who also have a valid AMATEUR RADIO LICENSE issued by the licensing bureau of the country in which they reside. The spouse of a member of WIT **Radio**, even though not a licensed amateur radio operator, is considered to be a member of WIT **Radio**.

ARTICLE VI APPLICATION FOR MEMBERSHIP

There is a one-time initiation fee of Ten Dollars (\$10.00). This shall be sent to the secretary of WIT **Radio** along with a properly filled out application form. ~~This form can be found in the WIT CLUB NEWS.~~ If membership in WIT or the radio operator license is terminated, membership in WIT Radio will also cease. If membership in WIT and the license to operate an amateur radio become valid again, membership in WIT **Radio** can then be reinstated with a new application form and another Ten Dollars (\$10.00) initiation fee.

ARTICLE MEMBERSHIP DUES

There are no annual dues at the present time.

ARTICLE VOTING

WIT Radio members shall be entitled to one vote for each adult owner of a unit. Proxy votes are not legal in any voting in WIT.

ARTICLE IX OFFICERS

The following officers shall be elected and installed at the WITCARS annual meeting at the Grand National Rally in Forest City, Iowa: President, Vice President, Secretary and/ or Treasurer.

ARTICLE X ADMINISTRATION

The executive board of WIT **Radio** consists of the elected officers and the Immediate Past President. The board will report to the Board of Directors to Winnebago Industries Inc. through proper channels.

Nothing in these Bylaws may conflict with the bylaws of WIT, which will govern WIT **Radio** in case of conflict or omission.

ARTICLE XI EFFECTIVE DATE
